**I. Continue discussion on the Bill**

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. The Bills Committee requested the Administration -

- (a) to provide information on the number of investigation reports where the classification of the reportable complaints concerned

were endorsed by the Independent Police Complaints Council (IPCC) by circulation of papers in 2007;

- (b) to provide information on the number of reportable complaints monitored by the Serious Complaints Committee of IPCC in 2007;
- (c) to provide information on the transitional or other matters to be completed before the Bill upon passage should be brought into operation; and
- (d) to consider further revising the heading of clause 9, having regard to the views of members.

3. The Bills Committee requested the Secretary for Security to explain during the resumption of Second Reading debate on the Bill that the Administration would not appoint immediate family members of members of the Police Force as IPCC observers.
