**I. Meeting with the Administration**

The Bills Committee deliberated (index of proceedings attached at Annex).

2. The Bills Committee requested the Administration -

- (a) to provide information on the number of complaint cases where the case files submitted by the Complaints Against Police Office (CAPO) were examined by members of the Independent Police Complaints Council (IPCC) in 2006;

- (b) to provide information on the respective number of complaint cases where the investigation results of CAPO were accepted/disagreed by the IPCC Secretariat in 2006;
- (c) to provide information on the respective number of complaint cases where the recommendations of the IPCC Secretariat on the cases were endorsed/disagreed by IPCC in 2006;
- (d) to provide information on the number of complaint cases where the results of CAPO's investigations were changed after IPCC provided its comments to the Police;
- (e) to provide information on previous cases where IPCC disagreed with CAPO's classification of complaints and made a report to the Chief Executive and the Chief Executive's reply to IPCC on the cases concerned;
- (f) to provide information on the outcome of the seven complaint cases discussed at bi-monthly joint meetings of IPCC and CAPO in 2006; and
- (g) to advise on the pay point of the Head of CAPO.

3. The Bills Committee agreed to invite the Chairman and members of IPCC to the meeting to be held on 13 December 2007 to exchange views on the Bill and related matters, including -

- (a) the mode of operation of the existing IPCC and the proposed statutory IPCC to be established under the Bill in respect of the examination of complaint cases;
- (b) the support required of the Secretariat of the proposed statutory IPCC;
- (c) the staffing of the Secretariat of the proposed statutory IPCC;
- (d) the financial provision for the proposed statutory IPCC; and
- (e) the level of honorarium for IPCC members.

4. The meeting ended at 10:15 am.
