Bills

First Reading

Prevention of Bribery (Amendment) Bill 2007
Independent Police Complaints Council Bill

The Bills were read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Prevention of Bribery (Amendment) Bill 2007

The Chief Secretary for Administration moved the Second Reading and addressed the Council.

While the Chief Secretary for Administration was addressing the Council, the President left the chair at 3:42 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Independent Police Complaints Council Bill

The Secretary for Security moved the Second Reading and addressed the Council.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Hazardous Chemicals Control Bill

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 24 May 2006 resumed.

Hon CHOY So-yuk, Chairman of the Bills Committee on Hazardous Chemicals Control Bill, addressed the Council on the Committee's Report. She then spoke on the Bill in her personal capacity as a Member.

Three Members spoke on the Bill.

The Secretary for the Environment replied.

At 4:31 pm, while the Secretary for the Environment was speaking, the President resumed the chair.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Hazardous Chemicals Control Bill**.

Question that clauses 3, 5 to 9, 12, 14, 15, 17, 18, 20, 24, 25, 26, 30, 32 to 40, 42, 43, 45, 46, 49 and 51 stand part of the Bill proposed, put and agreed to.

Question that clauses 1, 2, 4, 10, 11, 13, 16, 19, 21, 22, 23, 27, 28, 29, 31, 41, 44, 47, 48 and 50 stand part of the Bill proposed.

The Secretary for the Environment moved amendments to the aforesaid clauses and addressed the Committee.

Question on the amendments put and agreed to.

Question that clauses 1, 2, 4, 10, 11, 13, 16, 19, 21, 22, 23, 27, 28, 29, 31, 41, 44, 47, 48 and 50, as amended, stand part of the Bill proposed, put and agreed to.

New clause 50A read the first time.

The Secretary for the Environment moved the Second Reading of new clause 50A and addressed the Committee.

Question on the Second Reading of new clause 50A proposed, put and agreed to.

New clause 50A read the second time.

The Secretary for the Environment moved the addition of new clause 50A to the Bill.

Question on the addition proposed, put and agreed to.

Question that Schedules 1, 2 and 3 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for the Environment reported that

the **Hazardous Chemicals Control Bill**

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Motions

Proposed resolutions under the Mass Transit Railway Ordinance

1. Mass Transit Railway (Amendment) Bylaw 2007

The Secretary for Transport and Housing moved the following motion and addressed the Council:

RESOLVED that the Mass Transit Railway (Amendment) Bylaw 2007, made by the MTR Corporation Limited on 20 June 2007, be approved.

Question on the Secretary for Transport and Housing motion's proposed.

The President stated that Hon James TO had given notice to move three amendments to the motion. In accordance with the Rules of Procedure, the motion and the three amendments would be debated together in a joint debate.

Hon James TO spoke on the motion and his amendments.

Hon Miriam LAU spoke on the motion and amendments as Chairman of the Subcommittee to Study the Draft Subsidiary Legislation Relating to the Rail Merger, and then in her personal capacity as a Member.

Three other Members and Hon LEUNG Yiu-chung spoke on the motion and the amendments.

While Hon LEUNG Yiu-chung was speaking, Hon Mrs Selina CHOW raised a point of order on whether Hon LEUNG Yiu-chung's speech was related to the motion and amendments. The President reminded Hon LEUNG Yiu-chung to speak on the motion and the three amendments. Hon LEUNG Yiu-chung continued to speak.

Hon Mrs Selina CHOW spoke on the motion and amendments.

With the President's permission, Hon James TO elucidated on two points he had made earlier which he considered to be misunderstood by Hon Mrs Selina CHOW.

Two more Members spoke on the motion and the amendments.

The Secretary for Transport and Housing spoke on the amendments.

Hon James TO moved the first amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

(a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";

(b) by adding at the end -

"in section 8(b), by adding -

"(3) Paragraphs (1) and (2) do not apply in case of accident or other emergency."."

Question on Hon James To's amendment to the Secretary for Transport and Housing's motion proposed and put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, four were in favour of the amendment and 18 against it; while among the Members returned by geographical constituencies through direct elections, 22 were present, 10 were in favour of the amendment and 11 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Mass Transit Railway (Amendment) Bylaw 2007" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon James To moved the second amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

(a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";

(b) by adding at the end -

"in section 18, in new by-law 32A, by deleting "for the purpose of advertisement or publicity" and substituting "with intent to do so for the purpose of commercial advertisement or commercial publicity"."

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed, put and negatived.

Hon James TO moved the third amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

(a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";

(b) by adding at the end -

"by deleting section 21."

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed, put and negatived.

The Secretary for Transport and Housing replied.

Question on the Secretary for Transport and Housing's motion put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that there were 43 Members present, 30 were in favour of the motion, two against it and 10 abstained. (Voting record in Appendix II.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

2. Mass Transit Railway (North-west Railway) Bylaw

The Secretary for Transport and Housing moved the following motion and addressed the Council:

RESOLVED that the Mass Transit Railway (North-west Railway) Bylaw, made by the MTR Corporation Limited on 20 June 2007, be approved.

Question on the Secretary for Transport and Housing's motion proposed.

The President stated that Hon James TO had given notice to move seven amendments to the motion. In accordance with the Rules of Procedure, the motion and the amendments would be debated together in a joint debate.

Hon James TO spoke on the motion and his amendments.

Hon Miriam LAU spoke on the motion and the amendments.

With the President's permission, Hon James TO elucidated on some points he had made earlier which he considered to be misunderstood by Hon Miriam LAU.

The Secretary for Transport and Housing spoke on the amendments.

Hon James TO moved the first amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

- (a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";

(b) by adding at the end -

"in section 18, by adding -

"(1A) The Corporation may, by notice published in the Gazette, declare any notice and indicator that shall be complied with within the railway premises.

(1B) The notice published under subsection (1A) shall specify the date on which a notice or indicator is to take effect."."

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 20 were present, four were in favour of the amendment and 16 against it; while among the Members returned by geographical constituencies through direct elections, 18 were present, nine were in favour of the amendment and eight against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Mass Transit Railway (North-west Railway) Bylaw" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon James TO moved the second amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

(a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";

(b) by adding at the end -

"(a) by deleting section 22(1)(a) and substituting -

"(a) behave in a noisy or disorderly manner, or use threatening, abusive or insulting

words, with intent to cause a breach of the peace on the railway premises, or whereby a breach of the peace on the railway premises is likely to be caused;";

(b) in section 22, by adding -

"(3) Notwithstanding the provisions of section 39(4), an official shall have power to detain any person who contravenes subsection (1)(a) until he can be delivered into the custody of a police officer to be dealt with according to law.";

(c) in the Schedule, in the entry relating to section 22, in the first column, by deleting "22" and substituting "22(1)(b), (c), (d) and (e)".

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed, put and negatived.

Hon James To moved the third amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

(a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";

(b) by adding at the end -

"(a) by deleting section 23 and substituting -

"23. Prohibited persons

An official may refuse the admission into or remove from the railway premises -

(a) any person whom he believes or is given reasonable cause to believe is under the influence of alcohol or drugs or in a state of intoxication resulting from consuming or abusing medicine;

(b) any person whom he believes or is given reasonable cause to believe is suffering from a contagious disease; or

- (c) any person whom he believes or is given reasonable cause to believe may prejudice the safety of railway premises.”;

(b) in the Schedule, by deleting -

“23 Passengers in unfit \$5,000 fine”.”.
or improper
condition entering

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed, put and negatived.

Hon James To moved the fourth amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

- (a) by deleting “be approved.” and substituting “subject to the following amendments, be approved -”;
- (b) by adding at the end -

“in section 26(b), by deleting “for the purpose of advertisement or publicity” and substituting “with intent to do so for the purpose of commercial advertisement or commercial publicity”.”.

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed, put and negatived.

Hon James To moved the fifth amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

- (a) by deleting “be approved.” and substituting “subject to the following amendments, be approved -”;
- (b) by adding at the end -

“(a) by deleting section 28 and substituting -

“28. **Loitering prohibited**

An official may request a person to leave, or remove the person from, the railway premises if he believes or is given reasonable cause to believe that the person, while in or upon any part of the railway premises, is -

- (a) loitering with intent to commit an arrestable offence;
- (b) loitering in any way as to wilfully obstruct any other person using the railway premises; or
- (c) loitering, and his presence in the railway premises, either alone or with others, causes any other person reasonably to be concerned for his safety or well-being.”;

“28 Loitering \$2,000 fine”.”.

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed, put and negatived.

Hon James To moved the sixth amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

- (a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";
- (b) by adding at the end -

"in section 36(1)(b), by deleting "1 month" and substituting "3 months".”.

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 20 were present, four were in favour of the amendment and 16 against it; while among the

Members returned by geographical constituencies through direct elections, 18 were present, 10 were in favour of the amendment and seven against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon James To moved the seventh amendment to the Secretary for Transport and Housing's motion as follows:

RESOLVED that the motion to be moved by the Secretary for Transport and Housing under section 34 of the Mass Transit Railway Ordinance (Cap. 556) at the Legislative Council meeting of 11 July 2007 be amended -

(a) by deleting "be approved." and substituting "subject to the following amendments, be approved -";

(b) by adding at the end-

"by adding immediately after section 41 -

"42. Cessation of the Bylaw

This Bylaw shall cease to have effect upon the expiry of 15 months immediately following the Merger Date."."

Question on Hon James TO's amendment to the Secretary for Transport and Housing's motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 19 were present, three were in favour of the amendment and 16 against it; while among the Members returned by geographical constituencies through direct elections, 17 were present, 10 were in favour of the amendment and six against it. (Voting record in Appendix V.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

The Secretary for Transport and Housing replied.

Question on the Secretary for Transport and Housing's motion put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that there were 36 Members present, 27 were in favour of the motion, one against it and seven abstained. (Voting record in Appendix VI.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

The Secretary for Transport and Housing moved the following motion and addressed the Council:

Question on the motion proposed, put and agreed to.

Proposed resolution under the Kowloon-Canton Railway Corporation Ordinance

The Secretary for Transport and Housing moved the following motion and addressed the Council:

RESOLVED that the Kowloon-Canton Railway Corporation (Suspension of Bylaws) Bylaw 2007, made by the Kowloon-Canton Railway Corporation on 15 June 2007, be approved.

Question on the motion proposed, put and agreed to.

Members' Motions

Proposed resolution under the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China

Hon TSANG Yok-sing moved the following motion and addressed the Council:

RESOLVED that Rule 33 of the Rules of Procedure of the Legislative Council of the Hong Kong Special Administrative Region be amended -

- (a) in subrule (3A), by repealing "When" and substituting "Subject to subrule (3B), when";
- (b) by adding -

"(3B) Except in the case of a motion moved by a designated public officer or under Rule 13(1) (The Chief Executive's Policy Address) or Rule 16(4) (Motions for the Adjournment of the Council), the President shall call upon designated public officers attending the debate to speak -

- (a) before any Member who indicates his intention to speak is called upon to speak; and
- (b) when no more Member indicates his intention to speak or, in the case of a joint debate on the motion and its amendments, after the mover of the motion has been called upon to speak on the amendments and has spoken."

Question on the motion proposed, put and agreed to.

Proposed resolution under the Rules of Procedure of the Legislative Council of the Hong Kong Special Administrative Region

Hon Miriam LAU moved the following motion and addressed the Council:

RESOLVED that the amended terms of reference and list of corresponding bureaux/bodies set out in the Schedule, as recommended by the House Committee, be approved in respect of the existing 18 Panels formed by resolutions made and passed by this Council at its meetings of 8 July 1998, 20 December 2000 and 9 October 2002; and that the amendments so approved shall take effect on the day when the 2007-2008 session of the Council begins.

Question on the motion proposed, put and agreed to.

Rights and interests of ethnic minorities

Hon Fred LI moved the following motion and addressed the Council:

That, as the Administration has failed to provide the necessary support and protection for some 300 000 ethnic minorities in Hong Kong, and many of them have encountered difficulties on various fronts, creating barriers to their development and integration into the Hong Kong community, this Council urges the Administration to adopt measures to protect the rights and interests of ethnic minorities, including:

- (a) on the education front, allocating additional resources to increase the number of designated schools in various districts which admit more non-Chinese speaking primary and secondary students and to provide appropriate support

to the schools concerned and, at the same time, offering a curriculum and public examination for the subject of Chinese Language which are suitable for students of ethnic minorities, so that such students who are not proficient in Chinese can have equal opportunities to further their studies in schools, especially universities, and in employment;

- (b) on the employment front, conducting vocational training courses and trade tests in English or the languages of ethnic minorities according to their needs, relaxing the entry requirement in respect of Chinese proficiency in the recruitment of staff by the Government and public sector organizations, and arranging for suitable posts to be filled by ethnic minorities as far as practicable, and also providing information on job vacancies in both Chinese and English and setting up a dedicated employment counter by the Labour Department to assist ethnic minorities visiting the Department in seeking employment;
- (c) on the public services front, providing free interpretation service for ethnic minorities using public services, such as public healthcare, social and employment services, etc;
- (d) on the religion and culture fronts, providing venues and other facilities in the districts in which a larger number of ethnic minorities resided in for conducting religious and cultural activities and, at the same time, enhancing civic education to promote public understanding of and respect for the cultures of ethnic minorities;
- (e) ensuring, by means of comprehensive legislation and complementary measures, that ethnic minorities are not discriminated against; and
- (f) formulating a well-thought out policy to facilitate the integration of ethnic minorities into the Hong Kong community.

While Hon Fred LI was addressing the Council, the President left the chair at 7:40 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Hon Fred LI's motion proposed.

The President's Deputy stated that Hon CHOY So-yuk would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon CHOY So-yuk moved the following amendment to Hon Fred LI's motion and addressed the Council:

To add "(b) in respect of young people of ethnic minorities, allocating additional resources to strengthen social services for young people of ethnic minorities, and assisting those who are beyond school age to complete secondary and vocational education;" after "in schools, especially universities, and in employment;"; to delete the original "(b)" and substitute with "(c)"; to add "and making enquiries about labour laws as well as workers' rights and interests" after "ethnic minorities visiting the Department in seeking employment"; to delete the original "(c)" and substitute with "(d)"; to delete the original "(d)" and substitute with "(e)"; to add "(f) appointing ethnic minorities with ability to public organizations or advisory bodies, such as the Equal Opportunities Commission, so as to reflect the aspirations of ethnic minorities;" after "respect for the cultures of ethnic minorities;"; to delete the original "(e)" and substitute with "(g)"; and to delete the original "(f)" and substitute with "(h) setting up a comprehensive database to collect, in a systematic and focused manner, data relating to ethnic minorities in such areas as employment, education, use of public services, religion and culture, with a view to understanding their needs and thereby".

Question on Hon CHOY So-yuk's amendment to Hon Fred LI's motion proposed.

Nine other Members and Dr Hon YEUNG Sum spoke on the motion and the amendment.

At 8:55 pm, while Dr Hon YEUNG Sum was speaking, the President resumed the chair.

10 more Members spoke on the motion and the amendment.

Hon Fred LI spoke on the amendment.

The Secretary for Constitutional and Mainland Affairs spoke on the motion and the amendment.

Question on Hon CHOY So-yuk's amendment to Hon Fred LI's motion put and agreed to.

Hon Fred LI replied.

Question on Hon Fred LI's motion as amended by Hon CHOY So-yuk put and agreed to.

The President suspended the meeting at 10:38 pm.

* * * * *

The Council resumed at 9:00 am on 12 July 2007.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

Developing co-operative relationship with the Mainland

Hon TSANG Yok-sing moved the following motion and addressed the Council:

That, as Hong Kong's relationship with the Mainland is increasingly close since its reunification with the motherland, and experience has proved that enhancing co-operation between the two places can bring about a mutually beneficial and win-win effect, this Council urges the Government to continue to develop its co-operative relationship with the Mainland on all fronts, and set up a co-operation mechanism which is permanent and authoritative, covering more areas and levels, to undertake overall planning, co-ordination and policy formulation on important issues concerning co-operative development.

Question on Hon TSANG Yok-sing's motion proposed.

The President stated that three Members would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the three amendments would be debated together in a joint debate.

Hon Emily LAU, Hon Audrey EU and Hon Albert HO, who would move amendments to the motion, spoke on the motion and their amendments.

30 other Members spoke on the motion and the amendments.

Hon TSANG Yok-sing spoke on the amendments.

The Secretary for Commerce and Economic Development spoke on the motion and the amendments.

Hon Emily LAU moved the following amendment to Hon TSANG Yok-sing's motion:

To add ", on the premise of 'one country, two systems and a high degree of autonomy'," after "urges the Government to continue"; and to add "and urges the Central Government to issue Home Visit Permits to those Hong Kong people who cannot return to the Mainland, including Members of the Legislative Council and District Councils who belong to the democratic camp, and communicate with the Legislature and political parties in Hong Kong and develop a normal working relationship

to enhance mutual understanding, so that the relationship between the HKSAR and the Mainland can be normalized," after "on all fronts,".

Question on Hon Emily LAU's amendment to Hon TSANG Yok-sing's motion proposed and put.

Hon Emily LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, seven were in favour of the amendment and 14 against it; while among the Members returned by geographical constituencies through direct elections, 20 were present, 11 were in favour of the amendment and eight against it. (Voting record in Appendix VII.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Developing co-operative relationship with the Mainland" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Audrey EU moved the following amendment to Hon TSANG Yok-sing's motion:

To delete "and" after "on all fronts," and substitute with "especially on issues concerning immigration policies, environment, air quality and food safety, and to"; and to delete "authoritative" after "permanent and" and substitute with "efficient".

Question on Hon Audrey EU's amendment to Hon TSANG Yok-sing's motion proposed, put and agreed to.

As Hon Audrey EU's amendment had been agreed, the President granted leave for Hon Albert HO to revise the terms of his amendment and explain them to the Council.

Hon Albert HO moved the following further amendment to Hon TSANG Yok-sing's motion as amended by Hon Audrey EU, and explained the revised terms of his amendment to the Council:

To add "; in addition, the Government should promote expeditious development in the country's constitutional democracy with Hong Kong's experience in practising full democracy, and urge the Mainland to draw on Hong Kong's experience in the rule of law to establish a law regime which respects judicial independence and protects the autonomy of the law profession" after "co-operative development".

Question on Hon Albert HO's amendment to Hon TSANG Yok-sing's motion as amended by Hon Audrey EU proposed and put.

Hon Albert HO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, seven were in favour of the amendment and 14 against it; while among the Members returned by geographical constituencies through direct elections, 20 were present, 11 were in favour of the amendment and eight against it. (Voting record in Appendix VIII.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon TSANG Yok-sing replied.

Question on Hon TSANG Yok-sing's motion as amended by Hon Audrey EU put and agreed to.

End of session

As it was the last meeting in the session, the President wished Members a restful time during the summer recess. She then declared that the first meeting in the next session would be held on 10 October 2007 at 11:00 am.

The Council was adjourned at 1:44 pm.
