**V. Report of Bills Committees and subcommittees**

**Report of the Subcommittee on Road Traffic (Traffic Control)  
(Amendment) Regulation 2007**  
*(LC Paper No. CB(1) 1123/06-07)*

9. Mr WONG Kwok-hing, Chairman of the Subcommittee, said that the Amendment Regulation sought to empower the Commissioner for Transport to exempt any category of taxis from a closed road restriction in respect of such closed roads as he might specify.
10. Mr WONG further said that with the impending commissioning of the public transport interchanges (PTIs) at the Sheung Shui to Lok Ma Chau Spur Line Terminus and the Hong Kong side of the Hong Kong-Shenzhen Western Corridor, the Administration proposed to allow urban and New Territories (NT) taxis to operate at the PTIs. As the roads leading to the PTIs at the new control points were closed roads, it was necessary to amend the relevant Regulation to allow urban and NT taxis to access the PTIs.
11. Mr WONG added that the Subcommittee was in support of the Amendment Regulation but had requested the Administration to closely monitor the traffic impacts and security risks arising from the proposal.
12. The Chairman reminded Members that the deadline for giving notice of amendments, if any, was Wednesday, 21 March 2007.
