Public Health and Municipal Services Ordinance (Cap. 132)
Designation of Museums (Amendment) Order 2007 (L.N. 5)
Public Health and Municipal Services Ordinance (Civic Centres) (Amendment of Thirteenth Schedule) Order 2007 (L.N. 6)

L.N. 5 amends the Schedule to the Designation of Museums Order (Cap. 132 sub. leg. P) by providing that certain premises shall cease to be designated as museums and rectifying two clerical errors (by adding "of the Ordinance" after "section 105M" in the English text of two items respectively in the Schedule).

- 2. L.N. 6 amends the Thirteenth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) ("the Ordinance") by setting aside certain premises for use as civic centres and rectifying a minor clerical error (by repealing "Kowloon." and substituting "Kowloon" in an item of the Schedule).
- 3. The combined effects of L.N. 5 and L.N. 6 are that the following premises cease to be designated as museum and are set aside as civic centre—
  - (a) the Tea Room, Galleries, 1, 2 and 3 and the North Lawn of the Flagstaff House Museum of Tea Ware, Victoria Barracks;
  - (b) the Lobby and the Podium on 1/F of the Hong Kong Museum of Art;
  - (c) the Lecture Hall, the Activity Rooms 1 and 2, the Special Exhibition Gallery and the Courtyard of the Hong Kong Museum of History;

- (d) the Theatre, the Seminar Room, the Education Studio, the Function Place, the Courtyard and the Main Foyer (including the Grand Staircase) of the Hong Kong Heritage Museum;
- (e) the Cinema and the Exhibition Hall of Hong Kong Film Archive; and
- (f) the Lecture Hall in the extension block connecting Blocks S61 and S62, the Activity Room in Block S62, and the Courtyard and Cafeteria between Blocks S61 and S62, of Hong Kong Heritage Discovery Centre.
- 4. Upon the setting aside of any premises for use as a civic centre, the Director of Leisure and Cultural Services, under section 105Q of the Ordinance, may hire a civic centre or any part thereof to the public for payment.
- 5. These Orders will come into operation on 16 March 2007.
- 6. No legal or drafting difficulties have been identified in relation to the above two items.
