000320 - 000652	Ms Miriam LAU Administration Hong Kong North West Express Limited (HKNWE)	Ms Miriam LAU kin-yea was concerned about the tenant's plan in providing cross-boundary ferry services to/from Macao and other ports in Mainland China. The Hong Kong North West Express Limited (HKNWE) responded that the company was liaising with the relevant authorities on the Tuen Mun-Macao services and was examining the feasibility to provide services to other Mainland ports such as Nansha	
000653 - 001010	Mr CHEUNG Hok-ming Administration	Mr CHEUNG Hok-ming was concerned about the low utilization rate of the new TMFT and the resultant waste of resources as well as the financial and civil service implications for the Government. The Administration responded that the project should be cost-neutral to the Government	
001011 - 002604	Chairman Administration HKNWE	Mr Albert HO Chun-yan was concerned about the obligations of the tenant in the tenancy agreement. The Administration explained that whilst the operator was obliged to provide cross-boundary ferry services at the new TMFT in accordance with its tender proposal, the service frequency and whether to run the ferry services by itself or sub-let the terminal premises and berthing slots to other parties for operation were commercial decisions to be made by the tenant. In line with the arrangements for the existing cross-boundary ferry service operators, the Government would not regulate the fares to be charged by the TMFT tenant

002605 - 003409	Mr CHEUNG Hok-ming Administration Chairman	Mr CHEUNG Hok-ming was concerned about the possible conflict in traffic between ferry passengers and the light rail trains as the new TMFT was located near the Light Rail Terminus. The Administration explained that given the short distance between the Light Rail Terminus and the new TMFT, and the TMFT's design capacity of only 800 passengers per hour, there was no need to construct a direct access link between Pierhead Garden and the new TMFT. The Transport Department had also been improving the signage in the area to facilitate passenger circulation and enhance pedestrian safety	
003410 - 004820	Ms Miriam LAU HKNWE Chairman Administration Mr CHEUNG Hok-ming	<p>Ms Miriam LAU Kin-ye opined that consideration could be given for the tenant to enter into a joint venture with existing operators so that cross-boundary ferries leaving China Ferry Terminal or Macau Ferry Terminal could also call at the new TMFT before their onward journeys to Macao and other Mainland ports. The tenant might also consider sub-letting the berthing slots to existing operators if it could not obtain the necessary approval from the relevant authorities for using their port facilities</p> <p>The Chairman was concerned whether the TMFT service caused any noise nuisance to nearby residents. The tenant confirmed that it had not received any complaint regarding noise nuisance</p>
