Progress Report on the Partnership Fund for the Disadvantaged

Purpose

This paper updates Members on the progress of the implementation of the Partnership Fund for the Disadvantaged (PFD).

Background

2. The PFD aims to promote tripartite partnership involving the Government, the business sector and welfare non-governmental organisations (NGOs) in working for the benefit of the disadvantaged groups. Under the PFD, the Government provides matching grants to donations in cash or in kind made by business organisations to support NGOs in implementing social welfare initiatives.

3. Members were consulted on the objectives, application criteria, targeted welfare initiatives, composition of the vetting committee and monitoring of the approved projects on 8 November 2004 (Paper titled “Matching Grant for Social Welfare Services” with reference no. of CB(2)145/04-05(07)). The Fund was subsequently set up on 17 December 2004 following the approval of the Finance Committee of the Legislative Council (Paper No. FCR (2004-05)34).

Latest Position

Overview

4. An Advisory Committee (AC) chaired by the Director of Social Welfare comprising non-official members from the welfare sector, service users, academics, District Council and business sector has been set up to examine and advise on applications and matters relating to the operation of the Fund. The membership is at Annex A. Honorary Advisors from business chambers, the Hong Kong Council of Social Services and business

related organisations also give advice on the strategic development of PFD. A list of the Advisors is at Annex B.

5. Two rounds of applications were invited on 7 March 2005 and 17 October 2005 respectively. A total of 43 projects have been approved, involving grant from the PFD of over \$13 million. These projects have attracted 109 business partners, with total business sponsorship (in cash or in kind) of over \$16 million. We expect a total of 120 000 disadvantaged persons to benefit from the projects. A summary of the approved projects is at Annex C. Of these projects, ten have been completed.

6. We invited the third round of applications on 21 July 2006. A total of twelve applications have been received and they are being processed.

Publicity

7. Details of the approved projects have been uploaded onto Social Welfare Department's (SWD) website for reference by the interested NGOs, business partners and the public at large. To facilitate NGOs forming partnerships with the business sector, SWD has also uploaded NGOs' proposals for business sponsorship onto SWD's web-based platform. We have also publicized the Fund through experience-sharing and recognition fora, exhibitions, press conferences and visits. The launching of the three rounds of applications was well reported by the media. Two newsletters have been published and distributed to the welfare sector and business chambers, as well as uploaded onto SWD's website.

Analysis of the Approved Projects

8. Disadvantaged persons of a wide variety of background benefit from the approved projects and they include survivors of domestic violence, ex-offenders and their families, children and elders in residential care, new arrivals with little vocational skills or social support, youth delinquents, drug abusers, poor elders living alone, unemployed and low-skilled youths, people with disabilities and families in poverty, etc.

9. The amount of PFD grant approved for each project ranges from \$30,000 to \$500,000, and the projects last from two months to three years.

10. Apart from donations in cash or in kind to support the welfare projects, many business partners also take active part in implementing the projects. A total of 36 projects (or 84%) involve participation of staff from

business corporations in serving as instructors for job skills training, assisting in the programmes for the service users, paying visits to elders in residential care or giving professional advice for renovation of homes for the deprived families, etc.

Monitoring

11. We monitor the implementation of the projects closely. Apart from checking the progress and vetting the final evaluation reports as well as the audited financial statements submitted by the NGOs, AC Members and SWD pay visits to the projects to ensure that they are carried out in accordance with the programme plans, and collect feedback from service users.

Facilitation Measures

12. To further encourage the formation of tripartite partnerships, we have introduced the following facilitation measures prior to inviting the third round of applications :

- (a) NGOs can now submit their applications all year round till 20 July 2007 for this round. This facilitates the submission of applications according to the work schedule and budgeting arrangements of the NGOs and their business partners;
- (b) the maximum amount of the PFD grant for each project has been increased from \$500,000 to \$1 million. This would give NGOs a greater incentive to secure larger sponsorship for benefiting more disadvantaged persons;
- (c) while each NGO may only submit one application in the first two rounds taken together, they may now have three approved applications per round; and
- (d) contributions from charitable trusts/foundations established and managed by business corporations registered and operating their business in Hong Kong will now be accepted as business contributions.

Evaluative Study

13. As a means to sustain the impetus of the PFD and to enhance

NGOs' capacity for forming tripartite social partnership, an evaluative study on promoting and sustaining partnership between NGOs and business corporations will be carried out, tentatively from January 2007.

Way Forward

14. We will continue to promote the PFD to business corporations, welfare sector and other potential strategic partners so as to invite more applications to facilitate the realization of the Fund's objectives to the fullest extent.

Action Required

15. Members are invited to note the progress of the PFD above.
