

L.N. 190 of 2006**CLUBS (SAFETY OF PREMISES) (EXCLUSION)
(AMENDMENT) ORDER 2006**

(Made by the Secretary for Home Affairs under section 3 of the Clubs
(Safety of Premises) Ordinance (Cap. 376))

1. Schedule amended

The Schedule to the Clubs (Safety of Premises) (Exclusion) Order

- (d) in paragraph (38), by repealing “Room 303, 3/F, 1, Wa Yung Road, Tui Min Hoi, Sai Kung, New Territories” and substituting “Room D249 & D250, 2/F, Marine Police Outer Waters District Headquarters and Marine Police North Division, Kiu Ha Road, Ma Liu Shui, New Territories”;
- (e) in paragraph (41), in the Chinese text, by repealing “港口” and substituting “海港”;
- (f) in paragraph (45), by repealing “15/F, 200, Ma On Shan Road, Shatin, New Territories” and substituting “13/F, New Territories South Regional Headquarters, 8 Shing Mun Road, Tsuen Wan, New Territories”;
- (g) in paragraph (47), by repealing “Officers’ Mess, Police Training School” and substituting “Hong Kong Police College Officers’ Mess”;

- (h) by repealing paragraph (48) and substituting—
“(48) The Police Civilian Staff Club Room 3403A, 34/F, Arsenal House, Police Headquarters, 1 Arsenal Street, Wanchai, Hong Kong”;
- (i) by repealing paragraph (50) and substituting—
“(50) Police Sports and Recreation Club 430, Sai Yeung Choi Street North, Kowloon”;
- (j) in paragraph (59), in the Chinese text, by repealing “俱樂部” and substituting “餐廳”;
- (k) in paragraph (62), by repealing “District”;
- (l) by adding—
“(92) Castle Peak Bay Immigration Centre Staff Mess 4/F, Castle Peak Bay Immigration Centre, 84 Castle Peak Road, Tuen Mun, New Territories”.

Explanatory Note

The Schedule to the Clubs (Safety of Premises) (Exclusion) Order (Cap. 376 sub. leg. C) contains a list of club-houses situated in Government premises which are excluded from the application of the Clubs (Safety of Premises) Ordinance (Cap. 376). The purposes of this Order are to—

- (a) update the names of 8 clubs and the locations of 6 club-houses set out in the Schedule;
- (b) delete one club-house from the Schedule; and
- (c) add one club-house to the Schedule.
