Elderly Health Care Voucher Pilot Scheme

計劃概要

Project at a glance

- 三年的試驗計劃
3 year pilot
- 七十歲或以上持有香港身份證的長者
Elders aged 70 or above and hold a Hong Kong Identity Card (HKID)
- 每年5張面值50元的醫療券
5 vouchers valued \$50 each every year
- 為接受私人基層醫療服務提供部份資助
Providing partial subsidy for receiving private primary care

Formulating the operational details

- 其中一個主要目的是希望盡量簡化發放和使用醫療券的方式，務求方便長者

One of the objectives is to simplify the distribution and use of health care vouchers **for bringing convenience to the elders**

主要構思 (1)

Main ideas (1)

- 登記所有參加試驗計劃的服務提供者，並設有計劃標誌以資識別
Register all service providers who participate in the pilot, and assign them a sign for identification
- 參與計劃的服務提供者可登入電子醫療券系統
Participating service providers can log on the electronic health care voucher system

主要構思 (2)

Main ideas (2)

- 長者希望使用醫療券時，只需到任何已登記參加計劃的服務提供者出示身份證

When the elders would like to use the health care vouchers, they only need to present their HKIDs to the participating service providers

- 服務提供者會為首次使用醫療券的長者，透過電子醫療券系統進行登記並設立個人醫療券戶口

Service providers will register and create a personal voucher account through the electronic health care voucher system for those elders who use vouchers for the first time

Need not pre-register

無須領取醫療券
Need not collect health care vouchers

無須攜帶醫療券
Need not bring health care vouchers

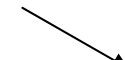

Search & retrieve account record (Input HKID number and date of birth of elders)



與長者確認希望使用的醫療券數目及要求長者簽署同意書

Confirm with elders the number of vouchers to be used and ask elders to sign consent form



輸入資料 Input information

(Type of service; reason for visit; number of vouchers to be redeemed)

Keep original copy of consent form for inspection when required

Appeal to Healthcare Sectors' Support

- 會為參加計劃的醫護專業人員提供支援

Will provide support to participating healthcare professionals

- 會提供不同方式使用電子醫療券系統

Will provide various options for using e-voucher system

- 電腦 Computer
- 電子手帳 Personal Digital Assistants
- 手提電話 Mobile Phone
- 固網電話 Fixed-line Telephones

對長者的宣傳工作

Publicity Targeted at Elderly

- 會對長者廣泛宣傳使用醫療券的方法
Will promote widely among elders on how to use health care vouchers
- 會聯絡社福機構及地區團體，透過它們為長者解釋
Will liaise with welfare and district organisations, which in turn explain to elders
- 與社會福利署研究居於院舍而自理有困難的長者如何使用醫療券的安排
Explore with Social Welfare Department on the arrangement for institutionalised elders who have difficulties in taking care of themselves to use health care vouchers
