Action

I. Meeting with the Administration

[The Bill, LC Paper Nos. CB(2)1550/07-08(01) to (03), CB(2)1734/07-08(01) and CB(2)1987/07-08(01) and (03)]

<u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

Proposed amendments to the Conveyancing and Property Ordinance (CPO) (Cap. 219) (Part 6 of the Bill)

2. <u>Senior Government Counsel (Law Drafting Division)/Department of Justice</u> explained to members the Administration's proposed Committee Stage amendments (CSAs) to the new section 13A of CPO after taking into account members' views. She added that the Law Society of Hong Kong had indicated its agreement to the revised new section 13A.

Action

3. <u>Members</u> noted that the Law Society had provided additional information on issues relating to the effect of the proposed new section 13A(4) on the right or interest of third parties, as well as the relevant extract from its Senior Counsel's advice (LC Paper No. CB(2)1987/07-08(03)).

4. While expressing support for the Administration's proposed CSAs to the new section 13A, <u>members</u> requested <u>the Administration</u> to review the use of the word "的" in the revised new section 13A(1) of CPO.

Proposed amendments under Parts 5, 7 and 8 of the Bill

5. <u>Assistant Legal Adviser 2</u> referred members to clause 66 of the Bill and advised that following the passage of the Pneumoconiosis (Compensation) (Amendment) Bill 2008 at the Council meeting on 9 April 2008, the title of the Pneumoconiosis (Compensation) Ordinance (Cap. 360) had been amended as the Pneumoconiosis and Mesothelioma (Compensation) Ordinance. In this connection, the reference to the Pneumoconiosis (Compensation) Appeal Rules (Cap. 360 sub. leg. C) in clause 66 should be amended accordingly. <u>The Administration</u> agreed to make a CSA to this effect.

6. <u>The Bills Committee</u> raised no further questions on the proposed amendments under Parts 5, 7 and 8 of the Bill. <u>The Chairman</u> instructed the legal adviser to the Bills Committee to study the Chinese version of these proposed amendments, and alert the Bills Committee if any problems were identified.

II. Any other business

- 7. <u>Members</u> noted that the Administration would need more time to prepare a consolidated response to issues of concern raised at the last meeting regarding the drafting formula "to the satisfaction of" under Parts 2 to 4 of the Bill, and agreed that the meeting originally scheduled for 27 May 2008 would be cancelled. <u>The Chairman</u> said that the next meeting of the Bills Committee would be held on 30 May 2008 at 8:30 am.
