**The Chief Executive of the Hong Kong Special Administrative Region presents the Policy Address to the Council**

The Chief Executive attended the Council meeting.

When the Chief Executive was about to address the Council, the proceedings were interrupted by Hon LEUNG Kwok-hung who remained standing, spoke aloud to the Chief Executive and displayed a placard. The President repeatedly ordered him to stop talking. The President also warned him that she would rule that he had breached the Rules of Procedure and would order him to withdraw from the Council if he did not stop talking. As Hon LEUNG Kwok-hung ignored the President's repeated warnings, the President ordered him to withdraw immediately from the Chamber and not to return for the remainder of the meeting.

Hon LEUNG Kwok-hung continued to speak aloud for a short while and then resumed his seat. As Hon LEUNG Kwok-hung had already sat down, the President allowed him to stay at the meeting.

The Chief Executive presented the 2007-2008 Policy Address.

The President declared that the next meeting of the Council would be held on 11 October 2007 at 3:00 pm.

The Council was adjourned at 12:52 pm.
