### **Members' Motions**

#### **Development of the convention and exhibition industry**

The Council continued with the unfinished part of the motion on the Development of the convention and exhibition industry.

The President stated that at the last meeting, she had put to Members the question that Hon WONG Ting-kwong's amendment to Hon Andrew LEUNG Kwan-yuen's motion be passed. In this connection, Hon Albert HO had claimed a division.

The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 22 were in favour of the amendment; while among the Members returned by geographical constituencies through direct elections, 22 were present, 21 were in favour of the amendment. (Voting record in Appendix I.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Hon Andrew LEUNG Kwan-yuen replied.

Question on Hon Andrew LEUNG Kwan-yuen's motion as amended by Hon WONG Ting-kwong put and agreed to.

#### **Motion of Thanks**

Hon Miriam LAU moved the following motion and addressed the Council:

That this Council thanks the Chief Executive for his address.

Question on the motion proposed.

The President stated that Hon Albert HO, Hon Andrew CHENG, Hon Frederick FUNG, Hon Emily LAU, Hon Albert CHAN and Hon LEUNG Yiu-chung would move amendments to the motion respectively, and Hon Fred LI would also move an amendment to Hon Albert HO's amendment. In accordance with the Rules of Procedure, the motion and the amendments would be debated together in a joint debate.

The President announced the commencement of the first debate session, which covered the following policy areas: administration of justice and legal services, constitutional affairs, public service, security, district administration and civic education.

Five Members spoke.

Hon CHIM Pui-chung asked whether he could speak on policy areas other than those for the first debate session. The President asked him not to do so because she respected the House Committee's decision in respect of the policy areas of the five debate sessions. Hon CHIM Pui-chung agreed and spoke.

Five other Members and Hon CHEUNG Man-kwong spoke.

While Hon CHEUNG Man-kwong was speaking, the President left the chair at 1:03 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Four more Members and Hon Emily LAU spoke.

At 2:00 pm, while Hon Emily LAU was speaking, the President resumed the chair.

Three other Members spoke.

Hon Mrs Sophie LEUNG spoke. The President interrupted her as her speech was on policy areas other than those for the first debate session. The President said that the House Committee and the Committee on Rules of Procedure might need to reconsider the arrangements for the debate on the Motion of Thanks, as Members very often spoke on policy areas other than those for the session in progress. Hon Mrs Sophie LEUNG continued to speak.

Two more Members and Hon CHOY So-yuk spoke.

Hon Mrs Selina CHOW raised a point of order on whether cultural policy, on which Hon CHOY So-yuk was speaking, fell outside the scope of the first debate session.

Hon CHOY So-yuk said that cultural policy was one of the policy areas relating to home affairs which was covered in the first session.

The President said that Hon CHOY So-yuk had misunderstood the policy areas which were covered by home affairs in the first session. The President pointed out that in its circular, the Secretariat stated that the first session covered home affairs which referred to "district administration" and "civil education" that were shown in brackets. At the beginning of the first session, she had also stated clearly that those two policy areas were covered in that session, so that Members would understand that "cultural policy" and other policy areas relating to home affairs should be discussed in the second session. Nevertheless, if Hon CHOY So-yuk wished to continue to speak on cultural policy, she would allow her to do so. Hon CHOY So-yuk continued to speak.

Another nine Members spoke.

At 4:49 pm, the President suspended the meeting for 10 minutes.

The Council resumed at 4:59 pm.

The Chief Secretary for Administration, the Secretary for Justice, the Secretary for Constitutional and Mainland Affairs, the Secretary for the Civil Service, the Secretary for Security and the Secretary for Home Affairs spoke.

The President announced the end of the first debate session and the commencement of the second debate session, which covered the following policy areas: energy, environmental affairs, food safety and environmental hygiene, home affairs, creative industry and heritage conservation.



Four Members and Hon Frederick FUNG spoke.

While Hon Frederick FUNG was speaking, the President left the chair at 6:41 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Four other Members and Hon Abraham SHEK spoke.

At 7:42 pm, while Hon Abraham SHEK was speaking, the President resumed the chair.

Two more Members and Hon LEE Cheuk-yan spoke.

Hon Mrs Selina CHOW raised a point of order on whether Hon LEE Cheuk-yan had used offensive language about other Members in his speech. The President then suspended the meeting at 8:09 pm.

The Council resumed at 8:26 pm.

The President stated that she had repeatedly viewed the video-recording of the speech of Hon LEE Cheuk-yan. She ruled that Hon LEE Cheuk-yan's speech had not used offensive language about other Members since he was only posing a question, and not making a comment.

Hon LEE Cheuk-yan continued to speak.

Three other Members spoke.

The President suspended the meeting at 9:04 pm.

\* \* \* \* \*

The Council resumed at 9:00 am on 25 October 2007 to continue the second debate session of the Motion of Thanks.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

Eleven Members spoke.

Hon Martin LEE said that as he had returned to Hong Kong the night before, his speech in the session in progress would also cover the subject of constitutional reform.

Hon Martin LEE spoke. The President interrupted him and asked him not to comment on the platforms of the candidates running for the Legislative Council by-election, as the Policy Address was the subject matter of the debate in progress. Hon Martin LEE continued to speak.

After Hon Martin LEE had spoken, the President pointed out that in response to enquires from some Members and Hon CHIM Pui-chung on whether they could speak on subjects other than those for the first debate session, she had asked

them to refrain from doing so. This was because she respected the House Committee's decision in respect of the policy areas of the five debate sessions. She also pointed out that the Rules of Procedure did not provide that the five debate sessions of the Motion of Thanks must be conducted in accordance with the arrangements endorsed by the House Committee, but she hoped that Members could comply with such decision as far as possible. Later, a Member raised a point of order and requested the Member who was speaking to speak on the subjects of the first session.

The President said that she was not personally satisfied with how the situation had been handled, because on the one hand, she, as the President, would certainly respect Members' right to speak freely and she had to safeguard Members' right to freedom of speech. On the other hand, she had to enforce the Rules of Procedure and respect the decision of the House Committee. In such circumstances, those Members who had initially sought her permission to speak on subjects other than those for the first debate session had refrained from doing so at her request. Yet she subsequently allowed other Members to speak on subjects other than those for the session in progress.

The President added that she felt sorry that some Members considered attending the regular meetings of the Legislative Council not as important as other matters, and she had made such remark with an aching heart. She hoped that Members would try their best to attend Council meetings, so that a good debate could be conducted in accordance with the Rules of Procedure and the decision of the House Committee. The President further said that if Members considered that the current arrangements were not satisfactory, she hoped that they would make adjustments or changes to the arrangements.

Another Member spoke.

At 11:49 am, the President suspended the meeting for 10 minutes.

The Council resumed at 11:59 am.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

The Secretary for the Environment, the Secretary for Development, the Secretary for Commerce and Economic Development, the Secretary for Food and Health and the Secretary for Home Affairs spoke.

While the Secretary for Home Affairs was speaking, the President left the chair at 12:59 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

With the President's Deputy's permission, Hon Tommy CHEUNG elucidated on a point he had made earlier and which he considered to be misunderstood by the Secretary for Food and Health.

The President's Deputy announced the end of the second debate session and the commencement of the third debate session, which covered the following policy areas: manpower, welfare services, social enterprise, family matters and allocation of public resources.

Five Members and Hon Ronny TONG Ka-wah spoke.

At 2:07 pm, while Hon Ronny TONG Ka-wah was speaking, the President resumed the chair.

Two Members spoke.

Hon Albert HO sought the President's permission to respond to Hon TSANG Yok-sing's earlier comments on Hon Martin LEE. The President said that as Hon Martin LEE and Hon TSANG Yok-sing had spoken in the second session, Hon Albert HO should have responded to their speeches in that session. She would still allow him to do so in the session in progress as he might not have sufficient time to consider whether he should make a response in the last debate session. However, the President added that if other Members sought to make similar responses after Hon Albert HO had spoken, she must also allow them to do so.

Hon Albert HO said that while he understood the President's ruling, he had to make a simple response for record purpose, as Hon TSANG Yok-sing's allegation was very serious.

Hon Albert HO and 18 other Members spoke.

At 6:16 pm, the President suspended the meeting for 10 minutes.

The Council resumed at 6:26 am.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

The Secretary for Labour and Welfare spoke.

While the Secretary for Labour and Welfare was speaking, the President left the chair at 6:29 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

The Secretary for Home Affairs and the Secretary for Financial Services and the Treasury spoke.

The President's Deputy announced the end of the third debate session and the commencement of the fourth debate session, which covered the following policy areas: education, health services and immigration policies.

Hon Andrew CHENG spoke.

At 7:16 pm, while Hon Andrew CHENG was speaking, the President resumed the chair.

Eleven other Members spoke.

The President suspended the meeting at 8:57 pm.

The Council resumed at 9:00 am on 26 October 2007 to continue the fourth debate session of the Motion of Thanks.

Ten Members spoke.

At 10:02 am, the President suspended the meeting for 10 minutes.

The Council resumed at 10:12 am.

The Secretary for Education, the Secretary for Food and Health and the Secretary for Security spoke.

The President announced the end of the fourth debate session and the commencement of the fifth debate session, which covered the following policy areas: commerce and industry, economic services, financial services, housing, information technology and broadcasting, planning, lands and works and transport.

Three Members and Hon WONG Ting-kwong spoke.

While Hon WONG Ting-kwong was speaking, Hon Margaret NG indicated her intention to seek elucidation of a point raised in his speech. Hon WONG Ting-kwong elucidated.

Two other Members and Hon CHAN Kam-lam spoke.

While Hon CHAN Kam-lam was speaking, the President left the chair at 11:52 am temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Ten Members and Hon LEUNG Kwok-hung spoke.

At 1:20 pm, while Hon LEUNG Kwok-hung was speaking, the President resumed the chair.

Twelve more Members spoke.

At 2:37 pm, the President suspended the meeting for 10 minutes.

The Council resumed at 2:47 pm.

The Financial Secretary, the Secretary for Development, the Secretary for Transport and Housing, the Secretary for Commerce and Economic Development and the Secretary for Financial Services and the Treasury spoke.

The President announced the end of the fifth debate session.

Hon Miriam LAU spoke on the amendments.

Hon Albert HO moved the following amendment to Hon Miriam LAU's motion:

To add ", but strongly requests the Government to increase the rates of the Old Age Allowance for the elderly" immediately before the full stop.

Dr Hon Philip WONG declared his interest on the Old Age Allowance.

Question on Hon Albert HO's amendment to Hon Miriam LAU's motion proposed.

Hon Fred LI moved the following amendment to Hon Albert HO's amendment:

To delete "Old Age Allowance" after "the rates of the" and substitute with "Normal Old Age Allowance and Higher Old Age Allowance"; and to add "to \$900 and \$1,000 per month respectively, so as to improve the life of the poor elderly" immediately before the full stop.

Question on Hon Fred LI's amendment to Hon Albert HO's amendment proposed, put and agreed to.

Question on Hon Albert HO's amendment, as amended by Hon Fred LI, to Hon Miriam LAU's motion put and agreed to.

As Hon Albert HO's amendment as amended by Hon Fred LI had been agreed earlier, the President granted leave for Hon Andrew CHENG to revise the terms of his amendment and explain them to the Council.

Hon Andrew CHENG moved the following further amendment to Hon Miriam LAU's motion as amended by Hon Albert HO and Hon Fred LI, and explained the revised terms of his amendment to the Council.

To add "; this Council also expresses deep disappointment that, despite a huge surplus in the government treasury, the Chief Executive only deploys a meagre amount of resources to enhance the medical services for the elderly, which is hardly sufficient to meet the medical needs of the elderly in the lower class; this Council urges the Chief Executive and the Government to adopt measures and devote more resources to enhance the medical services for the elderly, including extending the beneficiaries of the health care vouchers to all senior citizens aged 65 or above, increasing the amount of subsidy for each elderly recipient, offering half-fee concession for public medical services to all senior citizens, setting up a fund to subsidize dental services for the elderly, and providing all senior citizens with free vaccination against influenza, etc" immediately before the full stop.

Question on Hon Andrew CHENG's amendment to Hon Miriam LAU's motion as amended by Hon Albert HO and Hon Fred LI proposed, put and agreed to.

As Hon Albert HO's amendment as amended by Hon Fred LI and Hon Andrew CHENG's amendment had been agreed earlier, the President granted leave for Hon Frederick FUNG to revise the terms of his amendment and explained them to the Council.

Hon Frederick FUNG moved the following further amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI and Hon Andrew CHENG, and explain the revised terms of his amendment to the Council:

To add "; this Council at the same time urges the Government to set up an ad hoc committee headed by the Chief Secretary for Administration to tackle the problem of poverty, and to expeditiously implement the recommendations put forward by the Commission on Poverty and the Legislative Council Subcommittee to Study the Subject of Combating Poverty in their reports, as well as to deploy more resources to develop social enterprises" immediately before the full stop.

Question on Hon Frederick FUNG's amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI and Hon Andrew CHENG proposed, put and agreed to.

As Hon Albert HO's amendment as amended by Hon Fred LI, Hon Andrew CHENG's amendment and Hon Frederick FUNG's amendment had been agreed earlier, the President granted leave for Hon Emily LAU to revise the terms of her amendment and explained them to the Council.

Hon Emily LAU moved the following further amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI, Hon Andrew CHENG and Hon Frederick FUNG, and explained the revised terms of her amendment to the Council:

To add "; in addition, as the majority of people support the implementation of dual universal suffrage in 2012, this Council expresses regret at the Chief Executive's lack of commitment to the expeditious implementation of dual universal suffrage and his failure to make every effort to convince those who are against the implementation of dual universal suffrage in 2012" immediately before the full stop.

Question on Hon Emily LAU's amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI, Hon Andrew CHENG and Hon Frederick FUNG proposed and put.

Hon Emily LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, seven were in favour of the amendment, 19 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, 16 were in favour of the amendment, nine against it and one abstained. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Motion of Thanks" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

As Hon Albert HO's amendment as amended by Hon Fred LI, Hon Andrew CHENG's amendment and Hon Frederick FUNG's amendment had been agreed earlier, the President granted leave for Hon Albert CHAN to revise the terms of his amendment and explain them to the Council.

Hon Albert CHAN moved the following further amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI, Hon Andrew CHENG and Hon Frederick FUNG, and explained the revised terms of his amendment to the Council:

To add "; in addition, this Council expresses deep regret at and strong condemnation of the policy address's failure to respond specifically to the hardship and pressure of the life of the grass-roots people" immediately before the full stop.

Question on Hon Albert CHAN's amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI, Hon Andrew CHENG and Hon Frederick FUNG proposed and put.

Hon Albert CHAN claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, five were in favour of the amendment, 19 against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, eight were in favour of the amendment, 10 against it and eight abstained. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

As Hon Albert HO's amendment as amended by Hon Fred LI, Hon Andrew CHENG's amendment and Hon Frederick FUNG's amendment had been agreed earlier, the President granted leave for Hon LEUNG Yiu-chung to revise the terms of his amendment and explain them to the Council.

Hon LEUNG Yiu-chung moved the following further amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI, Hon Andrew CHENG and Hon Frederick FUNG, and explained the revised terms of his amendment to the Council:

To add "; in addition, this Council expresses deep regret that the Chief Executive has not taken any concrete steps to prescribe a statutory minimum wage and standard working hours, nor has he offered any assistance to the serving non-civil service contract staff in resolving their plight of possible loss of job, while at the same time disregarding protection for the livelihood of the grass-roots workers" immediately before the full stop.

Question on Hon LEUNG Yiu-chung's amendment to Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI, Hon Andrew CHENG and Hon Frederick FUNG proposed and put.

Hon LEUNG Yiu-chung claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, eight were in favour of the amendment, 17 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, 16 were in favour of the amendment, nine against it and one abstained. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU replied.

Question on Hon Miriam LAU's motion as amended by Hon Albert HO, Hon Fred LI, Hon Andrew CHENG and Hon Frederick FUNG put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, 22 were in favour of the motion as amended and five abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, 17 were in favour of the motion as amended, four against it and five abstained. (Voting record in Appendix V.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the motion as amended was carried.
