Bills

Appropriation Bill 2008

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 27 February 2008 resumed.

Hon LEUNG Kwok-hung raised a point of order on whether he could speak. The President said that she could not allow him to do so, because the arrangement was for Members to speak at the previous Council meeting held on Wednesday and Thursday of the week before, and for government officials to speak at this meeting. If she allowed him to speak, she would set a precedent and render the arrangement meaningless. The President added that Hon LEUNG Kwok-hung would have an opportunity to speak when the Council went into Committee to consider the Bill.

The Secretary for Education, the Secretary for Food and Health, as well as the Secretary for Labour and Welfare spoke on the motion.

The Financial Secretary replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Appropriation Bill 2008**.

In accordance with Rule 68 of the Rules of Procedure, the Committee first considered the schedule to the Bill.

Question that the sums for heads 21 to 28, 30, 31, 33, 37, 39, 42, 44 to 49, 51, 55, 59, 60, 62, 63, 70, 72, 74, 76, 78, 79, 80, 82, 90, 91, 92, 94, 95, 96, 100, 106, 112, 114, 116, 118, 120, 121, 136, 140, 143, 148, 155, 159, 160, 162, 163, 166, 168, 169, 170, 173, 174, 180, 181, 184, 186, 188, 190 and 194 stand part of the schedule proposed, put and agreed to.

Question that the sums for heads 53, 137, 138, 139, 141, 142, 144, 147, 151, 152, 156 and 158 stand part of the schedule proposed.

Dr Hon YEUNG Sum moved that heads 53, 137, 138, 139, 141, 144, 147, 151, 152, 156 and 158 be reduced by \$4,650,000 respectively and that head 142 be reduced by \$3,940,000 in respect of subhead 000 and addressed the Committee.

Three Members and Hon LEUNG Kwok-hung spoke on the amendments.

While Hon LEUNG Kwok-hung was speaking, Hon Martin LEE drew the attention of the Chairman to the absence of a quorum. The Chairman directed the Clerk to summon Members to the meeting. A quorum was then present and Hon LEUNG Kwok-hung continued to speak.

Dr Hon KWOK Ka-ki spoke on the amendments.

While Dr Hon KWOK Ka-ki was speaking, the Chairman left the chair at 1:30 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Two more Members and Dr Hon Fernando CHEUNG spoke on the amendments.

At 2:09 pm, while Dr Hon Fernando CHEUNG was speaking, the Chairman resumed the chair.

Hon CHIM Pui-chung drew the attention of the Chairman to the absence of a quorum. The Chairman directed the Clerk to summon Members to the meeting. A quorum was then present

One Member and Hon TAM Yiu-chung spoke on the amendments.

With the Chairman's permission, Hon Frederick FUNG elucidated a point he had made earlier which he considered to be misunderstood by Hon TAM Yiu-chung.

Three more Members spoke on the amendments.

The Secretary for Constitutional and Mainland Affairs spoke on the amendments.

Dr Hon YEUNG Sum spoke again.

Question on the amendments put.

Dr Hon YEUNG Sum claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 27 were present, six were in favour of the amendments and 21 against it; while among the Members returned by geographical constituencies through direct elections, 28 were present, 16 were in favour of the amendments and 11 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendments were negatived.

Question that the sums for heads 53, 137, 138, 139, 141, 142, 144, 147, 151, 152, 156 and 158 stand part of the schedule proposed, put and agreed to.

Question that the sum for head 122 stand part of the schedule proposed.

Hon James TO moved that head 122 be reduced by \$47,790,000 in respect of subhead 000 and addressed the Committee.

One Member and the Secretary for Security spoke on the amendment.

While the Secretary for Security was speaking, Hon James TO sought, with the Chairman's permission, elucidation by the Secretary of a point raised in his speech.

Hon James TO spoke again.

Question on the amendment put.

Hon James TO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 26 were present, six were in favour of the amendment and 20 against it; while among the Members returned by geographical constituencies through direct elections, 21 were present, 10 were in favour of the amendment and 10 against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon James TO moved that head 122 be reduced by \$80,000,000 in respect of subhead 103 and addressed the Committee.

One Member and the Secretary for Security spoke on the amendment.

Hon James TO spoke again.

Question on the amendment put.

Hon James TO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, four were in favour of the amendment and 20 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 11 were in favour of the amendment and 11 against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Question that the sum for head 122 stand part of the schedule proposed, put and agreed to.

Question that the schedule stand part of the Bill put and agreed to.

Question that clauses 1 and 2 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Financial Secretary reported that

the **Appropriation Bill 2008**

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed and put.

Hon Albert CHAN claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 51 Members were present, 45 were in favour of the motion, three against it and two abstained. (Voting record in Appendix IV.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the third time and passed.

Mainland Judgments (Reciprocal Enforcement) Bill

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 7 March 2007 resumed.

Hon Margaret NG, Chairman of the Bills Committee on Mainland Judgments (Reciprocal Enforcement) Bill, addressed the Council on the Committee's Report. After the address, she spoke on the Bill in her personal capacity as a Member.

Three Members spoke on the Bill.

The Secretary for Justice replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Mainland Judgments (Reciprocal Enforcement) Bill**.

Question that clauses 1, 4, 8 to 13, 15, 16, 20, 22, 23, 24 and 26 stand part of the Bill proposed, put and agreed to.

Question that clauses 2, 3, 5, 6, 7, 14, 17, 18, 19, 21 and 25 stand part of the Bill proposed.

The Secretary for Justice moved amendments to the aforesaid clauses and addressed the Committee.

One Member spoke on the amendments.

The Secretary for Justice spoke again.

Question on the amendments put and agreed to.

Question that clauses 2, 3, 5, 6, 7, 14, 17, 18, 19, 21 and 25, as amended, stand part of the Bill proposed, put and agreed to.

New clause 25A read the first time.

The Secretary for Justice moved the Second Reading of new clause 25A and addressed the Committee.

Question on the Second Reading of new clause 25A proposed, put and agreed to.

New clause 25A read the second time.

The Secretary for Justice moved the addition of new clause 25A to the Bill.

Question on the addition proposed, put and agreed to.

Question that schedule 1 stand part of the Bill proposed, put and agreed to.

Question that schedule 2 stand part of the Bill proposed.

The Secretary for Justice moved amendments to schedule 2 and addressed the Committee.

One Member spoke on the amendments.

The Secretary for Justice spoke again.

Question on the amendments put and agreed to.

Question that schedule 2, as amended, stand part of the Bill proposed, put and agreed to.

Question that the long title stand part of the Bill proposed.

The Secretary for Justice moved the amendments to the long title and addressed the Committee.

One Member spoke on the amendments.

Question on the amendments put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Justice reported that

the **Mainland Judgments (Reciprocal Enforcement) Bill**

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Legislative Council (Amendment) Bill 2007

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 19 December 2007 resumed.

Hon Howard YOUNG, Chairman of the Bills Committee on Legislative Council (Amendment) Bill 2007, addressed the Council on the Committee's Report.

While Hon Howard YOUNG was addressing the Council, the President left the chair at 7:15 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

After the address, Hon Howard YOUNG spoke on the Bill in his personal capacity as a Member.

Six Members and Hon Margaret NG spoke on the Bill.

At 8:30 pm, while Hon Margaret NG was speaking, the President resumed the chair.

Another Member spoke on the Bill.

The Secretary for Constitutional and Mainland Affairs replied.

Question on the Second Reading put.

Hon Ronny TONG Ka-wah claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 33 Members were present, 20 were in favour of the motion and 12 against it. (Voting record in Appendix V.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Legislative Council (Amendment) Bill 2007**.

Question that clauses 1 and 3 to 6 stand part of the Bill proposed, put and agreed to.

Question that clauses 2 and 7 to 10 stand part of the Bill proposed.

The Secretary for Constitutional and Mainland Affairs moved the deletion of clause 2 and amendments to clauses 7 to 10 and addressed the Committee.

Question on the amendments put and agreed to.

The Chairman stated that as the amendment to clause 2, which dealt with deletion, had been agreed, clause 2 was therefore deleted from the Bill.

Question that clauses 7 to 10, as amended, stand part of the Bill proposed, put and agreed to.

New clause 6A read the first time.

The Secretary for Constitutional and Mainland Affairs moved the Second Reading of new clause 6A and addressed the Committee.

Question on the Second Reading of new clause 6A proposed, put and agreed to.

New clause 6A read the second time.

The Secretary for Constitutional and Mainland Affairs moved the addition of new clause 6A to the Bill.

Question on the addition proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Constitutional and Mainland Affairs reported that

the **Legislative Council (Amendment) Bill 2007**

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Next Meeting

The President declared that the next meeting of the Council would be held on 30 April 2008 at 11:00 am.

The Council was adjourned at 9:17 pm.


