Bills

Prevention of Bribery (Amendment) Bill 2007

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 11 July 2007 resumed.

Hon TSANG Yok-sing, Chairman of the Bills Committee on Prevention of Bribery (Amendment) Bill 2007, addressed the Council on the Committee's Report.

While Hon TSANG Yok-sing was addressing the Council, Hon Margaret NG raised a point of order. She said that the President had previously informed Members of her decision that if the tropical cyclone warning signal no. 8 was cancelled before 11:00 am, the Council meeting would be held at 2:30 pm that day; otherwise the Council meeting would be held at As it turned out to be the latter 9:00 am the following day. case, Hon Margaret NG queried if sufficient notice had been given for the Council meeting to be held at 2:30 pm that day, as so decided by the President. She expressed concern that the legal effect of decisions made by the Council meeting might be called into question.

Dr Hon YEUNG Sum expressed similar concern.

The President said that she had already considered questions raised by Hon Margaret NG and Dr Hon YEUNG Sum. President explained that when she informed Members of her decision on 24 June 2008, it was not sure when the tropical cyclone would move away from Hong Kong. After it was announced that the cyclone had moved away from Hong Kong at around 7:00 am on 25 June 2008, she had been watching closely when the tropical cyclone signal no. 8 would be cancelled. The President added that while it was necessary to give of the meeting, sufficient notice Members she had reschedule the meeting to be held as soon as practicable because of its long agenda. In the morning of 25 June 2008, had called her and staff of the Secretariat, the Council indicating their wish that meeting be held The President said that she had sought at 2:30 pm that day. legal advice, and that it was legally in order to hold the meeting as rescheduled, and that the notice given sufficient. Moreover, the change of meeting time would not affect the legal effect of the proceedings of the Council.

Hon Martin LEE said that he was the Member who called the President to ask about the Council meeting time. As banks and the Hong Kong Disneyland had announced on 25 June 2008 that they would be open two hours after tropical cyclone warning signal no. 8 was lowered, he therefore considered that given its heavy workload, the Legislative Council should also hold its meeting in that afternoon.

Hon Margaret NG requested the President to set out her explanation in writing. The President acceded to the request.

Hon Miriam LAU said that according to Rule 14(3) of the Rules of Procedure, the President might, at any time after she had determined the day and hour upon which a meeting was to begin, change the day or hour so determined to a later day or hour, or to an earlier day or hour. She asked whether the President had considered that Rule.

The President said that she had considered that Rule when discussing the matter with the Legal Adviser.

Hon TSANG Yok-sing continued to address the Council. After the address, he spoke on the Bill in his personal capacity as a Member.

While Hon TSANG Yok-sing was addressing the Council, the President left the chair at 4:43 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Four Members and Hon Ronny TONG Ka-wah spoke on the Bill.

At 5:51 pm, while Hon Ronny TONG Ka-wah was speaking, the President resumed the chair.

Two more Members spoke on the Bill.

The Chief Secretary for Administration replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Prevention** of Bribery (Amendment) Bill 2007.

Question that clauses 1 to 4 stand part of the Bill proposed.

Two Members spoke on the clauses.

The Chief Secretary for Administration spoke on the clauses.

The two Members who had spoken spoke again, and then one of them spoke for the third time.

The Chief Secretary for Administration spoke again.

Question that clauses 1 to 4 stand part of the Bill put and agreed to.

Question that clause 5 stand part of the Bill proposed.

Council resumed by order of the Chairman. The President then granted leave for Hon Margaret NG to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(5) of the Rules of Procedure in order that the Committee of the whole Council could consider new clause 4A together with clause 5.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New clause 4A read the first time.

The Chairman stated that Hon Margaret NG had given notice to move the deletion of clause 5 and the addition of new clause 4A. Dr Hon YEUNG Sum and the Chief Secretary for Administration had separately given notice to move amendments to clause 5. She ordered that the aforesaid clauses and amendments be debated together in a joint debate.

Hon Margaret NG spoke on her amendments.

While Hon Margaret NG was speaking, the Chairman left the chair at 7:07 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Dr Hon YEUNG Sum and the Chief Secretary for Administration spoke on Hon Margaret NG's amendment and their proposed amendments.

Two Members spoke on these amendments.

Dr Hon YEUNG Sum and Hon Margaret NG spoke again.

At 8:01 pm, while Hon Margaret NG was speaking, the Chairamn resumed the chair.

Another Member spoke on these amendments.

A Member and the Chief Secretary for Administration spoke again.

Hon Margaret NG and another Member spoke for the third time.

A Member spoke for the fourth time.

Before putting to Members the question on Hon Margaret NG's amendment to clause 5, the Chairman reminded Members that if Hon Margaret NG's amendment was agreed, Dr Hon YEUNG Sum and the Chief Secretary for Administration might not move their amendments to clause 5. If Hon Margaret NG's amendment was negatived, Dr Hon YEUNG Sum might move his amendment to clause 5. Subject to the voting result of Dr Hon YEUNG Sum's amendment, the Committee will then deal with the Chief Secretary for Administration's amendments to clause 5. On the other hand, irrespective of whether the amendments moved to clause 5 were passed or not, Hon Margaret NG might move the second reading of new clause 4A.

Question on the amendment moved by Hon Margaret NG put.

Hon Margaret NG claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 28 were present, seven were in favour of the amendment and 21 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 14 were in favour of the amendment and eight against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in respect of the remaining provisions of the Prevention of Bribery (Amendment) Bill 2007 or amendments thereto, the Committee do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Dr Hon YEUNG Sum moved the amendment to clause 5.

Before putting to Members the question on Dr Hon YEUNG Sum's amendment to clause 5, the Chairman reminded Members that if Dr Hon YEUNG Sum's amendment was agreed, the Chief Secretary for Administration might not move his amendment to the proposed section 31AA in clause 5, but the Secretary may move his remaining amendments to clause 5. If Dr Hon YEUNG Sum's amendment was negatived, the Secretary might move all his amendments to clause 5.

Question on the amendment moved by Dr Hon YEUNG Sum put.

Dr Hon YEUNG Sum claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 28 were present, seven were in favour of the amendment and 21 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 14 were in favour of the amendment and eight against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

The Chief Secretary for Administration moved the amendments to clause 5.

Question on the amendments moved by the Chief Secretary for Administration put.

Hon Margaret NG claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that 51 Members were present, 33 were in favour of the amendments and 17 against them. (Voting record in Appendix III.) Since the question was agreed by a majority of the Members present, she declared that the amendments were agreed.

Question that clause 5 as amended stand part of the Bill proposed, put and agreed to.

Hon Margaret NG moved the Second Reading of new clause 4A.

Question on the Second Reading of new clause 4A proposed and put.

Hon Margaret NG claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 28 were present, eight were in favour of the motion and 20 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 13 were in favour of the motion and nine against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.

Question that clause 6 stand part of the Bill proposed.

The Chief Secretary for Administration moved an amendment to clause 6 and addressed the Committee.

Question on the amendment put and agreed to.

Question that clause 6, as amended, stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Chief Secretary for Administration reported that

the Prevention of Bribery (Amendment) Bill 2007

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed and put.

Hon Emily LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 48 Members were present, 45 were in favour of the motion, one against it and one abstained. (Voting record in Appendix V.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the third time and passed.

Revenue Bill 2008

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 7 May 2008 resumed.

Hon Andrew LEUNG Kwan-yuen, Chairman of the Bills Committee on Revenue Bill 2008, addressed the Council on the Committee's Report. After the address, he spoke on the Bill in his personal capacity as a Member.

Fourteen Members spoke on the Bill.

The Secretary for Financial Services and the Treasury replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

The President suspended the meeting at 11:49 pm.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

Committee Stage

The Council went into Committee and considered the Revenue Bill 2008.

Question that clauses 1, 2, 4, 5, 6, 8, 9 and 11 to 19 stand part of the Bill proposed, put and agreed to.

Question that clause 7 stand part of the Bill proposed.

Six Members spoke on the clause.

Two of these Members spoke again.

Five more Members and the Secretary for Financial Services and the Treasury spoke on the clause.

Another Member spoke on the clause.

Question that clause 7 stand part of the Bill put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that 52 Members were present, 34 were in favour of the motion, 15 against it and one abstained. (Voting record in Appendix VI.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in respect of the remaining provisions of the Revenue Bill 2008 or amendments thereto, the Committee do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Question that clause 10 stand part of the Bill proposed.

Hon LEE Cheuk-yan moved amendments to clause 10 and addressed the Committee as a Member of the Bills Committee on Revenue Bill 2008. After the address, he spoke on the amendments in his personal capacity as a Member.

Three Members and the Secretary for Financial Services and the Treasury spoke on the amendments.

Hon LEE Cheuk-yan and another Member spoke again.

A Member spoke on the amendments.

Before putting to Members the question on Hon LEE Cheuk-yan's amendments to clause 10, the Chairman reminded Members that if Hon LEE Cheuk-yan's amendment was negatived, Hon LEE Cheuk-yan might not move his remaining amendments.

Question on the amendments moved by Hon LEE Cheuk-yan put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, eight were in favour of the amendments and 16 against them; while among the Members returned by geographical constituencies through direct elections, 24 were present, 14 were in favour of the amendments, eight against them and one abstained. (Voting record in Appendix VII.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendments were negatived.

The Chairman stated that as Hon LEE Cheuk-yan's amendments had been negatived, he might not move his amendment to clause 3, nor the second reading of new clauses 2A, 2B, 2C, 4A and 5A, which were inconsistent with the decision already taken.

Question that clause 10 stand part of the Bill put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that 50 Members were present, 38 were in favour of the motion and 10 against it. (Voting record in Appendix VIII.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Question that clause 3 stand part of the Bill put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Financial Services and the Treasury reported that

the Revenue Bill 2008

had passed through the Committee without amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed.

Two Members spoke on the motion.

Question on the Third Reading put.

Hon LEE Cheuk-yan claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 50 Members were present, 43 were in favour of the motion. (Voting record in Appendix IX.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the third time and passed.

Road Traffic Legislation (Amendment) Bill 2008

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 20 February 2008 resumed.

Hon Miriam LAU, Chairman of the Bills Committee on Road Traffic Legislation (Amendment) Bill 2008, addressed the Council on the Committee's Report. After the address, she spoke on the Bill in her personal capacity as a Member.

Hon CHEUNG Hok-ming spoke on the Bill.

While Hon CHEUNG Hok-ming was speaking, the President left the chair at 12:15 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Three other Members spoke on the Bill.

The Secretary for Transport and Housing replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Road Traffic Legislation (Amendment) Bill 2008.

Question that clauses 1, 2, 4, 5, 6, 12 to 19, 21 to 24, 26, 27, 30 to 33, 35, 36, 38 to 49, 51 to 58 and 61 to 70 stand part of the Bill proposed, put and agreed to.

Question that clauses 3, 9, 11, 20, 25, 28, 29, 34, 37, 50, 59 and 60 stand part of the Bill proposed.

The Secretary for Transport and Housing moved amendments to the aforesaid clauses and addressed the Committee.

Question on the amendments put and agreed to.

Question that clauses 3, 11, 20, 25, 28, 29, 34, 37, 50, 59 and 60, as amended, stand part of the Bill proposed, put and agreed to.

Question that clauses 7, 8 and 10 stand part of the Bill proposed.

Hon Andrew CHENG moved amendments to clauses 7, 8 and 10 and further amendments to clause 9, and addressed the Committee.

At 1:13 pm, while Hon Andrew CHENG was addressing the Council, the Chairman resumed the chair.

A Member and the Secretary for Transport and Housing spoke on the amendments.

Hon Andrew CHENG spoke again.

Question on the amendments moved by Hon Andrew CHENG put.

Hon Andrew CHENG claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule $47\,(1)$ of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 22 were present, five were in favour of the amendments, 15 against them and two abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, 13 were in favour of the amendments, six against them and one abstained. (Voting record in Appendix X.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendments were negatived.

Question that clauses 7, 8 and 10 stand part of the Bill put and agreed to.

Question that clause 9 as amended stand part of the Bill proposed, put and agreed to.

New clauses 62A and 62B read the first time.

The Secretary for Transport and Housing moved the Second Reading of the aforesaid clauses and addressed the Committee.

Question on the Second Reading of the aforesaid clauses proposed, put and agreed to.

New clauses 62A and 62B read the second time.

The Secretary for Transport and Housing moved the addition of the aforesaid clauses to the Bill.

Question on the addition proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Transport and Housing reported that

the Road Traffic Legislation (Amendment) Bill 2008

had passed through the Committee with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Motions

The Secretary for Constitutional and Mainland Affairs moved the following motion and addressed the Council:

Hon James TO spoke on the motion as Chairman of the Subcommittee on Subsidiary Legislation to Implement the Obligations under the United Nations Convention Against Transnational Organized Crime.

Question on the motion put and agreed to.

2. Mutual Legal Assistance in Criminal Matters (Finland) Order

The Secretary for Constitutional and Mainland Affairs moved the following motion and addressed the Council:

RESOLVED that the Mutual Legal Assistance in Criminal Matters (Finland) Order, made by the Chief Executive in Council on 22 April 2008, be approved.

Question on the motion proposed.

Hon James TO spoke on the motion as Chairman of the Subcommittee on Mutual Legal Assistance in Criminal Matters (Finland) Order.

Question on the motion put and agreed to.

Members' Bills

The Hong Kong University of Science and Technology (Amendment) Bill 2008

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 11 June 2008 resumed.

Hon Abraham SHEK spoke on the Bill.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered The Hong Kong University of Science and Technology (Amendment) Bill 2008.

Question that clauses 1 to 8 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

Hon Abraham SHEK reported that

The Hong Kong University of Science and Technology (Amendment) Bill 2008

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Members' Motions

Proposed resolution under the Interpretation and General Clauses Ordinance

Hon LEE Cheuk-yan moved the following motion and addressed the Council:

RESOLVED that the Pension Benefits Ordinance (Established Offices) (Amendment) (No. 2) Order 2008, published in the Gazette as Legal Notice No. 104 of 2008 and laid on the table of the Legislative Council on 7 May 2008, be repealed.

Question on the motion proposed.

Hon LI Fung-ying addressed the Council on the motion as a Member of the Subcommittee on Pension Benefits Ordinance (Established Offices) (Amendment) (No. 2) Order 2008. After the address, she spoke on the motion in her personal capacity as a Member.

Three Members and the Secretary for the Civil Service spoke on the motion.

Hon LEE Cheuk-yan replied.

Question on the motion put and negatived.

Address by the Chief Executive

The President said that under Rule 8 of the Rules of Procedure, the Chief Executive might at his discretion attend meetings of the Council, or any committee or subcommittee thereof, for the following purpose, as set out in paragraph (a) of that Rule: addressing the Council at any time as he should think fit, including during a special meeting. At around noon 26 June 2008, the Secretary General of the Legislative Council Secretariat received a letter from the Director Administration informing him that the Chief Executive would like to address the Council on the further development of the political appointment system before the commencement of the second Members' motion on the Agenda of the Council meeting. President said that Members had received the revised Agenda and Script as well as a copy of the letter from the Director of Administration.

Hon Martin LEE raised a point of order on whether the Chief Executive had to perform all the duties set out in paragraphs (a), (b) and (c) of Rule 8 of the Rules of Procedure, when the Chief Executive attended a Council meeting under that Rule.

The President replied that it was not the case and pointed out that the Chief Executive attended question and answer sessions under paragraph (b) of that Rule.

The Chief Executive addressed the Council.

Hon James TO said that according to Rule 8 of the Rules of Procedure, Members might be allowed to immediately ask questions on the Chief Executive's address, provided that the Chief Executive was willing to answer them and the President gave permission. Hon James TO asked whether the Chief Executive was willing to do so.

The President said that the Chief Executive had indicated in his address that he would answer Members' questions on 16 July 2008. As paragraph (a) of Rule 8 did not mention whether the Chief Executive could answer Members' questions, she had to respect the Chief Executive's wishes.

The Chief Executive said that he had attended the Council meeting and addressed the Council under paragraph (a) of Rule 8 of the Rules of Procedure, which did not include the arrangement of answering Members' questions. The asking and answering of questions should follow the procedure laid down in paragraph (b) of that Rule. If Members had questions on his address, his colleagues would answer them at the debate of the Member's motion to be held immediately after his address. He would also answer Members' questions at the Council meeting on 16 July 2008.

Seeking papers, books, records and documents regarding the salary and fringe benefits of Under Secretaries and Political Assistants

Hon LEE Wing-tat moved the following motion and addressed the Council:

That, pursuant to section 9(1) of the Legislative Council (Powers and Privileges) Ordinance (Cap. 382), this Council orders the Director of Chief Executive's Office of the Hong Kong Special Administrative Region to attend before the Council on 2 July 2008 to produce any papers, books, records or documents in relation to matters regarding the salary and fringe benefits of Under Secretaries and Political Assistants.

While Hon LEE Wing-tat was addressing the Council, the President left the chair at 3:58 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on the motion proposed.

The Chief Secretary for Administration spoke on the motion.

At 4:11 pm, while the Chief Secretary for Administration was speaking, the President resumed the chair.

The Secretary for Justice spoke on the motion.

While the Secretary for Justice was speaking, Hon Albert HO requested the Secretary to elucidate a point raised by him in his speech. The Secretary continued to speak and elucidated after he had finished his speech.

Nine Members and Hon Albert HO spoke on the motion.

While Hon Albert HO was speaking, the President left the chair at 6:25 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Five other Members and Hon LEUNG Kwok-hung spoke on the motion.

At 7:58 pm, while Hon LEUNG Kwok-hung was speaking, the President resumed the chair.

Hon Emily LAU spoke on the motion.

While Hon Emily LAU was speaking, Hon CHIM Pui-chung drew the attention of the President to the absence of a quorum. The President directed the Clerk to summon Members to the meeting.

Nine more Members spoke on the motion.

The Secretary for Education, the Secretary for the Civil Service and the Secretary for Constitutional and Mainland Affairs spoke on the motion.

Hon LEE Wing-tat replied.

Question on the motion put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, seven were in favour of the motion, 20 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 15 were in favour of the motion and nine against it. (Voting record in Appendix XI.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.

The President suspended the meeting at 10:57 pm.

While Dr Hon Fernando CHEUNG was speaking, the President left the chair at 11:20 am temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

The Secretary for Home Affairs spoke again.

Hon Alan LEONG Kah-kit replied.

At 11:37 am, while Hon Alan LEONG Kah-kit was speaking, the President resumed the chair.

Question on the motion put and agreed to.

Enhancing co-operation between Hong Kong and Macao

Hon TSANG Yok-sing moved the following motion and addressed the Council:

That, in view of Macao's close proximity to Hong Kong and its remarkable development in recent years, there is much room for co-operation between the two places to achieve synergy through complementing and reinforcing each other, this Council urges the Government to enhance the co-operation between Hong Kong and Macao on all fronts, set up a permanent and high-level co-operation mechanism, and formulate overall plans and policy measures, so as to promote joint development of Hong Kong and Macao.

While Hon TSANG Yok-sing was addressing the Council, the President left the chair at 11:39 am temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Hon TSANG Yok-sing's motion proposed.

The President's Deputy stated that Hon CHEUNG Man-kwong intended to move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon CHEUNG Man-kwong moved the following amendment to Hon TSANG Yok-sing's motion and addressed the Council:

To add ", both being Special Administrative Regions of our country," after "Macao's close proximity to Hong Kong"; and to add "safeguard the freedom of lawful border-crossing between and human rights of the two places, strengthen anti-corruption and judicial co-operation between the two places," after "on all fronts,".

Question on Hon CHEUNG Man-kwong's amendment to Hon TSANG Yoksing's motion proposed.

The Secretary for Constitutional and Mainland Affairs spoke on the motion and the amendment.

Five Members and Hon Jeffrey LAM Kin-fung spoke on the motion and the amendment.

While Hon Jeffrey LAM Kin-fung was speaking, the President left the chair at $12:44~\rm pm$ temporarily and the President's Deputy, Hon Fred LI, took the chair.

Three other Members and Hon Albert Jinghan CHENG spoke on the motion and the amendment.

At 1:05 pm, while Hon Albert Jinghan CHENG was speaking, the President resumed the chair.

Another Member spoke on the motion and the amendment.

Hon TSANG Yok-sing spoke on the amendment.

The Secretary for Constitutional and Mainland Affairs spoke again.

Question on Hon CHEUNG Man-kwong's amendment to Hon TSANG Yoksing's motion put and negatived.
