Revised Order 53 - Judicial Review

2. The Subcommittee noted the Judiciary's proposal to remove all requirements relating to "interested parties" from the revised Order 53 [LC Paper No. CB(2)1983/07-08(02)] having regard to members' concerns. Members, however, did not agree that such requirements should be removed altogether, as they did not object in principle to the proposal of requiring applicants for leave for judicial review to serve on interested parties with a view to expediting the proceedings by involving interested parties at an earlier stage. Rather, their concern was about the added obligations imposed on applicants by the rules concerning interested parties such as Order 53 rule 4A(2). The Judiciary Administration agreed to relay members' views and concerns to the Steering Committee for further consideration (For details, please refer to the Annex).

She was however concerned about the added obligations imposed on the applicant by the rules such as the requirement under Order 53 rule 4A(2) that the applicant should serve the order granting leave to all interested parties within 14 days. In her view, such arrangements should be dealt with by way of court directions so as to allow flexibility to cater for the circumstances of individual cases. As such, she did not consider it necessary to remove all requirements in the revised Order 53 relating to "interested parties". Instead, amendments should be made to the rules to address members' concerns</p> <p>Ms Miriam LAU shared the Chairman's views and suggested that the revised Order 53 rule 3(2)(a)(iv) be amended by adding the words 'known to the applicant' at the end of the sentence</p> <p>JA agreed to relay members' views to the Steering Committee for consideration</p>	<b>JA to follow up</b>
