Follow-up actions required to be taken by the Administration

*Six items of subsidiary legislation under the Trade Descriptions Ordinance (Cap. 362) gazetted on 18 April 2008 (the subsidiary legislation)*

2. To address members' concern about the lack of protection for retailers when they were supplied with goods in the course of their business, the Administration undertook to review the subsidiary legislation and consider the need to enhance the protection for retailers in the light of implementation of the new requirements.

3. In response to ALA's view, the Administration agreed to amend the notice in Schedule 3 by adding "(Cap. 362, sub. leg.)" after "Trade Descriptions (Marking) (Platinum) Order".

4. In response to ALA's view, the Administration agreed to change the word "carried" to "conducted" in the new section 3(1A) proposed to be added to the Order.

Members noted that the Subcommittee would report its deliberation to the House Committee at its meeting on 30 May 2008.
