**I. Meeting with the Administration**

[L.N. 124 of 2008, Legislative Council Brief, LC Paper Nos. LS86/07-08 and CB(2)2084/07-08(01)]

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. Members expressed concern about the application of the Building (Planning) (Amendment) Regulation 2008 (the Amendment Regulation) to buildings where only limited facilities could be provided for persons with a disability (PWDs) due to physical constraints. The Administration advised that there were special circumstances where proposals for building works were unable to meet the full requirements. Variation of the requirements would be considered by the Building Authority after taking into account the merits of individual cases. The Administration was requested to provide information on the mechanism and criteria for granting exemption for compliance with the obligatory design requirements stipulated in the Building (Planning) Regulations, together with the number of such applications and approved cases by types of buildings in the past few years.

3. Mr Tommy CHEUNG advised that the food business industry had expressed grave concern about the requirement for provision of ramps in food premises. Given that the installation of removable wheelchair spaces was allowed in cinemas, Mr CHEUNG considered that ramps should be provided in a specified percentage of dining area and that removable ramps might be used for changes in level of not more than 300 mm below or above the floor for the purpose of providing access to PWDs in food premises.

4. The Chairman requested members to provide the Subcommittee with the proposed amendments to the Amendment Regulation, if any, for consideration by the Subcommittee as early as practicable.

5. Members expressed dissatisfaction that the Administration had taken almost 10 years to review and revise the design requirements, and had introduced the Amendment Regulation into the Legislative Council as late as in May 2008. They also expressed dissatisfaction at the "bunching" of legislation at the end of the current term.

**II. Date of next meeting**

6. The Chairman reminded members that the next meeting would be held on 10 June 2008 at 8:30 am to meet with deputations and the Administration.
