**Court Waiting Times**

**Purpose**

The purpose of this paper is to update Members on the present position of waiting times at all levels of court.

**Court Waiting Times in 2007**

2. The Judiciary has been monitoring the waiting times at all levels of court, and deploying necessary resources to keep their waiting times within targets as far as practicable. The average waiting time for all levels of court in 2006 and 2007 are set out in the Annex.

3. Overall, the Judiciary has been able to keep the court waiting times within targets for 2007. There are a number of pressure areas and their waiting times have exceeded the targets. In this connection, the Judiciary has been taking necessary measures to improve the waiting times. Details are set out in the following paragraphs.

**Family Court**

4. Over the past few years, there has been a substantial increase in the caseload of the Family Court. The caseload was 18,544 in 2006 and 18,131 in 2007, which represented an increase of 9% and 7% over the caseload of 16,974 in 2005 respectively. The majority of cases are cases on the special procedure list of dissolution of marriage and financial applications. Despite the increase in caseload, their respective average waiting times were within targets in 2007. The waiting time for the defended list (one day hearing) of dissolution of marriage was 119 days in 2007 which exceeded the target of 110 days. Though the number of such cases was small, we have been taking actions to deal with the overall increased workload at the Family Court. Additional resources, in terms of

an additional District Judge for the Family Court, have been provided for in the 2008-09 Draft Estimates for this purpose.

### Lands Tribunal

5. Regarding the Lands Tribunal, the majority of cases are appeals, tenancy cases and building management cases. Their respective average waiting times were within targets in 2007. The waiting time for compensation cases was 141 days in 2007 which exceeded the target of 100 days. Though the number of the compensation cases was very small, we have been taking actions to address the overall workload at the Lands Tribunal. Additional temporary judicial resources, in terms of an additional Deputy District Judge, were deployed to the Tribunal in late 2007 to help to shorten the waiting time of compensation and other cases. Improvements have since been observed, with the average waiting time of the compensation cases reduced from 141 days in 2007 to 117 days for the period between September 2007 and February 2008. Resources are also made available in the 2008-09 Draft Estimates to enable the continual deployment of additional temporary judicial resources to improve the waiting times of compensation and other cases in the Lands Tribunal.

### Magistrates' Courts

6. In 2007, the caseload at the Magistrates' Courts reached a record of 314,214 in 2007, which represented an increase of 15,957 cases (5%) over the caseload of 298,257 in 2006. Due to the upsurge in caseload and the increasing complexity of some of the cases heard by the Magistrates Courts, the average waiting times for the Magistrates' Courts could not meet the targets in 2007.

7. We have put in place measures to improve the situation. Six newly recruited Special Magistrates took office in mid 2007 and additional temporary judicial resources, in terms of two additional Deputy Magistrates and two additional Deputy Special Magistrates, were also deployed between late 2007 and early 2008 to improve the situation. As a result, all the waiting times of the Magistrates' Courts have been reduced over the past six months. The waiting times for charge cases for the period between September 2007 and February 2008 are within targets, i.e. 40 days for defendants in custody and 58 days for defendants on bail, while the waiting time for summons is reduced from 95 days in 2007 to 74 days for the same period. The Judiciary

has included in the 2008-09 Draft Estimates financial provisions for the engagement and deployment of temporary judicial and support staff resources at the Magistrates' Courts with a view to improving the waiting times.

### **Looking Ahead**

8. We would continue to monitor the waiting times at all levels of court closely, deploy necessary resources and take necessary measures to keep them within targets as far as practicable.
