Legislative Council Panel on Home Affairs Progress Report on 2008 Olympic and Paralympic Equestrian Events

PURPOSE

This paper reports to Members on the progress in preparing for the 2008 Olympic and Paralympic Equestrian Events (the Equestrian Events) co-hosted by the Hong Kong Special Administration Region (HKSAR).

BACKGROUND

On 8 July 2005, the International Olympic Committee (IOC) accepted the proposal of the Beijing Organizing Committee for the Games of XXIX Olympiad (BOCOG) to relocate the Events to Hong On 20 July 2005 and 18 June 2007, we reported to Members of Panel on Home Affairs on the Government's proposed arrangements for co-hosting the Events in Hong Kong and the progress on preparation for the Equestrian Events (LC Paper No. CB(2)2347/04-05(03) and LC Paper No. CB(2)2041/06-07(01) are relevant). Besides, we updated Members of the Panel on Security and Panel on Home Affairs on the security arrangements for Equestrian (LC Paper No. the **Events** CB(2)2086/07-08(03) is relevant).

PROGRESS REPORT


3. BOCOG and the Government will, under the fundamental principle of "One Country, Two Systems", in accordance with the Olympic Rules and Regulations, organise the Equestrian Events within the legislative framework of the HKSAR; and bring into full play the strengths and initiative of various sectors of the Hong Kong community in order to facilitate the overall development of the Hong Kong economy, society and environment.

- 4. The Government has set up the Equestrian Committee (Hong Kong) of the Beijing Organizing Committee for the Games of the XXIX Olympiad (Equestrian Committee), which is responsible for making policy decisions and give directions for the organization and staging of the Equestrian Events in Hong Kong. Its executive arm the Equestrian Events (Hong Kong) of the XXIX Olympiad Company Limited (Equestrian Company) has also been established to handle the day-to-day organizational work of the Equestrian Events.
- 5. The Government will first give a progress update of the key government functions in preparation for the Equestrian Events to the Panel Members according to the attached presentation materials, including security, transport and traffic, medical services, quarantine, promotion of Olympism and community involvement, protection of the Olympic-related intellectual property rights and observatory services, etc. The Equestrian Company will then report the progress made in other functional areas for the organization of the Equestrian Events such as competition management, arrangements of competition and non-competition venues, accreditation, horse transportation, media services and volunteers.





Security

Duties of the Police:

- The security of HKSAR as a whole
- Commander of security of the Equestrian Events
- Guide and monitor the security measures of the Equestrian Company
- Ensure the smooth running of the Equestrian Events and provide a safe and secure environment for all participants



The Equestrian Company will be responsible for the security within competition venues under the monitoring of the Police

Scope:

Security

Security duties to be taken up the Equestrian Company:

- Co-ordinate security measures
- All non-major security measures (access control, crowd control, house rules, medication and doping control, etc.)
- Other security measures, e.g. provide assistance to the Police when necessary (security check of people and vehicles), security of transport, contingency exercises, etc.





Traffic and Transport Arrangement

- Work out transport and traffic arrangements for spectators, VIPs, athletes, media and officials
- Make necessary arrangement for road diversion and prohibited zone

Medical Services

- Provide medical services for the Olympic family, sponsors, media and spectators under the requirement of BOCOG
- Provide free medical services for authorised persons (athletes and the Olympic family) during the Equestrian Events in Hong Kong
- Provide free medical treatment for spectators at the venues
- Monitor food safety closely





Inspection and quarantine

Quarantine before leaving: 7 days
Quarantine after arrival: 10 days
(Permitted to engage in training
and competition)

Quality of health:

- common health certificates
- vaccination
- no signs of getting infectious diseases
- no infection of ectoparasites
- suitable for transportation
