#### **Background brief prepared by the Legislative Council Secretariat for the meeting on 14 December 2007**

#### **Implementation of a pilot scheme under the 2006 District Council Review**

##### **Purpose**

This paper provides background information on the 2006 District Council (DC) Review and gives an account of discussions of Members on the recommendations relating to the roles and functions of and support for DCs arising from the Review, including recent discussions held by the Panel on Home Affairs on the implementation of a pilot scheme under the 2006 DC Review for DC's to participate in the management of district facilities (as summarized in paragraphs 24-35).

##### **Background**

2. The 2006 DC Review was initiated in the 2004 Policy Address. In his 2004 Policy Address delivered on 7 January 2004, the then Chief Executive (CE) stated that the Government would review the functions and composition of DCs at a suitable time.

3. In his Policy Address delivered on 12 January 2005, the then CE said that -

"This year, we will review the functions and other aspects of District Councils and enhance our support for them. We will attach importance to how the 18 District Officers may better play their role. We will help them resolve community problems in a practical manner, referring them if necessary to higher levels for expeditious resolution. I have asked the Principal Officials to fully support the District Officers to enable them to function more effectively. We will deliver on the "people-based" service culture, pay constant attention to public aspirations and respond actively."

4. In January 2005, a working group was set up jointly by the Home Affairs Bureau (HAB) and the Constitutional Affairs Bureau (CAB) to make preparation for the review.

5. In his inaugural Policy Address delivered on 12 October 2005, CE stated that -

"The role of District Councils will be expanded. The Government will allow each District Council to assume responsibility for the management of some district facilities, such as libraries, community halls, leisure grounds, sports venues and swimming pools. The executive departments will follow the decisions of the District Council in managing such facilities, within the limits of their existing statutory powers and resources available. I have asked the working party under the Home Affairs Bureau and the Constitutional Affairs Bureau to work out an implementation plan for this proposal in the context of the on-going review of the functions and structure of the District Councils. The working party will seek the views of District Council members in making its recommendations. The formal public consultation on the review will commence in the first quarter of next year."

### **The 2006 DC Review**

6. According to the Administration, the following basic parameters have been adopted for the DC Review in 2006 -

- (a) the existing legal provisions relating to DCs, including Article 97 of the Basic Law (BL 97) which provides that DCs shall not be organs of political power, and section 61 of the District Councils Ordinance which sets out the functions of DCs (legal provisions relating to DCs are attached in **Appendix I**);
- (b) existing powers and responsibilities of the relevant statutory authorities responsible for the delivery of district services;
- (c) the need for a prudent and gradual approach to ensure no disruption to the delivery of public services at district level; and
- (d) the need for continued support to be provided by relevant Government departments in taking forward the DCs' advice or decisions in view of staffing implications.

7. On 27 April 2006, HAB and CAB jointly issued the Consultation Document entitled "Review on the Role, Functions and Composition of DCs" (the Consultation Document) which contained proposals on enhancing the role of DCs in the management of district facilities, strengthening communication with DCs and support for DC members as well as on the composition of DCs and other DC election-related matters.

8. On 28 September 2006, the Administration announced its plan for implementing recommendations arising from the DC Review, including a pilot scheme in four selected districts (i.e. Wan Chai, Wong Tai Sin, Sai Kung and Tuen Mun) for DCs to participate in the management of district facilities starting from 1 January 2007 (the Pilot Scheme). Details of the Pilot Scheme are set out in **Appendix II**.

### **Discussions held by the Panel on Constitutional Affairs and the Panel on Home Affairs on the 2006 DC Review and the Consultation Document**

#### Meetings held

9. Following the CE's Policy Address on 12 October 2005, the CA Panel held two meetings on 18 and 20 February 2006 to discuss the role, functions and composition of DCs. On 27 April 2006, the CA Panel received a briefing by the Secretary for Constitutional Affairs and the Secretary for Home Affairs (SHA) on the DC Review. The CA Panel further discussed the subject at its meeting on 15 May 2006. Members of the Panel on Home Affairs were invited to all these meetings to join the discussion.

10. The views and concerns expressed at the meetings of the CA Panel on the recommendations relating to the roles and functions of and support for DCs are summarised under the following topics -

- (a) role and functions of DCs (paragraphs 11 to 13);
- (b) enhancing work in districts (paragraphs 14 to 16);
- (c) funding provision for DCs (paragraphs 17 to 21); and
- (d) need for the Pilot Scheme (paragraphs 22 and 23).

#### Role and functions of DCs

11. Some members expressed dissatisfaction that the Administration had only proposed to entrust DCs with advisory and consultative functions in district affairs. They considered that, with the dissolution of the municipals councils, DCs could perform the duties of the former municipal councils as

described in BL 97, i.e. "District organizations which are not organs of political power may be established in the Hong Kong Special Administrative Region, to be consulted by the government of the Region on district administration and other affairs, or to be responsible for providing services in such fields as culture, recreation and environmental sanitation". These members suggested that the functions of DCs should be enhanced by involving DCs in the provision of district services and facilities, increasing funding provisions for DCs, improving the remuneration package of DC members, and providing an independent secretariat for DCs.

12. Hon CHAN Kam-lam, however, held the view that the devolution of power to DCs would have to comply with BL and should be progressive so as to avoid confusion.

13. The Administration explained that DCs would not play merely an advisory role because, apart from prioritizing works projects concerning their own districts, DCs would assume responsibility for the management of district facilities. Executive departments would consider DCs' views on the management and priorities in relation to the provision of district facilities, within the limits of the departments' statutory powers, resources available and prevailing Government policies. With the proposed setting up of a District Facilities Management Committee (DFMC) under each DC, DC members could be actively involved in the management of some district facilities, and steer and oversee the work concerned by way of consideration and endorsement of proposals on the operation and management of district facilities as well as proposals on activities to be organized therein. The Administration considered it undesirable to set up an independent secretariat for DCs, as the small staff establishment could not provide much opportunity for career advancement and staff morale might be affected.

#### Enhancing work in districts

14. Some members expressed concern over the delay in district work which might be caused by the creation of the proposed Steering Committee on District Administration (SCDA). They queried the demarcation of duties among District Officers (DOs), Heads of Departments (HoDs) and DC members, and the relationship between District Management Committees (DMCs) and SCDA.

15. The Administration explained that district matters in future would be dealt with at three levels -

- (a) DOs would continue to chair the respective DMCs which served as a forum for inter-departmental consultation on district matters and for co-ordinating the provision of services and facilities to ensure timely response to district needs;

- (b) SCDA, to be chaired by SHA or Permanent Secretary for Home Affairs (PSHA) and attended by the relevant HoDs, would resolve inter-departmental district management issues as well as formulate strategies and provide a steer to DOs and DMCs to enhance district work; and
- (c) SHA/PSHA would escalate important issues that could not be resolved by SCDA to the highest level, i.e. the Policy Committee co-chaired by the Chief Secretary for Administration and the Financial Secretary.

16. The Administration further explained that SCDA could look into cases where DCs/DFMCs were not satisfied with the relevant department's response concerning the management of district facilities. HoDs who had direct interface with the public would also be required to attend DC meetings once every two to three months, to listen to DC members' concerns about matters within their purview.

#### Funding provision for DCs

##### *Leisure and sports programmes and community involvement projects*

17. Some members expressed concern as to how the proposed annual provision of \$300 million for DC funds, to be earmarked for non-works items, such as leisure and sports programmes and community involvement projects, would be distributed among the 18 DCs.

18. The Administration explained that the allocation would be made on the basis of objective criteria, such as the population size, district size, number of facilities in a district, etc. Furthermore, a portion of the funds could be allocated to individual DCs for projects of a small scale, and the remaining portion be kept centrally in the Home Affairs Department (HAD) for projects of a larger scale, say, costing over \$5 million. Hon Daniel LAM held the view that the funding provision to each DC should be based on the size of the district and not on its population size.

##### *Minor works and facility improvement projects in districts*

19. Some members were of the view that DCs should be given the power to initiate and plan minor works projects. They queried whether the proposed annual provision of \$300 million for the dedicated capital works block vote would be adequate. These members also considered that the Administration should provide adequate technical and professional support for DCs to perform their enhanced role in managing district works projects.

20. The Administration explained that while the Legislative Council (LegCo) would continue to approve district-based works projects costing more than \$15

million, DCs in future could initiate and prioritise proposed works projects costing up to \$15 million, to be funded from a new dedicated capital works block vote. The new dedicated capital works block vote would replace three existing sources of funding for district minor works project, namely, the block vote on Minor Building Works and the Urban Minor Works Programme block vote under the Capital Works Reserve Fund, as well as DC funds for Minor Environmental Improvement projects.

21. The Administration considered that the proposed annual provision of \$300 million was adequate. Taking the year 2006-2007 as an example, 24 Minor Building Works projects costing about \$184 million were supported by DCs and endorsed by the Government as at May 2006. In addition, there were currently around 35 projects with a total cost of about \$13 million under the Urban Minor Works Programme being processed by HAD for implementation in 2006-2007. There were also around 175 projects with a total cost of about \$22 million under the Minor Environment Improvement Programme for implementation in 2006-2007. The Administration also undertook to strengthen the technical and professional support for the design, tender and supervision of the works projects initiated by DCs in future. It was proposed that DCs might opt for the established mechanism whereby the Architectural Services Department (Arch SD) would serve as the works agent for projects undertaken by the Leisure and Cultural Services Department, while works departments or contractors entrusted by HAD would implement the other minor works. DCs might also opt for direct engagement of contractors or consultants to carry out minor works projects in close collaboration with HAD and Arch SD.

#### Need for the Pilot Scheme

22. Dr Hon YEUNG Sum questioned the need to conduct the Pilot Scheme, given that no major changes were being made to the DC structure. The Administration explained that a major change in the culture of the Government was envisaged, i.e. the executive departments being required to follow the decisions of DC as far as possible. As the proposed arrangements would have considerable impact on departmental operations, it would be prudent to start on a pilot basis and allow the DOs concerned to assess the additional manpower requirement. To facilitate implementation of the Pilot Scheme, official guidelines on the use of DC funds and handling of works projects to be undertaken by DCs would be prepared.

23. In response to members' enquiries about the criteria for selection of districts for the Pilot Scheme, the Administration said that it intended to select districts with a good mix of facilities and characteristics. For example, it would select a district with old facilities versus a district with new facilities, a densely populated district versus a sparsely populated district, etc., to test the effect of the package of proposals.

## **Discussions held by the Panel on Home Affairs on the implementation of the Pilot Scheme**

### Meeting of the Panel on Home Affairs held on 10 November 2006

24. At its meeting held on 10 November 2006, the Panel on Home Affairs received a briefing by the Administration on the arrangements for implementing the recommendations of the 2006 DC Review, including the launching of the Pilot Scheme, a revised remuneration package for DC members and the creation of a dedicated capital works block vote for district minor works. While members in general were supportive of involving DCs in the management of district facilities, they raised various concerns relating to the implementation of the Pilot Scheme as summarised in paragraphs 26 to 35 below.

25. The proposed creation of a dedicated capital works block vote under the Capital Works Reserve Fund was endorsed by the Public Works Subcommittee on 19 December 2006 and approved by the Finance Committee on 12 January 2007.

### Provision of guidelines to pilot DCs

26. Some members suggested that the Administration should provide clear guidelines to assist the pilot DCs in discharging their enhanced role in the management of district facilities. The Administration responded that to ensure consistency and public accountability, relevant departments were in the course of preparing manuals and guidelines on district minor works projects and the use of DC Funds to facilitate DCs' involvement in the management of district facilities. Some members considered that, while standard procedures should be stringently applied to financial matters for DCs, there was no need to over-emphasise uniformity in the mode of management of district facilities in order to encourage DCs to come up with new ideas of improving the provision of district services.

### Financial and staff support to DCs

27. Regarding the proposal of creating a dedicated capital works block vote with an annual provision of \$300 million under the Capital Works Reserve Fund for DCs to initiate and implement district minor works projects within a cost ceiling of \$15 million each, some members suggested that, in order to better meet district needs, the annual provision for this block vote should be further increased and DCs should be given more flexibility to initiate or endorse a project.

28. The Administration explained that to utilize the proposed annual provision of \$300 million which was only the cash flow, there would be an

over-commitment facility of up to 200%, which meant that works contracts valued between \$500 and \$600 million could be awarded within a year.

29. Some members asked about the endorsement procedures for district minor works projects not exceeding \$15 million, and whether DCs would enjoy a high degree of autonomy in initiating such projects. The Administration explained that each DC would have full discretion in apportioning the funds allocated to it for carrying out projects, having regard to the needs of the district. DCs could also draw up their own list of proposed district minor works projects and provide it to the Administration for assessing cost implications. DCs could then examine the priority of the projects on the list, having regard to the estimated cost and their financial constraints. After the endorsement of a proposed project by a DC, the controlling officers concerned would be responsible for the delivery of works and signing the relevant contract on behalf of the DC concerned. The works would be undertaken by works departments or contractors entrusted by HAD.

30. Hon Albert HO expressed the view that there was no need for DCs to get involved in the day-to-day operation. After DCs had agreed on a set of pre-determined assessment criteria and principles, government officials should be responsible for performing the day-to-day management work of the district facilities in accordance with the criteria and principles that had been drawn up.

31. Hon Emily LAU considered that an independent secretariat should be provided for DCs to ensure that DCs enjoyed a degree of autonomy in performing their work. She also considered that an independent review should be conducted to study whether DC members' work should be recognized duly as a job with a view to attracting the young generation and able people to take part in the work of DCs.

32. The Administration explained that individual DCs were not corporate bodies and did not enjoy separate legal status under the law. Hence, DCs could not employ their own staff. The Administration, however, would increase the total provision for the DC Funds from \$170 million to \$300 million per year upon full implementation of the recommendations arising from the DC Review in all 18 DCs in the next DC term in order to strengthen support for DCs. DCs could then use the DC Funds to hire additional staff members to work independently to support their work.

#### Evaluation of the Pilot Scheme

33. Members noted that the evaluation team of the tertiary institution engaged to conduct an evaluation study on the implementation of the Pilot Scheme would work closely with the various stakeholders to track the progress of the Pilot Scheme, evaluate the effectiveness of the new mechanisms and identify room for improvement.

34. Hon James TIEN asked whether the Administration would need to further decide on the final mode of implementation for the management of district facilities on the basis of the experience gained from the Pilot Scheme as the pilot DCs might adopt different modes of implementation.

35. The Administration explained that the Pilot Scheme was needed to test out protocols and working relationship amongst the various stakeholders in order to pave the way for a smooth and effective roll-out to all the 18 districts from the next term DCs. There might be some fine-tuning of the proposed arrangements only, e.g., the level of resource requirements.

## Legal Provisions Relating to District Councils

### Basic Law

Chapter IV of the Basic Law sets out the political structure of the Hong Kong Special Administrative Region. Section 5 of that Chapter contains two Articles on district organisations. Article 97 of the Basic Law provides -

*"District organizations which are not organs of political power may be established in the Hong Kong Special Administrative Region, to be consulted by the government of the Region on district administration and other affairs, or to be responsible for providing services in such fields as culture, recreation and environmental sanitation."*

Article 98 provides -

*"The powers and functions of the district organizations and the method for their formation shall be prescribed by law."*

### District Councils Ordinance

2. The District Councils Ordinance (Cap. 547) (the Ordinance) provides for the number, composition and functions of DCs. Schedule 2 to the Ordinance specifies that there shall be 18 DCs. As regards the composition of DCs, section 9(1) of the Ordinance (Cap. 547) stipulates that a DC is to consist of -

- (a) elected members;
- (b) appointed members; and
- (c) ex-officio members, if it is a DC established for a District in which there is one or more Rural Committees, with the Chairman of each Rural Committee serving as ex-officio members of the DC while holding office as Chairman of Rural Committee.

3. The numbers of elected, appointed and ex-officio members on each DC are specified in Schedule 3 to the Ordinance.

4. According to section 61 of the Ordinance, the functions of a DC are -
- (a) to advise the Government -
    - (i) on matters affecting the well-being of the people in the District;
    - (ii) on the provision and use of public facilities and services within the District;
    - (iii) on the adequacy and priorities of Government programmes for the District; and
    - (iv) on the use of public funds allocated to the District for local public works and community activities;
  - (b) where funds are made available for the purpose, to undertake -
    - (i) environmental improvements within the District;
    - (ii) the promotion of recreational and cultural activities within the District; and
    - (iii) community activities within the District.

**A Pilot Scheme to involve District Councils in the Management of  
District Facilities to be implemented in  
Wan Chai, Wong Tai Sin, Tuen Mun and Sai Kung**

The pilot scheme will be implemented from 1 January 2007 and last till the suspension of DCs for the next round of DC election towards the end of 2007. The purpose of the pilots is to try out the various guidelines to facilitate DCs' involvement in the management of district facilities relating to capital works and programmes. Additional staffing and financial resources will be provided to pilot districts. The ultimate objective is to pave the way for a smooth roll-out to all the 18 Districts from the next term DCs commencing 1 January 2008.

*Financial Support to Pilot DCs*

- (a) To support the pilot DCs in the management of district facilities, an additional \$3 million will be added to the DC Funds provision for each of the pilot DCs for the organisation of community involvement programmes;
- (b) To enable pilot DCs to initiate and implement district minor works projects, a dedicated capital works block vote will be created under the Capital Works Reserve Fund in the 2007-08 financial year with an initial provision of \$20 million for that financial year for deployment by the pilot DCs. Given the lead time for project planning, it is envisaged that the provision with an over-commitment facility would provide sufficient room for the pilot districts to plan additional works;

*Manpower Support to Pilot DCs*

- (c) To support the pilot DCs in discharging their enhanced role in the management of district facilities, service the District Facilities Management Committee and handle the increased

provision of DC Funds, an additional Executive Officer II and Assistant Clerical Officer will be provided to each DC Secretariat of the pilot districts;

- (d) To support the pilot DCs in deploying the DC Funds in organising community involvement programmes, an additional Liaison Officer will be provided to each District Office of the pilot districts;
- (e) To support the pilot DCs in participating in the management of district facilities, an additional Senior Librarian and Leisure Services Manager will be provided to each of the pilot districts. These district-based librarians and leisure services managers will attend District Facilities Management Committee and/or other relevant DC meetings and work closely with the pilot DCs on proposals initiated and/or endorsed by them; and

#### *Evaluation*

- (f) A tertiary institution will be engaged as consultant to conduct an evaluation study on the implementation of the pilot scheme. The consultant will work closely with the pilot DCs to track the progress of the pilot scheme, evaluate the effectiveness of the new mechanisms and identify room for improvement.
