Legislative Council Panel on Security

Quality Migrant Admission Scheme

Purpose

This paper provides supplementary information on the implementation of the Quality Migrant Admission Scheme (QMAS).

Background

2. At the meeting of the Panel on 19 February 2008, we informed Members of a number of enhancements to the QMAS put in place following a review of the scheme completed in January 2008. The Panel requested for additional information on the implementation of the scheme, including the selection mechanism and criteria, as well as an analysis of the applications received.

Selection Mechanism and Criteria

3. Under the QMAS, applicants are required to fulfil a set of prerequisites¹ before they can be awarded points under one of the two points-based tests, namely the General Points Test (GPT) and the Achievement-based Points Test (APT). There are five point-scoring factors² under the GPT and one point-scoring factor³ under the APT. Applications which satisfy both the prerequisites and the passing mark under the GPT and applications under the APT will be short-listed for further comment by the Advisory Committee on Admission of Quality

¹ Prerequisites include age (18 or above), financial requirement (i.e. ability to support and accommodate themselves and their dependants, if any, without relying on public assistance), good character (i.e. absence of criminal or adverse immigration record), proficiency in Chinese or English, and good education background (normally a first degree)/good technical qualification/proven professional abilities/experience/achievements.

² For the GPT, the five point-scoring factors are age, academic/professional qualifications, work experience, language proficiency, and family background.

³ For the APT, points may be awarded if the applicant has received an award of exceptional achievement (e.g. Olympic medals, Nobel prize); or he/she can show that his/her work has been acknowledged by his/her peers or has contributed significantly to the development of his/her field (e.g. lifetime achievement award from industry).

Migrants and Professionals (Advisory Committee). The Advisory Committee comprises official and non-official members from different sectors of the community appointed by the Chief Executive. It meets on a regular basis to advise the Director of Immigration (D of Imm) on the selection of suitable applicants for allocation of available quota under the scheme.

4. The objective of the selection exercise is to distribute the quota to those quality migrants that Hong Kong needs. The Advisory Committee advises the D of Imm on how best to allocate the available quota, taking into consideration the socio-economic needs of Hong Kong, the background of the short-listed candidates, such as educational attainment, professional training/membership, work experience, international exposure, language skills, future plan in Hong Kong, as well as other relevant factors.

5. Each short-listed application is considered by the Advisory Committee on its individual merits, and the decision whether or not to approve an application rests with the D of Imm. In general, entry under the QMAS may be refused in the circumstances that the applicants who opt to be assessed under the APT cannot provide satisfactory proof of exceptional achievement or widely recognised achievement in their professions; and that the entry of applicants is not considered to be conducive to the short term and longer term needs of Hong Kong, despite having met the passing mark under the GPT. An unsuccessful applicant may, if he/she so wishes, submit a fresh application to the Immigration Department (ImmD).

Analysis of the Applications Received

6. From the launch of the QMAS on 28 June 2006 to 27 June 2008, ImmD received a total of 1 947 applications, of which 1 761 (90%) chose the GPT and 186 (10%) chose the APT. Among these applications, 1 128 applications were processed in the past seven selection exercises, of which 689 were short-listed for further comment by the Advisory Committee while 439 were withdrawn/failed to meet the prerequisites or the passing mark for further processing. The remaining 819 applications were under processing by ImmD.

7. As of 27 June 2008, 493 (72%) of the 689 short-listed applicants were allotted quota. Among the 493 successful applicants, 55 (11%) chose the APT and they are the cream of the crop from a wide array of

professions, such as world-renowned pianists, Olympic medallists, high achievers in broadcasting and entertainment industries, etc. Apart from these topnotch talent, 438 (89%) of the successful applicants chose the GPT, the majority of whom are professionals or executives at managerial level in different sectors. Examples include accountants and senior managers at financial institutions. More details on the profile of these applicants are set out at **Annex A**. At Members' request, a sample of the QMAS application form is enclosed at **Annex B**.

Conclusion

8. We will further update the Panel in 2009 on the implementation of QMAS, including a breakdown covering the periods before and after the enhancement of the scheme with effect from 15 January 2008, and related information gathered from the applicants.
