**1. Measures to assist the Tin Shui Wai community**

At the Panel meeting on 30 October 2007, members raised concern about the inadequate provision of welfare services and community facilities by the Government for high-risk families in Tin Shui Wai. The Administration was requested to provide a consolidated response to the areas of concern raised by members and deputations at the meeting, and revert to the Panel on the progress of enhancing the welfare services for high-risk families in Tin Shui Wai by late January/early February 2008.

**2. Child Development Fund**

The Government has earmarked \$300 million for the establishment of a Child Development Fund to encourage children from a disadvantaged background to plan for the future and cultivate positive attitudes with a view to reducing inter-generational poverty. The Administration is working on the proposal for a pilot scheme, which will be available by the end of 2007.

**3. Progress report on the implementation of Comprehensive Child Development Service**

At the meeting on 12 April 2007, the Administration was requested to expedite the plan to extend the pilot Comprehensive Child Development Service and report the implementation progress to the Panel.

**4. Social security assistance for needy elderly in Hong Kong**

Discussions were held at the Panel meeting on 13 June 2005. The Administration was requested to brief the Panel on its thinking on how better to provide retirement protection to the current and future generation of older persons.

The Administration has advised that the Government has launched a study on "Sustainability of the Three Pillars of Retirement Protection in Hong Kong", which is expected to be completed in 2007. The Government will consider the findings of the study in deciding the future course of action.

**5. Proposed establishment of the Family Council**

At the Panel meeting on 13 October 2006, the Panel was advised that the Administration would study the feasibility of setting up a Family Commission. At the Panel on Home Affairs meeting of 8 December 2006 when the proposal to discuss the establishment of a Commission on Children was raised, members agreed with the Administration's suggestion that the issue should be followed up by the Panel on Welfare Services in the context of the proposed establishment of a Family Commission. Members of the Panel on Home Affairs will be invited to the future meeting of the Panel if the issue is discussed.

1<sup>st</sup> quarter of 2008

The subject had originally been scheduled for discussion by the Panel at the meeting in April 2007. At the request of the Administration, discussion on the item would be deferred to a future meeting. The Administration has advised that a steering committee has been formed to take forward the initiative set out in the Policy Address 2006-2007 to study whether a Family Commission should be set up.

At the meeting on 15 October 2007, the Administration advised that a high-level Family Council would be set up before the end of 2007-2008. The Administration subsequently announced appointment of members to the Family Council on 3 December 2007.

**6. Report of the Subcommittee on Guardianship and Custody of the Law Reform Commission**

At the meeting held on 11 March 2002, members agreed that the Administration should brief the Panel on the above report when it became available.

2<sup>nd</sup> quarter of 2008

The Report on Custody and Access by the Subcommittee on Guardianship and Custody of the Law Reform Commission was released on 7 March 2005. The Administration is studying the recommendations carefully and will consider how to take forward the relevant recommendations together with the recommendations made in the other two earlier reports, namely, the Report on Guardianship of Children and Report on International Parental Child Abduction.

**7. Infirmiry care in non-hospital setting**

The Administration consulted the Panel in December 2004 on a proposal to launch a trial scheme to provide infirmiry care places for medically stable elders in a non-hospital setting. In the light of feedback from the Panel and the sector during the consultation process, the latest plan of the Administration is to upgrade some of the places in subvented residential care homes for the elderly to provide infirmiry care.

**8. Improving the homes of elderly people living in poor conditions**

The 2007-2008 Policy Address has earmarked an one-off funding of \$200 million to help improve the homes of elderly people living in poor conditions. The Administration is working out the implementation details.

**9. Licensing of residential care homes for people with disabilities**

The Administration proposes to report progress on the introduction of a licensing scheme for residential care homes for the disabled to regulate their service quality.

**19. Public dental care services for the needy**

At the meeting of the Subcommittee on Review of the Comprehensive Social Security Assistance Scheme on 2 April 2007, the provision of public dental care services for the needy, including CSSA recipients, was discussed.

As the subject of public dental care services for the needy was beyond its purview, the Subcommittee agreed that the matter should be referred to the Panel on Welfare Services and the Panel on Health Services for follow-up, and a joint meeting of the two Panels could be held as appropriate.

**20. Charitable fund-raising activities**

The existing framework for the monitoring of charitable fund-raising activities was discussed at the meeting on 11 June 2007. Members agreed to further discuss the matter in the 2007-2008 session, especially the monitoring of the use of income generated from public charitable fund-raising activities.

The Administration has advised that the subject matter involved various bureaux, namely the Home Affairs Bureau, the Financial Services and the Treasury Bureau and the Labour and Welfare Bureau. As the Law Reform Commission is now studying this subject, the Administration has suggested deferring Panel discussion to after the completion of the study.

**22. Support services for young drug abusers**

The subject was discussed by the Panel at the special meeting on 3 July 2007. Dr KWOK Ka-ki suggested that discussion on the subject should be followed up by the Panel at a future meeting. Members agreed that it would be for the Panel to decide the timing for following up the matter in the 2007-2008 session.

---

At the Panel meeting on 11 October 2007, Dr KWOK Ka-ki suggested that a joint meeting be held with the Panel on Security to further discuss the support services for young drug abusers, having regard that the Chief Executive announced in the Policy Address 2007-2008 the establishment of a high-level inter-departmental task force headed by the Secretary for Justice to combat juvenile drug abuse.

The Panel on Security discussed the problem of juvenile drug abuse at its special meeting on 30 October 2007 and has decided to hold a follow up discussion around Budget time. As the issue of drug abuses is under the policy purview of the Security Bureau, the Administration has suggested that the subject should be followed up by the Panel on Security.

**23. Establishing formal arrangements on adoption with the Mainland**

At the request of the Bills Committee on Adoption (Amendment) Bill 2003, the Administration undertook to study the need to establish formal arrangements on adoption with the Mainland and consult the relevant Panels in due course.

---

The Administration has raised this with the Ministry of Civil Affairs (MCA). The Central People's Government (CPG) has already put in place legislation and mechanism to handle adoption of Mainland children by Hong Kong people. As regards adoption of children in Hong Kong by Mainlanders, the CPG does not see an urgent need for it at the moment because there is little demand, according to the MCA. The CPG may consider adoption by close relatives on a case-by-case basis.

The Administration has advised that there are no specific issues to address. It will liaise with the CPG as and when necessary and revert to the Panel when there are developments.

**24. Incorporating the posts of programme assistant, youth ambassador, peer counsellor and other similar temporary frontline posts into the staff establishment of the subvented organisations providing welfare services**

The Panel was requested by Duty Roster Members to follow up the matter with the Administration. ---

The Administration's position on the issue had been sent to the Panel vide LC Paper No. CB(2)1022/04-05(01) on 8 March 2005 (Chinese version only).

In 2007-2008, SWD regularized 1 383 temporary posts under its schedule. Of the remaining 1 690 positions, 1 590 (i.e. 1 440 Youth Ambassadors and 150 Peer Counsellors) will not be extended. As regards the other 100 Community Work Organizer posts, 39 and 61 would be extended till the end of March and July 2008 respectively.

It was stated in the 2007-2008 Policy Address that the Administration will buttress the employment support for young people by providing 3 000 three-year employment opportunities for those aged between 15 and 29. The Panel on Manpower was briefed on this initiative at its meeting on 18 October 2007. The Administration has suggested to refer further discussion on the subject of temporary positions to the Panel on Manpower, if necessary.
