**I. Batterer Intervention Programme**

Discussion

3. Members urged the Administration not to stop short at conducting briefings or workshops for social workers and other practitioners to share the findings of the pilot project and the development of user manuals for the Hong Kong Family Welfare Society (HKFWS) and the Social Welfare Department (SWD) programmes respectively with a view to standardising the intervention and sharing the experience gained from the pilot project. Members were of the view that the Batterer Intervention Programme (BIP) should be made a standard provision of SWD, as the findings of the pilot project revealed that there was a general reduction

in the violent behaviour of the participants in both HKFWS and SWD programmes.

4. Assistant Director of Social Welfare (Family and Child Welfare) (ADSW(F&CW)) advised that providing group counselling service to batterers would become part of the standard service provision of the Family and Child Protective Services Units. As different types of batterers responded to the BIPs differently, SWD would conduct further study and analysis to develop suitable programmes that cater for different types of batterers.

5. Dr Fernando CHEUNG hoped that a platform to facilitate exchange of views between SWD and non-governmental organisations (NGOs) on the development of the BIPs could be put in place.

6. Members asked whether additional funding would be provided to SWD for implementing the anti-violence programme (AVP) following the commencement of the Domestic Violence (Amendment) Bill 2007 on 1 August 2008.

7. ADSW(F&CW) advised that about \$1 million had been allocated to SWD to run the AVP through NGOs, which was estimated to serve about 100 participants. Should the demand for the AVP be greater than expected, SWD would meet the demand through internal redeployment of resources in the first instance and seek new resources in due course.

## **II. Child fatality review mechanism**

Discussion

9. Members were of the view that the Review Panel of the Pilot Project for Child Fatality Review (RP) should report to the Family Council chaired by the Chief Secretary for Administration (CS), so as to ensure that the recommendations made by the RP would be followed up by relevant parties and organisations. Members also considered that the RP should have statutory backing so as to ensure the provision of complete and accurate information by organisations that had rendered services to the deceased child or his/her family and that the scope of work of the RP should be expanded in the long run to cover all domestic violence cases which had caused deaths or serious injuries.

10. Principal Assistant Secretary for Labour and Welfare (Welfare)2 (PAS/LW(Welfare)2) advised that similar to other non-statutory bodies set up by the Administration, the RP operated independently from the Government, albeit with secretariat support from SWD. There was no reason to doubt that the recommendations made by the RP would not be followed up by relevant parties and organisations where practicable, as the review findings and recommendations of the RP would be published in annual reports for public scrutiny. PAS/LW(Welfare)2 further advised that organisations that had rendered services to the deceased child and/or his/her family had thus far been very co-operative in providing information to the RP on a voluntary basis. There was no reason to doubt that these organisations would withhold information from the RP. Subject to the experience gained and outcome of the review of the child fatality review mechanism after the two-year pilot period, the Administration would not rule out the possibility of making it a statutory mechanism and to expand its scope of work in the long run to cover all domestic violence cases which have caused deaths or serious injuries.

11. Members shared the view that one way to encourage organisations that had rendered services to the deceased child or his/her family to provide all necessary information to the RP would be to provide them with legal protection against being sued by family of the deceased child.

12. Members noted that the scope of cases to be covered by the review mechanism was all cases involving children under the age of 18 who died of non-natural causes. Review of these cases would only be conducted upon completion of all criminal and judicial processes to avoid prejudicing such processes. Members considered such an arrangement undesirable, as the sooner the RP could conduct its review, the better it could identify gaps and deficiencies in the delivery of services prior to the child's death. Members considered that reviewing the child fatality cases when the criminal and judicial processes were still ongoing should not prejudice such legal proceedings, as meetings of the RP were closed-doors ones.

13. Members expressed concern that placing the RP under SWD might confine the selection of cases for review to those relating to the social welfare system. ADSW(F&CW) pointed out that the Secretariat of RP prepared the list of children who died of non-natural causes for general review by the RP based on the list of

cases obtained from the Coroner's Court.

14. Some members suggested that the RP should preferably be chaired by the Secretary for Justice (SJ) and that people from law enforcement agency and with legal background should also be appointed as RP members, as were practised in many overseas jurisdictions, having regard to the fact that investigation of the child's death was an important element of the review. PAS/LW(Welfare)2 advised that the review mechanism was not intended to identify causes leading to the child's death nor to attribute responsibility to individuals. Instead, the objectives of the review were to examine the practice and service issues pertaining to the child death cases; to identify feasible and practical improvements in these areas; to identify patterns and trends for formulation of prevention strategies; and to promote multi-disciplinary and inter-agency cooperation for prevention of child death. PAS/LW(Welfare)2 also pointed out that although the RP was formed under SWD, SWD had consulted stakeholders from various sectors, such as the Hospital Authority, the then Education and Manpower Bureau (now the Education Bureau) and NGOs, on the scheme details through meetings, briefings and consultation sessions before setting up the child fatality review mechanism. The Chairman pointed out that if SJ could lead the Task Force on Youth Drug Abuse, there was no reason why SJ could not lead the RP to prevent child death.

15. Dr Fernando CHEUNG shared the view that the best way to safeguard the rights and well-being of children was for the Government to set up a statutory Children's Commission, as had been done in many developed economies such as Australia. But as the Administration had previously advised that it had no plan to set up a Children's Commission, such task should be put under the purview of the Family Council.

16. Members agreed that the Subcommittee should hold another meeting to further discuss the child review fatality mechanism, and CS and SJ should be invited to come before the Subcommittee to discuss the proposals of making the Family Council overseeing the operation of the RP, including the implementation of RP's recommendations by parties concerned and having SJ chaired the RP, as well as the suggestion of allowing the RP to review a child death case before the completion of all criminal and judicial processes on the case.

17. There being no other business, the meeting ended at 1:50 pm.
