

**L.N. 91 of 2008****CLUBS (SAFETY OF PREMISES) (EXCLUSION) (AMENDMENT:  
CLUB-HOUSES IN GOVERNMENT PREMISES)  
ORDER 2008**

(Made by the Secretary for Home Affairs under section 3 of the Clubs  
(Safety of Premises) Ordinance (Cap. 376))

**1. Schedule amended**

The Schedule to the Clubs (Safety of Premises) (Exclusion) Order (Cap. 376 sub. leg. C) is amended, in item 5—

- (e) in paragraph (67), by repealing “Staff Mess Block, Chi Ma Wan Correctional Institution, Chi Ma Wan Road, Lantau Island, New Territories” and substituting “341 Chi Ma Wan Road, Lantau Island, New Territories”;
- (f) in paragraph (68), by repealing “Barrack B6, G/F, Chi Ma Wan Correctional Institution, Chi Ma Wan Road, Lantau Island, New Territories” and substituting “Block B6, 385 Chi Ma Wan Road, Lantau Island, New Territories”;
- (g) in paragraph (72), by repealing “Block B, G/F, 5 Butterfly Valley Road, Kowloon” and substituting “5 Butterfly Valley Road, Lai Chi Kok, Kowloon”;
- (h) by repealing paragraph (74);

- (i) in paragraph (77), by repealing “1/F, SMQ, Phoenix House, Lung Cheung Road, Tai Wo Ping, Kowloon” and substituting “Phoenix House, 3 Lung Yan Road, Tai Wo Ping, Kowloon”;

### **Explanatory Note**

The Schedule to the Clubs (Safety of Premises) (Exclusion) Order (Cap. 376 sub. leg. C) contains a list of club-houses situated in Government premises which are excluded from the application of the Clubs (Safety of Premises) Ordinance (Cap. 376). The purposes of this Order are to—

- (a) update the locations of 8 club-houses set out in the Schedule;
- (b) delete one club-house from the Schedule; and
- (c) add one club-house to the Schedule.
