

**L.N. 145 of 2008****DESIGNATION OF LIBRARIES ORDER 2008**

(Made by the Director of Leisure and Cultural Services under section 105K of the Public Health and Municipal Services Ordinance (Cap. 132))

**1. Commencement**

This Order shall come into operation on 12 July 2008.

**2. Cessation of designation as libraries**

The following cease to be designated as libraries—

- (a) Level 5 of the building known as Urban Council Aberdeen Complex, Aberdeen Main Road, Aberdeen, Hong Kong; and
- (b) the Arts Library at the Hong Kong Cultural Centre, 10 Salisbury Road, Kowloon.

**3. Designation of library**

The third floor of Aberdeen Municipal Services Building, 203 Aberdeen Main Road, Hong Kong is designated as a library.

**4. Schedule amended**

The Schedule to the Designation of Libraries Order (Cap. 132 sub. leg. O) is amended—

“48. The ground floor of Mui Wo Municipal Services Building, 9 Ngan Shek Street, Mui Wo, Lantau Island.”;
- (u) by repealing item 53 and substituting—  
“53. The first floor of Tsing Yi Municipal Services Building, 38 Tsing Luk Street, Tsing Yi.”;
- (v) by repealing item 59 and substituting—  
“59. The first floor of Lei Yue Mun Municipal Services Building, 6 Lei Yue Mun Path, Kwun Tong, Kowloon.”.

### Explanatory Note

This Order—

- (a) cancels the designation of Level 5 of the building known as Urban Council Aberdeen Complex, Aberdeen Main Road, Aberdeen, Hong Kong as a library and designates the third floor of Aberdeen Municipal Services Building, 203 Aberdeen Main Road, Hong Kong as a library;
