<u>Chicago, USA</u> Chicago Police Department 3510 South Michigan Avenue Chicago, IL 60653 U.S.A.	November 21, 2006	“Since an officer may not violate the law, any kind of sexual service, even if in an undercover operation, is prohibited by law and by extension, Department policy.”
<u>Montreal, Canada</u> Service de police de la Ville de Montréal 1441 Saint-Urbain St. Montréal (Québec) H2X 2M6 Canada	November 7, 2006	“At no time does the Service de police de la Ville de Montréal requires, allows, encourages or tolerates that his police officers “undercover agents” have sexual contacts of any nature while undercover operations take place ore repress prostitution. Moreover, no law or regulation allows that kind of behavior as it is unnecessary to achieve the determined goal.”
<u>Ottawa, Canada</u> Ottawa Police Service P.O. Box 9634 Station T Ottawa, Ontario K1G 6H5 Canada	November 10, 2006	“...investigative techniques used never involve the undercover officer compromising his position by accepting a sexual favour. This type of behavior would not be acceptable by this police service for both ethical and moral issues...”
<u>Dublin and Cork, Ireland</u> (An Garda Síochána) An Garda Síochána Garda Headquarters, Phoenix Park Dublin 8	November 17, 2006	“It is not necessary or appropriate that members of An Garda Síochána would receive some form of sexual service in order to secure evidence as part of their investigation into offenses.”

<u>Sydney, Australia</u> (New South Wales Police) New South Wales Police Headquarters Locked Bag 5102 Parramatta, NSW 2124 Australia	November 16, 2006	“...it would be inappropriate for NSW Police to provide information as to covert police practices; procedures; policies or ethical standards.”
<u>Victoria, Australia</u> Policy, Planning and Evaluation Unit Ethical Standards Department Victoria Police	2006	, the current policy is that Victoria Police employees are not permitted to undertake or receive any sexual services while working undercover. Current policy allows undercover officers to enter premises. (e.g a massage parlour that is suspected as acting as a brothel) and receive a massage, however any other of sexual services must be turned down and recorded. For the purpose of such massages, female officers are not to remove any underwear and male officers are only permitted to remove their shirts.
<u>Melbourne, Australia</u> (Victoria Police) Victoria Police Centre 637 Flinders Street Melbourne VIC 3005 Australia	October 24, 2006	“Victoria Police employees are not permitted to undertake or receive any sexual services while working undercover.”
