We refer to your letter 9th December 2004 on which instructions have been taken.

Whilst we know what were said in the correspondence, we have no knowledge at all of the contents of the other documents in the Government's possession. Some of those documents may contain inaccurate information which unfairly injures our client's goodwill. For example, the notes taken by the various departments of the Government may not sufficiently and precisely record the dialogue exchanged in the mediation. Accordingly, our client believes it is inappropriate to grant the consent as requested without having had an opportunity to peruse and consider the documents to be released to the Housing Panel.
