

2009 年第 66 號法律公告

《定額罰款(吸煙罪行)規例》

(由食物及衛生局局長根據《定額罰款(吸煙罪行)條例》
(2008 年第 26 號)第 16 條訂立)

1. 生效日期

本規例自食物及衛生局局長以憲報公告指定的日期起實施。

2. 本條例第 3 及 6 條所指的通知書

- (1) 本條例第 3(1) 條所指的通知書，須符合附表中表格 1 的格式。
- (2) 本條例第 6(2) 條所指的通知書，須符合附表中表格 2 的格式。
- (3) 採用附表中表格 2 的通知書，只在簽上或印有代表主管當局行事的公職人員的姓名的情況下，方屬有效。

3. 定額罰款的繳付

(1) 就採用附表中表格 1 或 2 的通知書而繳付的定額罰款，須按下述方法繳付——

- (a) 以郵遞方式寄往庫務署；
- (b) 在任何郵政局(流動郵政局除外)的櫃位繳付；
- (c) 透過銀行自動櫃員機繳付；
- (d) 用電話使用一般稱為“繳費靈”的服務繳付；
- (e) 透過互聯網繳付；或
- (f) 透過銀行提供的電話理財服務繳付。

(2) 如任何人意欲按照第 (1)(a) 或 (b) 款繳付定額罰款，該人須按照與該項繳付有關的通知書所列明的繳款指示，將該通知書連同所繳付的款項一併交付。

(3) 如按照本條繳付款項，所繳付的款項須為通知書所指明的定額罰款數額；如就多於一份通知書繳付款項，則所繳付的款項須為該等通知書所指明的定額罰款數額的總和。

(4) 按照第 (1) 款繳付的款項，除包含關於有關通知書所指明的事宜的數額或構成該等數額的一部分外，不得包含關於其他事宜的數額或構成關於其他事宜的數額的一部分。

(5) 定額罰款如非按照本規例繳付，該定額罰款視作仍未繳付，而庫務署署長可將如此繳付的數額退回給付款人。

If, having notified the Authority that you wish to dispute liability for the offence, you appear before a magistrate and offer no defence or a defence which is frivolous or vexatious, you are liable to, in addition to any other penalty and costs, an additional penalty equal to the amount of the Fixed Penalty if you are convicted of the offence.
4. Failure to pay or notify the Authority that you wish to dispute liability for the offence in accordance with this notice may result in an additional penalty being imposed.

- (b) 訂明《條例》所指的在追討定額罰款法律程序中提交的未繳定額罰款的證明書的格式；及
- (c) 指明繳付定額罰款的方式。
