ALA 2. The Bills Committee completed scrutiny of the Bill. The Chairman requested the Legal Service Division of the Secretariat to vet the finalized English version of the Administration's proposed Committee Stage amendments (CSAs) to ensure consistency of the Chinese and English versions of the proposed amendments. The Chairman added that subject to the CSAs being in order, the Bills Committee would submit a written report to the House Committee on 23 October 2009 supporting resumption of the Second Reading debate at the Council meeting on 11 November 2009. He also reminded the Administration that the deadline for giving notice of CSAs would be 2 November 2009.
