# Applications for late membership

2. <u>The Bills Committee</u> accepted the applications for late membership from Dr Joseph LEE and Mr Alan LEONG.

# Meeting with deputations

3. <u>The deputations</u> expressed diverse views on the Bill which sought to increase the duty rates on tobacco. In general, <u>deputations from the medical</u>, <u>community service and catering sectors</u> supported the duty increase, quoting relevant local and overseas studies and statistics to prove the effectiveness of duty increase to discourage smoking, especially among young people and low-income people. They urged the Administration to allocate more resources to step up tobacco control, public education, enforcement against illicit cigarette activities, and smoking cessation services.

4. <u>Representatives from the tobacco industry and newspaper stallholders</u>, however, opposed the duty increase on grounds that it would only lead to increase in illicit cigarette activities and hence loss in Government revenue but not reduction in tobacco consumption. Low-income people who resorted to smoking illicit cigarettes might even be exposed to greater health hazards posed by counterfeit cigarettes. They preferred a phased approach in increasing tobacco duty coupled with greater education and enforcement efforts. Newspaper stallholders further expressed concern about the impact of the duty increase on their income, and called on the Administration to devise measures to help them make up for their loss.

# Meeting with the Administration

5. <u>The Administration</u> emphasized that the duty increase was introduced to help strengthen tobacco control efforts to discourage smoking and protect public health because duty and hence price increase could reduce demand. <u>The Administration</u> highlighted the immediate increase in enrollees to smoking

cessation classes after the duty increase, and stressed the need for a multi-pronged approach, including education, publicity, legislation, plus tobacco duty increase, to reduce smoking. Enforcement actions against different aspects of illicit cigarette activities, in particular import and retailing, as well as efforts on intelligence collection had been enhanced with encouraging results. The Administration was discussing options to increase business opportunities of newspaper stallholders.

6. <u>Mr WONG Yuk-man</u> stated that overseas experience had shown that tobacco duty increase could not discourage smoking. It was therefore not preferred because it would adversely affect the public's freedom of choice and the income of newspaper stallholders, and would lead to increase in illicit cigarette activities, which had become more rampant and difficult to detect and combat. <u>Mr WONG</u> further opined that it was unfair to increase the rates of duty on tobacco products on the one hand and reduce the rates of duty on alcoholic beverages on the other. He considered it necessary to establish a designated fund for smoking cessation services with the revenues from tobacco duty, and requested the Administration to provide the following information within one year following the enactment of the Bill to the relevant Panels for follow-up discussion -

(a) A progress report on the effectiveness of the Administrations' efforts in combating illicit cigarette activities;

- (b) Sale figures of duty-free cigarettes and the duty potential of the duty-free cigarettes sold;
- (c) Statistical figures on changes in the number of smokers in Hong Kong; and
- (d) Measures taken to increase the business opportunities of newspaper hawkers in order to address their concern on the impact brought about by the increase in cigarette duty on their livelihood.

7. <u>Mr Vincent FANG</u> shared some of Mr WONG Yuk-man's views above, and further highlighted the health hazards of counterfeit cigarettes. Though in support of the tobacco duty increase, <u>Dr Joseph LEE</u> and <u>Miss</u> <u>Tanya CHAN</u> shared Mr WONG 's concern about its impact on the income of newspaper stallholders, and were keen to ensure that effective mitigation measures would be worked out early. In this regard, <u>the Coalition of Hong</u> <u>Kong Newspaper and Magazine Merchants</u> pointed out that considering the environmental hygiene factor, relaxation of the licence restriction on advertising might be the most feasible measure and if implemented, the trade had already agreed to share the advertising income so derived among trade members in recognition that the income would vary with the locations of stalls.

Admin 8. <u>The Administration</u> agreed to provide a written response on the timeframe for working out measures to mitigate newspaper stallholders' income loss.

9. <u>The Bills Committee</u> examined the Bill clause by clause.
