Action

I. Confirmation of minutes

[LC Paper Nos. CB(2)934/08-09 and CB(2)951/08-09]

The minutes of the meetings held on 5 February 2009 and 17 February 2009 were confirmed.

II. Meeting with the Administration

[LC Paper Nos. CB(2))953/08-09(01)&(02), CB(3)85/08-09, CB(2)297/08-09(02) and CB(2)723/08-09(01)]

- 2. <u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).
- 3. <u>The Administration</u> briefed members on its response to issues raised at the meeting on 17 February 2009 [LC Paper No. CB(2)953/08-09(01)].

Effective date of section 78B order published by Gazette

4. To address the concern that persons subject to the section 78B order might unknowingly contravene the order if the start of the required prohibition action specified in the order fell on the same day on which the order was published in the Gazette, the Administration proposed to stipulate that the

section 78B order would take effect at a specified time, say 12 noon, on the day on which it was published in the Gazette. As Gazette would normally be published in the morning, specifying 12 noon as the effective time of the section 78B order would solve the problem in most circumstances. Another option would be to keep section 78C(6) as proposed under the Bill. The Administration would work with the Government Printer to publish the Gazette by uploading it onto the Government's website of Gazette notice at the earliest possible time.

- 5. Ms Audrey EU said that the modified option to specify the effective time of the section 78B order published by Gazette still could not address the problem that persons subject to the order might unknowingly contravene the order, as the Gazette could be published in the evening of the day. Ms EU proposed that the effective time of the section 78B order published by Gazette be determined by the Director of Food and Environmental Hygiene (DFEH) on a case by case basis.
- 6. <u>The Administration</u> responded that to do so would render the making of the section 78B order published by Gazette less certain to the trade, as the effective time would be determined by DFEH and not fixed. Nevertheless, the Administration was willing to consider Ms EU's suggestion if this was supported by the Bills Committee.
- 7. <u>Dr LEUNG Ka-lau</u> said that one way to allay members' concern about the effective time of the section 78B order published by Gazette was to stipulate in the Public Health and Municipal Services Ordinance (Cap.132) that persons subject to the order might use the grounds that they could not reasonably know the publication of the order in the Gazette as a defence for failing to carry out the act(s) specified in the order at the start time of the order. Mr Alan LEONG expressed similar views.
- 8. Mr Vincent FANG requested the Administration to stipulate in Cap. 132 that the start time of the actions required to be done in a section 78B order must be later than the effective time of the order, say, six hours, in order to allow sufficient time for persons bound by the order to comply with the order. Mr WONG Ting-kwong expressed similar views.
- 9. The Administration responded that although the effective time of the section 78B order published by Gazette could be the same as the start time of the order, public announcements through the media and electronics means would be made to notify the public and the trade of the order before it was formally published in the Gazette. The Administration further said that DFEH would exercise discretion in enforcing the compliance of the section 78B order,

if circumstances so justified, as had been done in the enforcement of other orders made under Cap. 132.

10. In closing, the Chairman requested the Administration to respond in writing to the suggestion made by Ms Audrey EU in paragraph 5 above, and other views expressed by members before the next meeting.

The Administration considered Mr Tommy CHEUNG's suggestion not preferable. There was already a time lag between preparation of the Gazette and actual publication during which the Government would publicise widely the food incidents and the section 78B order to the public through various means.
