Four Members asked supplementary questions and the Secretary for Financial Services and the Treasury replied.

Hon CHAN Kam-lam declared his interest that he held a very small amount of the shares of the PCCW Limited. He then asked his supplementary question.

While Hon CHAN Kam-lam was speaking, Hon James TO rose and declared his interest that he was also a shareholder of the PCCW Limited. Hon CHAN Kam-lam continued to speak.

The Secretary for Financial Services and the Treasury replied.

Two other Members asked supplementary questions and the Secretary for Financial Services and the Treasury replied.

3. Hon WONG Ting-kwong asked Question 3.

The Secretary for Commerce and Economic Development replied.

Eight Members asked supplementary questions and the Secretary for Commerce and Economic Development replied.

4. Hon WONG Kwok-hing asked Question 4.

The Secretary for Transport and Housing replied.

Seven Members asked supplementary questions and the Secretary for Transport and Housing replied.

5. Hon LEE Wing-tat asked Question 5.

While Hon LEE Wing-tat was asking his question, a member of the public in the Public Gallery spoke loudly. The President asked that person to keep quiet. Hon LEE Wing-tat continued to ask his question.

The Secretary for Security replied.

Nine Members asked supplementary questions and the Secretary for Security replied.

Hon Frederick FUNG declared that he was one of the victims in respect of the matter raised in this question. He then asked a supplementary question. The Secretary for Security replied.

Another Member asked a supplementary question and the Secretary for Security replied.

Written replies to Questions 6 to 19 were tabled for Members' information.

## **Bills**

### First Reading

Disciplined Services Legislation (Miscellaneous Amendments) Bill 2009

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

### Second Reading

Disciplined Services Legislation (Miscellaneous Amendments) Bill 2009

The Secretary for the Civil Service moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

## **Members' Motions**

### Measures for combating drink driving

Hon LEE Wing-tat moved the following motion and spoke on the motion:

That, as several serious traffic accidents caused by drink driving have occurred recently, which resulted in a large number of casualties, reflecting that the awareness of the danger of drink driving among motorists is still weak, this Council urges the Government to:

- (a) review the penalties for the drink driving offence by increasing the disqualification period to a minimum of 12 months or above upon first conviction of this offence as well as raising the maximum imprisonment term and fine for such an offence;
- (b) consider further tightening the legal limit of blood alcohol concentration;

- (c) lodge appeals to the Court by the Department of Justice against drink driving cases with relatively lenient sentences so as to allow the Judiciary to formulate more stringent sentencing criteria;
- (d) consider raising the maximum imprisonment term for dangerous driving causing death to the same level as that for manslaughter; and
- (e) enhance public education and publicity to enable motorists to understand the perils of drink driving,

so as to safeguard public safety.

Question on Hon LEE Wing-tat's motion proposed.

The President stated that Hon CHEUNG Hok-ming and Hon LEUNG Kwok-hung would move amendments to the motion. Also, Hon Miriam LAU would move an amendment to Hon CHEUNG Hok-ming's amendment. In accordance with the Rules of Procedure, the motion and the amendments would be debated together in a joint debate.

Hon CHEUNG Hok-ming, Hon LEUNG Kwok-hung and Hon Miriam LAU, who would move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Transport and Housing spoke on the motion and the amendments.

Hon CHAN Kin-por spoke on the motion and the amendments.

While Hon CHAN Kin-por was speaking, the President left the chair at 2:16 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Thirteen Members and Hon CHIM Pui-chung spoke on the motion and the amendments.

While Hon CHIM Pui-chung was speaking, Dr Hon Margaret NG sought elucidation of a point raised by Hon CHIM Pui-chung in his speech. Hon CHIM Pui-chung elucidated. Dr Hon Margaret NG then rose to seek further elucidation. Hon CHIM Pui-chung did not give way and continued to speak.

Two other Members spoke on the motion and the amendments.

Hon LEE Wing-tat spoke on the amendments.

At 3:59 pm, while Hon LEE Wing-tat was speaking, the President resumed the chair.

The Secretary for Transport and Housing spoke again.

Hon CHEUNG Hok-ming moved the following amendment to Hon LEE Wing-tat's motion:

To delete "as" after "That," and substitute with "according to government information, the number of prosecutions against drink driving has been on the rise in recent years; furthermore,"; to delete "review the penalties for the drink driving offence by" after "(a)" and substitute with "allocate more resources for conducting random breath tests, and set up permanent breath test checkpoints at cross-boundary control points and the roads nearby, as well as major bar areas and restaurants, etc; (b) expeditiously conduct a comprehensive review on the effectiveness of the newly implemented Road Traffic Legislation (Amendment) Ordinance 2008, including"; to delete "to a minimum of 12 months or above" after "disqualification period"; to add "where necessary" after "such an offence"; to delete the original "(b)" and substitute with "(c)"; to add ", and formulate a set of penalties whereby the greater the extent the alcohol limit is exceeded, the heavier the punishment" after "blood alcohol concentration"; to delete the original "(c)" and substitute with "(d)"; to add "reviews or" after "lodge"; to add "and guidelines" after "sentencing criteria"; to delete the original "(d)" and substitute with "(e)"; to delete the original "(e)" and substitute with "(f)"; and to add ", and require that cautionary words such as 'don't drink and drive' must be printed on the packages of alcoholic beverages" after "public education and publicity".

Question on Hon CHEUNG Hok-ming's amendment to Hon LEE Wing-tat's motion proposed.

Hon Miriam LAU moved the following amendment to Hon CHEUNG Hok-ming's amendment:

To add "various major speeding blackspots across the territory," after "the roads nearby"; and to add "studying the introduction of a new provision on 'dangerous driving causing grievous bodily harm' in the Ordinance and introducing dangerous driving after drinking as a factor of consideration for meting out heavier penalties, as well as" after "including".

Question on Hon Miriam LAU's amendment to Hon CHEUNG Hok-ming's amendment proposed and put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, 19 were in favour of the amendment and two abstained; while among the Members returned by geographical constituencies through direct elections, 28 were present, 18 were in favour of the amendment and nine abstained. (Voting record in Appendix I.) Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on “Measures for combating drink driving” or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Question on Hon CHEUNG Hok-ming’s amendment, as amended by Hon Miriam LAU, to Hon LEE Wing-tat’s motion put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, 19 were in favour of the amendment and two against it; while among the Members returned by geographical constituencies through direct elections, 28 were present, 17 were in favour of the amendment and 10 against it. (Voting record in Appendix II.) Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

Hon LEUNG Kwok-hung moved the following further amendment to Hon LEE Wing-tat’s motion as amended by Hon CHEUNG Hok-ming and Hon Miriam LAU:

To add “; this Council also urges the Government to set up medical facilities for treating alcoholics and community counselling centres for such people to receive appropriate treatment and counselling, so as to enable them to understand the perils of drink driving, thereby reducing the occurrence of drink driving accidents” immediately before the full stop.

Question on Hon LEUNG Kwok-hung’s amendment to Hon LEE Wing-tat’s motion as amended by Hon CHEUNG Hok-ming and Hon Miriam LAU proposed, put and agreed to.

Hon LEE Wing-tat replied.

Question on Hon LEE Wing-tat’s motion as amended by Hon CHEUNG Hok-ming, Hon Miriam LAU and Hon LEUNG Kwok-hung put and agreed to.

Helping young people cope with the financial tsunami

Hon Tanya CHAN moved the following motion and spoke on the motion:

That, being struck by the financial tsunami, Hong Kong's economy will most probably slacken off substantially and young people will definitely face pressure from various fronts, including the financial burden arising from repaying student loans and the employment difficulties caused by reduction in jobs etc; this Council urges the Government to show concern for the needs of young people amid economic adversities and offer suitable support to help them alleviate their pressure, develop their career and contribute to the society, with specific measures which include:

- (a) removing the existing 1.5% risk rate for the "Non-means Tested Loan Scheme" and making changes to the effect that the interest will be calculated after a student has completed the relevant programme;
- (b) suspending the collection of repayments from all borrowers of student loan schemes for one year and waiving the interests on all loans for that year;
- (c) providing young people with more employment counselling and support, especially by increasing the resources allocated to the environmental protection and creative industries, with a view to helping them find suitable jobs;
- (d) creating temporary jobs and placements which are suitable for young people, including those in the fields of environmental conservation, survey studies, community relations, publicity and promotion etc, to give them opportunities to accumulate working experience;
- (e) exploring various forms of support, including appropriate training, counselling services, subsidies or loan arrangements, for young people who aspire to start a business or become self-employed; and
- (f) expeditiously implementing the recommendations of the Task Force on Economic Challenges which target at young people's needs and putting forward specific work plans as well as announcing the details.

Question on Hon Tanya CHAN's motion proposed.

The President stated that five Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the five amendments would be debated together in a joint debate.

Hon Starry LEE, who intended to move an amendment to the motion, spoke on the motion and the amendments.

Hon Andrew LEUNG, who intended to move an amendment to the motion, declared that he was the Chairman of the Vocational Training Council. He then spoke on the motion and the amendments.

Hon WONG Sing-chi, Hon WONG Kwok-hing and Hon LEE Cheuk-yan, who intended to move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Labour and Welfare spoke on the motion and the amendments.

Eleven Members and Hon Paul CHAN spoke on the motion and the amendments.

With the President's permission, Hon Cyd HO rose to correct a figure mentioned earlier in her speech and also explained a point raised in her speech.

Four other Members spoke on the motion and the amendments.

Hon Tanya CHAN spoke on the amendments.

The Secretary for Labour and Welfare spoke again.

Hon Starry LEE moved the following amendment to Hon Tanya CHAN's motion:

To delete "being" after "That," and substitute with "as the global economy slows down, and Hong Kong is"; to delete "Hong Kong's economy will most probably slacken off substantially and" after "financial tsunami,"; to delete "removing" after "(a)" and substitute with "standardizing"; to delete "1.5% risk rate" after "the existing" and substitute with "interest rate"; to delete "and" after " 'Non-means Tested Loan Scheme' " and substitute with "at a flat rate of 2.5%,"; to add "and secured employment, as well as changing the means-tested loans to interest-free loans" after "programme"; and to add ", introducing an attachment allowance scheme for tertiary graduates whereby the Government will offer allowances to Hong Kong and Mainland enterprises which provide attachment places with a view to helping fresh graduates tackle employment difficulties," after "young people's needs".

Question on Hon Starry LEE's amendment to Hon Tanya CHAN's motion proposed, put and agreed to.

The President stated that Hon Andrew LEUNG had indicated that he would withdraw his amendment to Hon Tanya CHAN's motion if Hon Starry LEE's amendment was passed. Hon Andrew LEUNG had therefore withdrawn his amendment.

As Hon Starry LEE's amendment had been passed, the President granted leave for Hon WONG Sing-chi to revise the terms of his amendment.

Hon WONG Sing-chi moved the following further amendment to Hon Tanya CHAN's motion as amended by Hon Starry LEE, and explained the revised terms of his amendment to the Council:

To add “; (g) reviewing various financial assistance schemes for post-secondary students, relaxing the eligibility criteria, and raising the amount of grants and loans, so as to alleviate the financial burden on tertiary students; and (h) considering giving tertiary graduates more flexibility in repayment, including repaying a smaller amount during the first three years after graduation” immediately before the full stop.

Question on Hon WONG Sing-chi's amendment to Hon Tanya CHAN's motion as amended by Hon Starry LEE proposed, put and agreed to.

As Hon Starry LEE's and Hon WONG Sing-chi's amendments had been passed, the President granted leave for Hon WONG Kwok-hing to revise the terms of his amendment.

Hon WONG Kwok-hing moved the following further amendment to Hon Tanya CHAN's motion as amended by Hon Starry LEE and Hon WONG Sing-chi:

To add “; (i) raising the subsidy amount of the Continuing Education Fund to \$30,000 to alleviate the financial pressure from further studies on young people and, at the same time, widening the coverage of subsidy and stepping up monitoring of course operations; and (j) increasing the subsidized places for diploma, higher diploma, bachelor degree and master degree programmes, etc of various institutions, so that more young people are able to have the opportunity to receive tertiary education, thereby enhancing their competitiveness” immediately before the full stop.

Question on Hon WONG Kwok-hing's amendment to Hon Tanya CHAN's motion as amended by Hon Starry LEE and Hon WONG Sing-chi proposed and put.

Hon WONG Sing-chi claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 10 were present, four were in favour of the amendment, two against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, eight were in favour of the amendment and 12 against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

As Hon Starry LEE's and Hon WONG Sing-chi's amendments had been passed, the President granted leave for Hon LEE Cheuk-yan to revise the terms of his amendment.

Hon LEE Cheuk-yan moved the following further amendment to Hon Tanya CHAN's motion as amended by Hon Starry LEE and Hon WONG Sing-chi, and explained the revised terms of his amendment to the Council:

To add “; and (i) establishing a training contract system to enable young school leavers to have training opportunities and working experience” immediately before the full stop.

Question on Hon LEE Cheuk-yan's amendment to Hon Tanya CHAN's motion as amended by Hon Starry LEE and Hon WONG Sing-chi proposed, put and agreed to.

Hon Tanya CHAN replied.

Question on Hon Tanya CHAN's motion as amended by Hon Starry LEE, Hon WONG Sing-chi and Hon LEE Cheuk-yan put.

Hon Tanya CHAN claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 10 were present and 10 were in favour of the motion as amended; while among the Members returned by geographical constituencies through direct elections, 22 were present, 20 were in favour of the motion as amended and one against it. (Voting record in Appendix IV.) Since the question was agreed by a majority of each of the two groups of Members present, he declared that the motion as amended was passed.

### **Next meeting**

The President declared that the next meeting of the Council would be held on 25 February 2009 at 11:00 am.

The Council was adjourned at 8:07 pm.
