The Secretary for Commerce and Economic Development replied.

Seven Members asked supplementary questions and the Secretary for Home Affairs replied.

3. Hon Cyd HO asked Question 3.

The Secretary for Security replied.

Hon Cyd HO asked a supplementary question. While the Secretary for Security was replying to the supplementary question, Hon LEUNG Kwok-hung interrupted to seek elucidation of the content of the article which the Secretary had quoted in his reply.

The Secretary for Security did not accede to Hon LEUNG Kwok-hung's request and continued to reply.

Hon LEUNG Kwok-hung rose and repeatedly asked the Secretary for Security to elucidate. He then sat down after the President had ordered him to do.

Hon LEE Wing-tat interrupted to seek elucidation of why the Secretary had chosen to quote the article concerned in his reply to Hon Cyd HO's supplementary question.

The President said that question time was not for debate. Members might not be satisfied with the reply given by the Secretary for Security, and according to the Rules of Procedure, Members might seek elucidation of matters raised in the Secretary's speech. However, it was up to the Secretary to decide whether or not to elucidate. The President then pointed out to the Secretary that it was not appropriate to quote extensively from articles which had been published. He should simply draw Members' attention to the relevant article, and Members could read it themselves.

Hon Cyd HO then asked a follow-up question. The President pointed out that the Secretary for Security had already answered the question.

Hon James TO sought elucidation of the article quoted by the Secretary for Security.

The Secretary for Security elucidated.

Hon Ronny TONG raised a point of order on why the Secretary for Security was allowed to make comments in replying Members' questions.

The President said that if the Secretary considered that quoting the relevant article would help his reply to the question asked by Hon Cyd HO, he should be allowed to do so.

Five other Members asked supplementary questions and the Secretary for Security replied.

4. Hon TAM Yiu-chung asked Question 4.

The Secretary for Food and Health replied.

Four Members asked supplementary questions and the Secretary for Food and Health replied.

5. Hon KAM Nai-wai asked Question 5.

The Secretary for Constitutional and Mainland Affairs replied.

The Bills were read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Legal Practitioners (Amendment) Bill 2009

The Secretary for Justice moved the Second Reading and spoke on the Bill.

While the Secretary for Justice was speaking, the President left the chair at 2:00 pm temporarily and the President's Deputy, Hon Fred LI, took the chair.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Immigration (Amendment) Bill 2009

The Secretary for Security moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Inland Revenue (Amendment) (No. 2) Bill 2009

The Secretary for Financial Services and the Treasury moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Bunker Oil Pollution (Liability and Compensation) Bill

The Secretary for Transport and Housing moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Voting by Imprisoned Persons Bill

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 6 May 2009 resumed.

Hon IP Kwok-him, Chairman of the Bills Committee on Voting by Imprisoned Persons Bill, addressed the Council on the Committee's Report. After the address, he spoke on the Bill in his personal capacity as a Member.

Three Members and Dr Hon PAN Pey-chyou spoke on the Bill.

At 2:58 pm, while Dr Hon PAN Pey-chyou was speaking, the President resumed the chair.

Four other Members and Hon WONG Yuk-man spoke on the Bill.

While Hon WONG Yuk-man was speaking, some people in the Public Gallery clapped their hands. The President asked them to keep quiet.

One more Member spoke on the Bill.

With the President's permission, Hon LEUNG Kwok-hung explained a point which he had raised earlier in his speech.

The Secretary for Constitutional and Mainland Affairs replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Voting by Imprisoned Persons Bill.

Question that clauses 1 to 4 and 6 to 10 stand part of the Bill proposed, put and agreed to.

Question that the heading of Part 1 stand part of the Bill proposed.

The Secretary for Constitutional and Mainland Affairs moved an amendment to the heading of Part 1 and spoke on the amendment.

Question on the amendment put and agreed to.

Question that the heading of Part 1 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 5 stand part of the Bill proposed.

Dr Hon Margaret NG moved an amendment to clause 5 and spoke on the amendment.

A Member spoke on the clause and amendment.

The Secretary for Constitutional and Mainland Affairs spoke on the clause and amendment.

Dr Hon Margaret NG spoke again.

Question on the amendment put.

Hon IP Kwok-him claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, five were in favour of the amendment, 15 against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 15 were in favour of the amendment and 10 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that clause 5 stand part of the Bill put and agreed to.

New clause 1A read the first time.

The Secretary for Constitutional and Mainland Affairs moved the Second Reading of new clause 1A and spoke on the new clause.

Question on the Second Reading of new clause 1A proposed, put and agreed to.

New clause 1A read the second time.

The Secretary for Constitutional and Mainland Affairs moved the addition of new clause 1A to the Bill.

Question on the addition proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Constitutional and Mainland Affairs reported that

the Voting by Imprisoned Persons Bill

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Inland Revenue (Amendment) Bill 2009

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 13 May 2009 resumed.

A Member spoke on the Bill.

The Secretary for Financial Services and the Treasury replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Inland Revenue (Amendment) Bill 2009.

Question that clauses 1 and 2 stand part of the Bill proposed, put and agreed to.

Question that clause 3 stand part of the Bill proposed.

The Secretary for Financial Services and the Treasury moved amendments to clause 3 and spoke on the amendments.

Five Members spoke on the clause and amendments.

Three Members who had spoken spoke again.

The Secretary for Financial Services and the Treasury spoke again.

Question on the amendments put.

Hon Albert CHAN claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that 45 Members were present, 41 were in favour of the amendments and three against them. (Voting record in Appendix II.) Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that clause 3 as amended stand part of the Bill proposed, put and agreed to.

Question that the long title stand part of the Bill proposed.

The Secretary for Financial Services and the Treasury moved an amendment to the long title and spoke on the amendment.

Question on the amendment put and agreed to.

The Council then resumed.

Third Reading

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question that clauses 1 and 2 stand part of the Bill proposed, put and agreed to.

Question that the schedule stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Financial Services and the Treasury reported that

the Supplementary Appropriation (2008-2009) Bill

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Merchant Shipping (Safety) (Amendment) Bill 2009

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 27 May 2009 resumed.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Merchant Shipping (Safety) (Amendment) Bill 2009.

Question that clauses 1 to 52 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Transport and Housing reported that

the Merchant Shipping (Safety) (Amendment) Bill 2009

had passed through the Committee without amendment. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Motions

Proposed resolution under the Race Discrimination Ordinance and the Interpretation and General Clauses Ordinance

The Secretary for Constitutional and Mainland Affairs moved the following motion and spoke on the motion:

RESOLVED that the Race Discrimination (Proceedings by Equal Opportunities Commission) Regulation, made by the Secretary for Constitutional and Mainland Affairs on 11 March 2009, be approved, subject to the following amendment – in section 3, in the Chinese text, by deleting “指” and substituting “指出”.

Question on the motion proposed.

Hon Paul TSE spoke on the motion as the Chairman of the Subcommittee on Race Discrimination (Proceedings by Equal Opportunities Commission) Regulation.

Dr Hon Margaret NG spoke on the motion.

While Dr Hon Margaret NG was speaking, the President left the chair at 6:55 pm temporarily and the President's Deputy, Hon Fred LI, took the chair.

Another Member spoke on the motion.

The Secretary for Constitutional and Mainland Affairs replied.

Question on the motion proposed, put and agreed to.

Proposed resolution under the Pharmacy and Poisons Ordinance

The Secretary for Food and Health moved the following motion and spoke on the motion:

RESOLVED that the following Regulations, made by the Pharmacy and Poisons Board on 3 June 2009, be approved –

- (a) the Pharmacy and Poisons (Amendment) (No. 2) Regulation 2009; and
- (b) the Poisons List (Amendment) (No. 2) Regulation 2009.

Question on the motion proposed, put and agreed to.

Members' Motions

Proposed resolution under the Interpretation and General Clauses Ordinance

Hon Audrey EU moved the following motion and spoke on the motion:

RESOLVED that in relation to the Air Pollution Control (Volatile Organic Compounds) (Amendment) Regulation 2009, published in the Gazette as Legal Notice No. 107 of 2009 and laid on the table of the Legislative Council on 27 May 2009, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the first sitting (within the meaning of section 34(6) of that Ordinance) of the next session of the Legislative Council.

Question on the motion proposed, put and agreed to.

Seizing the chance to turn the risks from the 'Three Direct Links' across the Taiwan Strait into opportunities

Hon Mrs Sophie LEUNG moved the following motion and spoke on the motion:

That, since the implementation of the 'Three Direct Links', i.e. direct maritime, air and postal links, across the Taiwan Strait in December last year, coupled with the impact of the financial tsunami, the air passenger and air cargo traffic of Hong Kong has, to a certain extent, been affected; however, apart from promoting cross-strait exchanges and trade flows, the 'Three Direct Links' across the Taiwan Strait is also a development opportunity for Hong Kong; as such, this Council urges the Government to formulate a comprehensive plan to turn the 'Three Direct Links' across the Taiwan Strait into an opportunity for Hong Kong to further develop the relations among the three places across the Taiwan Strait, including:

- (a) conducting a study on fully opening up air rights on a reciprocal basis with the Mainland and Taiwan, so as to raise Hong Kong's position as a regional and international aviation centre;
- (b) strengthening cooperation with the neighbouring airports in the Pearl River Delta to achieve complementarity of edge, so as not to result in mismatched development and to consolidate Hong Kong's status in aviation;
- (c) putting into place arrangement for mutual visa-free access between Hong Kong and Taiwan, and establishing formal channels among the three places across the Taiwan Strait to strengthen exchanges and cooperation at the non-government and societal level as well as in areas of tourism, culture and creativity, etc; and
- (d) setting up a high level inter-departmental task force to study and coordinate long-term development plans for promoting economic and trade cooperation among the three places across the Taiwan Strait.

Question on Hon Mrs Sophie LEUNG's motion proposed.

The President's Deputy stated that seven Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the seven amendments would be debated together in a joint debate.

Hon Tommy CHEUNG, who intended to move an amendment to the motion, spoke on the motion and the amendments.

At 7:28 pm, while Hon Tommy CHEUNG was speaking, the President resumed the chair.

Hon Alan LEONG, Hon Albert CHAN, Hon Fred LI, Hon IP Wai-ming, Hon WONG Ting-kwong and Dr Hon Priscilla LEUNG, who intended to move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Constitutional and Mainland Affairs and the Secretary for Transport and Housing spoke on the motion and the amendments.

Eight Members spoke on the motion and the amendments.

Hon Mrs Sophie LEUNG spoke on the amendments.

The Secretary for Constitutional and Mainland Affairs and the Secretary for Transport and Housing spoke again.

The President suspended the meeting at 9:58 pm.

The Council resumed at 9:00 am on 25 June 2009.

Hon Tommy CHEUNG moved the following amendment to Hon Mrs Sophie LEUNG's motion:

To add "Hong Kong has all along been an important platform for commercial and social exchanges across the Taiwan Strait" after "That"; to delete "and" after "creativity, etc."; and to add "; (e) assisting the Mainland and Taiwan in concluding the Economic Cooperation Framework Agreement at an early date to eliminate the trade barriers between them and jointly create common markets in the Greater China, as well as fully utilizing the functions of the Trade Development Council's Taiwan Office to help Hong Kong businessmen to further develop; (f) studying the feasibility of promoting mutual recognition of professional qualifications among the Mainland, Hong Kong and Taiwan, so as to foster the development of Hong Kong's professional services industries; and (g) bringing forward arrangements with Taiwan to avoid double taxation, so as to enhance the competitiveness of Hong Kong, strengthen Hong Kong's position as a business platform of the Greater China and promote a win-win situation for the three places across the Taiwan Strait" immediately before the full stop.

Question on Hon Tommy CHEUNG's amendment to Hon Mrs Sophie LEUNG's motion proposed, put and agreed to.

As Hon Tommy CHEUNG's amendment had been passed, the President granted leave for Hon Alan LEONG to revise the terms of his amendment.

Hon Alan LEONG moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG, and explained the revised terms of his amendment to the Council:

To add "; so that Taiwan businessmen who set up companies in Hong Kong and operate businesses on the Mainland can avoid paying taxes in Taiwan and Hong Kong at the same time; (h) expeditiously setting up an office of the Special Administrative Region Government in Taiwan; (i) performing Hong Kong's special role as an intermediary in a more proactive manner, turning Hong Kong into a platform for exchanges among the three places across the Taiwan Strait, jointly promoting development in areas of rule of law, corruption prevention, culture and arts, environmental protection, etc on the Mainland and in Hong Kong and Taiwan, thereby enriching non-government and official exchanges among the three places; (j) strengthening cooperation with the Chung Hwa Travel Service, and enhancing its functions in areas of trade, investment and tourism, etc; and (k) promoting cruise tourism among the three places across the Taiwan Strait" immediately before the full stop.

Question on Hon Alan LEONG's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 20 were present, nine were in favour of the amendment, three against it and eight abstained; while among the Members returned by geographical constituencies through direct elections, 22 were present, 13 were in favour of the amendment, two against it and six abstained. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negated.

Hon Fred LI rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Seizing the chance to turn the risks from the 'Three Direct Links' across the Taiwan Strait into opportunities" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

As Hon Tommy CHEUNG's amendment had been passed, the President granted leave for Hon Albert CHAN to revise the terms of his amendment.

Hon Albert CHAN moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG, and explained the revised terms of his amendment to the Council:

To add " ; in addition, as the Administration has ignored the importance of establishing a close relationship with Taiwan for many years, causing the relations between Hong Kong and Taiwan to be at a standstill, and the Hong Kong Government's prohibition of the entry of officials of the Taiwan authorities and related individuals into Hong Kong for many years is even a greater insult to the relevant departments and officials of Taiwan, this Council is therefore extremely disappointed at and strongly condemns the Special Administrative Region Government's change of attitude from arrogance to subservience" immediately before the full stop.

Question on Hon Albert CHAN's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, three were in favour of the amendment, 16 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 14 were in favour of the amendment and nine against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negated.

As Hon Tommy CHEUNG's amendment had been passed, the President granted leave for Hon Fred LI to revise the terms of his amendment.

Hon Fred LI moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG, and explained the revised terms of his amendment to the Council:

To add “; and (h) discussing with Mainland departments to reinstate the right of those Hong Kong residents and Members of the Hong Kong Legislative Council who have been barred from entering the Mainland to return to their hometown and to issue the Hong Kong and Macao Residents Entry and Exit Permits to them, so that all Chinese nationals can travel freely to and from the three places across the Taiwan Strait, thereby achieving true links among these three places” immediately before the full stop.

Question on Hon Fred LI's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG proposed and put.

Hon Fred LI claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, five were in favour of the amendment, eight against it and eight abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 14 were in favour of the amendment and nine against it. (Voting record in Appendix V.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negated.

As Hon Tommy CHEUNG's amendment had been passed, the President granted leave for Hon IP Wai-ming to revise the terms of his amendment.

Hon IP Wai-ming moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG, and explained the revised terms of his amendment to the Council:

To add “; and (h) discussing the setting up of a task force on an airport cluster in the Great Pearl River Delta to exchange views on issues relating to the positioning, airspace, flight routes, flight schedules, runway construction and equity exchange, etc of the airports in the region, and studying the construction of the third runway for the airport of Hong Kong as well as discussing with the Mainland to resolve the problem of airspace allocation, etc” immediately before the full stop.

Question on Hon IP Wai-ming's amendment to Hon Mrs Sophie LEUNG's motion as amended by Tommy CHEUNG proposed, put and agreed to.

As Hon Tommy CHEUNG's and Hon IP Wai-ming's amendments had been passed, the President granted leave for Hon WONG Ting-kwong to revise the terms of his amendment.

Hon WONG Ting-kwong moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG and Hon IP Wai-ming's, and explained the revised terms of his amendment to the Council:

To add “; (i) stepping up efforts to attract Taiwan enterprises to raise capital through Hong Kong, so as to optimize Hong Kong's function as an international financial centre; and (j) actively participating in the planning and construction of the economic zone on the western side of the Taiwan Strait, and optimizing Hong Kong's function as an international financial, shipping and trading centre, so as to enable Hong Kong to continue to maintain its active role and functions in the economic and trading exchanges among the three places across the Taiwan Strait and give new impetus to Hong Kong's economic development” immediately before the full stop.

Question on Hon WONG Ting-kwong's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG and IP Wai-ming proposed, put and agreed to.

As Hon Tommy CHEUNG's, Hon IP Wai-ming's and Hon WONG Ting-kwong's amendments had been passed, the President granted leave for Dr Hon Priscilla LEUNG to revise the terms of her amendment.

Dr Hon Priscilla LEUNG moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Tommy CHEUNG, Hon IP Wai-ming and Hon WONG Ting-kwong, and explained the revised terms of her amendments to the Council:

To add “; (k) actively studying the streamlining of customs clearance procedures for residents of the three places across the Taiwan Strait travelling to and from these places; (l) strengthening exchanges and cooperation in areas of education, environmental protection and mutual legal assistance among the three places across the Taiwan Strait; and (m) in accordance with the existing mode adopted by the Special Administrative Region Government in establishing offices on the Mainland, commencing a study on the feasibility of establishing a government office in Taiwan” immediately before the full stop.

Question on Dr Hon Priscilla LEUNG’s amendment to Hon Mrs Sophie LEUNG’s motion as amended by Hon Tommy CHEUNG, Hon IP Wai-ming and Hon WONG Ting-kwong proposed, put and agreed to.

Hon Mrs Sophie LEUNG replied.

Question on Hon Mrs Sophie LEUNG’s motion as amended by Hon Tommy CHEUNG, Hon IP Wai-ming, Hon WONG Ting-kwong and Dr Hon Priscilla LEUNG put and agreed to.

Strengthening human resources in the fields of finance and trade

Dr Hon Philip WONG moved the following motion and spoke on the motion:

That, in the face of the impact of the financial tsunami, as well as many uncertain factors in the development of the global economic situation, Hong Kong must strengthen its own human resources in order that its position as a regional financial and trade centre can be consolidated; in this connection, this Council urges the Special Administrative Region Government to comprehensively review the existing policies and measures, with a view to strengthening the manpower training provided by local tertiary institutions in the fields of finance and trade, and further attracting relevant professionals across the world to Hong Kong.

Question on Dr Hon Philip WONG’s motion proposed.

The President stated that four Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the four amendments would be debated together in a joint debate.

Hon James TO, Hon Mrs Regina IP, Hon WONG Kwok-hing and Hon LEUNG Kwok-hung, who intended to move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Financial Services and the Treasury and the Secretary for Commerce and Economic Development spoke on the motion and the amendments.

Ten Members spoke on the motion and the amendments.

Dr Hon Philip WONG spoke on the amendments.

The Secretary for Financial Services and the Treasury and the Secretary for Commerce and Economic Development spoke again.

Hon James TO moved the following amendment to Dr Hon Philip WONG's motion:

To add "coupled with the fact that the Lehman Brothers incident, the Octave Notes incident and the CITIC Pacific incident have revealed that from corporate governance to the sale of retail financial products, those in the various sectors of Hong Kong's financial system all have to be better equipped," after "situation,"; to add " , improve corporate governance, and enable the trained personnel to fully understand the operation of the financial market and the relevant financial products, and to explain to the consumers who intend to invest in financial products the details of the products concerned," after "resources"; and to add " ; and this Council also appeals to all the people affected by the deficiencies of the financial system to voice out the above requests by demonstrating their power on 1 July" immediately before the full stop.

Question on Hon James TO's amendment to Dr Hon Philip WONG's motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 18 were present, four were in favour of the amendment, 11 against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 17 were in favour of the amendment and eight against it. (Voting record in Appendix VI.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Fred LI rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Strengthening human resources in the fields of finance and trade" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Mrs Regina IP moved the following amendment to Dr Hon Philip WONG's motion:

To delete "and trade" after "a regional financial" and substitute with ", trade and trade-related services (such as shipping)"; and to delete "and trade" after "finance" and substitute with ", trade and shipping".

Question on Hon Mrs Regina IP's amendment to Dr Hon Philip WONG's motion proposed, put and agreed to.

Hon WONG Kwok-hing moved the following further amendment to Dr Hon Philip WONG's motion as amended by Hon Mrs Regina IP:

To add "under the principle of giving priority to local talents" immediately before the full stop.

Question on Hon WONG Kwok-hing's amendment to Dr Hon Philip WONG's motion as amended by Hon Mrs Regina IP proposed, put and agreed to.

Hon LEUNG Kwok-hung moved the following further amendment to Dr Hon Philip WONG's motion as amended by Hon Mrs Regina IP and Hon WONG Kwok-hing:

To add "; and to ensure that such policies and measures must be formulated through democratic procedures and subject to regulation under appropriate regimes, so as to safeguard the interests of small investors and the public, and prevent government officials from following orders of the business sector and rampant speculative activities" immediately before the full stop.

Question on Hon LEUNG Kwok-hung's amendment to Dr Hon Philip WONG's motion as amended by Hon Mrs Regina IP and Hon WONG Kwok-hing proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 18 were present, four were in favour of the amendment and 14 against it; while among the Members returned by geographical constituencies through direct elections, 27 were present, 17 were in favour of the amendment and nine against it. (Voting record in Appendix VII.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Dr Hon Philip WONG replied.

Question on Dr Hon Philip WONG's motion as amended by Hon Mrs Regina IP and Hon WONG Kwok-hing put and agreed to.

Motion for the adjournment of the Council

The President said that he had determined under Rule 16(6) and (7) of the Rules of Procedure that if at the expiration of 75 minutes from the moving of this motion, there were Members who still wished to speak, he would extend the period of the debate until all Members who wished to speak had spoken, and the designated public officers had given their replies. As regards the speaking time, each Member might speak up to five minutes, and the designated public officers making replies might speak up to 15 minutes in total.

Hon CHEUNG Man-kwong moved the following motion and spoke on the motion:

That this Council do now adjourn for the purpose of debating the following issue: the relocation of Christian Zheng Sheng College to the former Heung Yee Kuk Southern District Secondary School in Mui Wo.

While Hon CHEUNG Man-kwong was speaking, the President left the chair at 12:01 pm temporarily and the President's Deputy, Hon Fred LI, took the chair.

Question on the motion proposed.

Five Members and Hon LAU Wong-fat spoke on the motion.

At 12:32 pm, while Hon LAU Wong-fat was speaking, the President resumed the chair.

Thirteen other Members spoke on the motion.

With the President's permission, Hon WONG Yuk-man clarified a point which he had raised earlier in his speech.

Four more Members spoke on the motion.

The Secretary for Security and the Secretary for Education replied.

As more than one and a half hours had lapsed since the moving of the motion, the President adjourned the Council without putting any question on the motion under Rule 16(7) of the Rules of Procedure.

Next meeting

The President declared that the next meeting of the Council would be held on 7 July 2009 at 3:00 pm.

The Council was adjourned at 2:13 pm.
