Special Finance Committee meeting on 24 March 2009


At the Special Finance Committee (FC) meeting yesterday when Members examined the Estimates of the Constitutional and Mainland Affairs Bureau, two Legislative Council (LegCo) Members repeatedly used vulgar and offensive language against the public officers attending the meeting, departing once again from Rules 10(2) and 41(4) of the LegCo Rules of Procedures which are applicable to FC meetings. We also note that FC Chairman had not reminded Members that they should not use such language which breached Rule 41(4).

We note that some Members have repeatedly challenged the Rules of Procedures by using grossly improper and offensive language and behaviour despite the fact that we have written several times to LegCo expressing our deep concern over such behaviour. Such acts seriously

departed from the spirit of mutual respect which underlies the Rules of Procedures and for which we express our deep regret.

We look to LegCo to adopt effective means as soon as possible to ensure public officers attending meetings of LegCo, including the remaining Special FC meetings, would not be subject to offensive language or behaviour.

Special Finance Committee meeting on 24 March 2009

I refer to your letter dated 25 March 2009 regarding your concern about the use of vulgar and offensive language by two Members at the special Finance Committee meeting on 24 March 2009.

As Chairman of the Finance Committee, I am responsible for the observance of the rules of order in the Committee. At the meeting on 24 March 2009, my attention had not been drawn to any vulgar or offensive language being used by Members against public officers. As you may probably be aware, I reminded Members twice at the special Finance Committee meeting yesterday that the Legislative Council does not accept the use of offensive language against Members and public officers at meetings of the Council and its committees. I also advised Members and public officers attending Finance Committee meetings to bring to my attention that such offensive or insulting language was used so that I could act in accordance with the Rules of Procedure and the Finance Committee Procedure.

In view of your having written to the President and the Chairman of the House Committee concurrently on this matter, I am providing a copy of this letter to the President and all other Members for their information.
