Reply :

The Home Affairs Department implements a Social Enterprises Partnership Programme which comprises the matching forum and mentorship scheme to provide a platform to enhance and facilitate partnership among different sectors of the community. It has been providing an effective means to enrich the entrepreneurial skills of social enterprise (SE) operators by having business entrepreneurs / professional offering advisory service to them. We will continue our effort in this regard and arrange sharing sessions to further enhance our support to SE operators.

In 2007-08 and 2008-09, we commissioned business plan writing competitions which provided training to tertiary students to help them turn their ideas into viable business models. Having regard to the positive feedback, we will consider commissioning similar business plan writing competition in 2009-10 and with more emphasis on the implementation of these business plans.

In the reply (Serial No. HAB069) to a question raised in the Examination of Estimates of Expenditure 2009-10, it was stated that the Administration commissioned the Centre for Cultural Policy Research of the University of Hong Kong to conduct A Study on Creativity Index in 2004. The study constructed a theoretical framework for measuring and evaluating the status of creativity in a place and the Creativity Index comprising 88 indicators tabulated from different data sources. Would the Administration inform this Committee:

1. What are the 88 indicators tabulated from different data sources? Please specify. What is the weighting of each indicator?
2. What was the Creativity Index derived by using these indicators from 1999 to 2008?
3. From 1999 to 2008, were there any changes in these 88 indicators? Please indicate in chronological order and table form.

Reply:

The Study on Creativity Index was conducted in 2004 using the historical data from 1999-2004. The Creativity Index is a statistical framework for measuring the status of creativity and the determinants of the growth of creativity in a place. The 88 indicators forming the Creativity Index are listed in Chapter IV of the study report and now attached at **Annex**. The weighting of each indicator is the same.

The overall Creativity Index for Hong Kong during 1999-2004 has shown a positive growth pattern. We have no information on the changes in the Creativity Index after 2004.

It is stated in Reply Serial No. HAB109 that the Administration will only provide secretariat support services for the Family Council, and that only \$5 million has been earmarked to promote the family core values. Please inform this Committee of the following:

- (a) What is the number of meetings, work progress and scope of discussion of the Family Council for the past two years?
- (b) The promotion of family-friendly practices and family core values involves efforts on various fronts, including labour, social welfare, education, etc, yet, the Family Council is only provided a budget of \$5 million for the promotional and publicity work. What are the reasons?
- (c) Since services and initiatives to support families are provided by different service providers and agents, please advise whether and how the Family Council is able to monitor that such initiatives and services adhere to its recommendations.

Reply :

(a) The Family Council was set up in December 2007. Six meetings have been held. The Council has had in-depth discussions about the family core values; ways to achieve a pro-family environment and family-friendly employment practices; better enhancement and co-ordination of family and parental education; and recommendations on better synergy between the Family Council and other stakeholders and advisory bodies. To advocate for cherishing the family as a main driver for social harmony, the Council has also rolled out territory-wide promotional activities to promote family core values.

Question :

The Administration has stated in the Reply Serial No. HAB 161 that the Rural Public Works (RPW) projects are not solely or directly related to works arising from the rainstorms in 2008. Regarding the incidents of flooding and landslips caused by the rainstorms last year, please advise the number of projects to be implemented in the coming year for the restoration and protection of the affected areas and the prevention of flooding and landslips. How much resources will be involved?

Asked by : Hon. WONG Kwok-hing

Reply :

During the rainy season in 2008, there were incidents of severe flooding in the rural areas of the New Territories. The Home Affairs Department (HAD) assisted to implement some of the restoration works under the RPW Programme. For example, in Islands district which was most affected by the rainstorms last year, we have carried / will carry out various works under the RPW Programme to restore local facilities damaged by flooding or landslips. These include reconstruction/improvement to drainage channels, stream course/ embankments, footpaths, footbridges and piers etc. Two projects have commenced and another nine will commence in the coming financial year. The total estimated project costs amount to some \$20 million.

Apart from the RPW programme, HAD also carried out restitution/emergency works and minor district improvement works to rural facilities damaged by rainstorms and typhoons under the Local Public Works (Maintenance) Programme and the District Minor Works programme in 2008-09. These include removing from footpaths debris resulting from landslips, desilting, reconnecting water pipes/ restoring water supply at villages and reinstallation of damaged railings.

In 2009-10, we plan to implement 38 improvement projects at a total cost of about \$30 million in the rural areas of the New Territories so as to prevent / alleviate flooding problems under the RPW Programme. These projects include erection of floodgates, improvement / construction of drainage channels and improvement to stream courses and stream embankments. As for works in relation to the prevention of landslip, they will be implemented by other works departments as HAD does not have the required geo-technical expertise.

The Administration is requested to provide information on the provision earmarked for the anticipated increase in criminal legal aid fees for 2009-10.

Reply:

The Administration put forward a revised proposal on criminal legal aid fee rates to the Law Society for consideration in December 2008, which, if accepted by the Law Society, represents an increase of about 70% from the current level of rates and the estimated increase in remuneration for solicitors engaged in criminal legal aid work will be about 120% to 400%, depending on the length and complexity of individual cases. The overall expenditure on criminal legal aid costs is expected to increase by around \$90 million per annum. The Administration has made provision in 2009-10 for the anticipated increase in legal aid fees.

Hong Kong will host the 2009 East Asian Games in December 2009. To enable our athletes to achieve high levels of performance in the events, the Government has provided \$19.4 million for the National Sports Associations (NSAs) to prepare the athletes for the Games, of which \$17 million is provided for enhancement of training and preparation programmes whilst \$2.4 million is for organising test events. A breakdown of the distribution of subventions disbursed to the NSAs of the 23 sports that will be contested at the Games is at the Annex.

Reply :

The Hong Kong Tourism Board (HKTB) will promote the 2009 East Asian Games (EAG) through various channels, including its website, publications and visitor centres. It will provide EAG volunteers with Hong Kong tourism information to help them look after the visiting athletes, VIPs and tourists. Its worldwide offices will work with the tourism trade and related organisations in the EAG's participating countries and regions to incorporate EAG events into the travel itineraries. During the EAG period, the HKTB will organise activities for the visiting media to showcase Hong Kong's attractions. The work will be implemented by the HKTB within its overall marketing budget for overseas promotion.

The Information Services Department (ISD) works closely with the Leisure and Cultural Services Department, the 2009 East Asian Games Company and the Hong Kong Economic and Trade Offices in the Mainland and overseas to promote the EAG through a variety of publicity programmes for EAG. In 2009-10, ISD will allocate about \$3 million for promoting EAG outside Hong Kong.
