PWSC(2009-10)15**


We refer to your letter referenced CB1/F/2/6(II) of 23 April 2009 to the Secretary for Financial Services and the Treasury.

In considering the paper referenced PWSC(2009-10)15 on 35CG "Greening master plan for Kowloon West", 36CG "Greening master plan for Hong Kong Island" and 40CG "Greening master plan for Kowloon East", Members requested the Administration to provide supplementary information on the following –

- (a) information on the specific sites where greening works would be implemented; and
- (b) the maintenance plans of the greening works under the proposed greening master plans.

The requested information is set out at the Annex for Members' reference. As regards (a) above, as the documents are very bulky (comprising more than 250 A3-size pages), we have not attached the hard copies of the greening master plans for environmental reasons but will deposit one set of the hard copies in LegCo Secretariat for Members' reference. - (b) The maintenance plans of the greening works under the proposed greening master plans

CEDD will provide one-year establishment work for the proposed greening works under GMPs and then maintain the greening works for at least one more year. Before the end of the above maintenance period, CEDD will review the outcome and discuss with the Leisure and Cultural Services Department with a view to developing a long-term maintenance strategy for GMPs related greening works.
