Updated 2008-09 Legislative Programme

In line with established practice, I attach at Annex the updated 2008-09 Legislative Programme for Members' reference.

The Building Management (Amendment) Bill was originally scheduled for introduction in the first half of the current legislative In the light of Members' comments at the Home Affairs Panel, the Administration will first explore administrative measures to assist members of management committee to observe the existing statutory declaration requirement. For bills intended for introduction in the second half of the 2008-09 legislative session (i.e. between March to July 2009), a new item, the Voting by Imprisoned Persons Bill, is now added. At the same time, the timing for seven bills, viz. Competition Bill, Buildings Energy Efficiency Bill, Employment (Amendment) Bill, Import and Export (Amendment) Bill, Food Safety Bill, Public Health and Municipal Services (Amendment) (No. 2) Bill and Residential Care Homes (Persons with Disabilities) Bill, have to be adjusted. Relevant bureaux will introduce these bills to LegCo upon completion of relevant preparatory work.

The updated programme serves as an indication of the Administration's latest legislative proposals, and is subject to change in light of development in the remaining months of the legislative session.
