Action

I Meeting with the Administration

Matters arising from previous meetings

- (LC Paper No. CB(1)157/08-09(01) - Administration's paper on taxi fares

The Subcommittee deliberated (index of proceedings attached at **Annex**).

Action

2. Members noted the Administration's response to the views and suggestions made at the last meeting of the Subcommittee held on 6 November 2008 regarding the introduction of legislative proposals to prohibit fare bargaining. The Administration appealed to members for support of the fare adjustments for the urban and Lantau taxis under the Road Traffic (Public Service Vehicles) (Amendment) Regulation 2008 (the Amendment Regulation). It would closely monitor changes in the operating environment of the taxi trade after the implementation of the fare adjustments. Meanwhile, it would study the overseas experience regarding the regulation of charging taxi fares according to meters and engage the taxi trade through the Transport Department's taxi conferences to understand more their views and concerns. It would report to the Panel on Transport findings of the study on overseas experience and the engagement with the taxi trade in six months' time.

3. The Subcommittee was disappointed that the Administration had not agreed to work out the above legislative proposals within six months, or to provide a concrete timetable for the legislative proposals. The Subcommittee considered Mr Ronny TONG's proposal of repealing the Amendment Regulation. However, there was no consensus view among members regarding the proposal. Ms Cyd HO suggested moving amendments to the Amendment Regulation to provide for an expiry date for the fare adjustments, i.e. to impose a "sunset section" to the Amendment Regulation. According to her, the "sunset section" would allow the fare adjustments to be implemented from 30 November 2008, while setting a time limit for the Administration to come back with concrete legislative proposals. Some members had reservations about moving the amendments proposed by Ms HO.

The Chairman asked members to inform the Secretariat before 17 November 2008 whether they wished to propose amendments to the Amendment Regulation, so that she could consider whether she would seek the agreement of the House Committee for her to move a motion to adjourn the Council on 26 November 2008 under Rule 16(4) of the Rules of Procedure to enable Members to debate on the Amendment Regulation. The Chairman also reminded members that a Member who wished to seek the President's permission to address the Council at the meeting on 26 November 2008 under Rule 21(5) of the Rules of Procedure on subsidiary legislation tabled in the Council should provide an advance copy of the intended address to the President.
