Funding support for activities to promote racial harmony and support services for ethnic minorities

Purpose

In response to issues raised by a Member at the Subcommittee meeting of 12 June 2009, this paper explains the selection of organisations for funding grants to promote racial harmony and provide support services to ethnic minorities in Hong Kong and monitoring of their performance.

Background

2. Since the establishment of the Race Relations Unit in 2002, Government has been providing funding grants to non-government organisations (NGOs) to provide support services for ethnic minorities and organize educational, cultural and community participation activities to promote racial harmony. The major services and activities are listed in **Annexes A and B**.

3. In this relation, we have provided additional resources to the Equal Opportunities Commission (EOC) for the implementation of the Race Discrimination Ordinance (RDO) and the related promotion and public education efforts on racial equality. An additional recurrent subvention of \$1.05 million has been provided to the EOC starting from the 2009/10 financial year for this purpose. Separately, we have reserved an additional recurrent subvention of around \$4 million for the EOC to implement the RDO, subject to the assessment with the EOC on their resource needs.

Selection

- 4. The selection of NGOs to operate the concerned services and activities is conducted in a fair, objective and competitive manner. The assessment criteria are set out when inviting applications from eligible organisations. These criteria include the merit and viability of the proposal, whether the proposal meets the stated objectives, the experience of the applicant and financial consideration. As an illustration, the assessment criteria in respect of the support service centres for ethnic minorities, as provided in the project brief issued in December 2008, are set out at **Annex C**.
- 5. Before deciding on the organisations to receive such grants, the proposals of the applicants were assessed in accordance with the criteria, in order to select the most suitable organisations. As the process is a competitive one, applicants may not be selected as they did not meet fully the eligibility criteria or more suitable organisations were chosen in accordance with the selection criteria.

Monitoring and review mechanisms

6. The performance of the organisations in carrying out the activities is kept under monitoring and review to ensure cost effective use of public funds. These include examination of reports of the sponsored activities by the organisations concerned, conducting visits to such

services and activities and requiring participants to fill in questionnaire to provide an assessment of the activities from their perspective. We also receive feedbacks from the ethnic minority communities through various channels from time to time on the services and measures provided.

- 7. For services which are provided on a longer term basis (as opposed to one-off projects funded under the funding scheme), we also consider whether to renew the funding grant of these services to the organisations concerned from time to time, taking into account the effectiveness of the services, the performance of the organisations, and the feedback from the users and the community.
- 8. The Government will continue to provide such support services and activities through engaging suitable NGOs. We will continue to conduct the selection process in a fair, objective and competitive manner and implement suitable review and monitoring measures as appropriate.

Support service centres for ethnic minorities

Major considerations for assessing the applications include the following –

- (a) viability and merit of the proposals
- (b) experience, past performance and capability of the applicant NGOs in providing support services to ethnic communities
- (c) expertise and qualification of personnel involved in carrying out the programmes
- (d) capability to network and cooperate with other organizations to deliver the supportive services and to make appropriate referrals
- (e) attainment levels for the output and outcome indicators mentioned in the project brief (and other performance assessment tools, if any, proposed by the applicant NGOs)
- (f) the time by which the centre will come into operation; and
- (g) budget and cost-efficiency.
