Working Timetable for Public Consultation and Legislative Process for the Two Electoral Methods for 2012

Introduction

This paper sets out the working timetable for the public consultation and the legislative process for the two electoral methods for 2012.

Working timetable for public consultation and legislative process

- 2. The Chief Executive (CE) announced on 15 January the decision to slightly postpone the public consultation on the two electoral methods for 2012 from the first half of this year to the fourth quarter, so that the community could focus on dealing with the economic issues arising from the financial tsunami. We plan to commence the public consultation on the 2012 electoral arrangements in the fourth quarter of this year, which will last about three months.
- 3. After summarizing the views received, we will present to the Legislative Council (LegCo) the proposed amendments to Annexes I and II to the Basic Law and strive to obtain the endorsement of LegCo. The relevant amendments will need to receive the endorsement of LegCo, obtain the consent of the CE and be reported to the Standing Committee of the National People's Congress for approval or for the record. We hope that this process could be completed by no later than the fourth quarter of 2010.
- 4. There will be about one year's time between the fourth quarter of 2009 and the fourth quarter of 2010, which would be sufficient for dealing with the public consultation and the amendments to Annexes I and II to the Basic Law. We plan to deal with the local legislation, including the amendments to the "Chief Executive Election Ordinance" and the "Legislative Council Ordinance" between early and mid-2011.

Thereafter, we will deal with the relevant subsidiary legislation and the practical arrangements for the two elections, so that the fourth term CE election and fifth term LegCo election could be held smoothly in March and September 2012 respectively.

5. The detailed working timetable for the public consultation and the legislative process is at the <u>Annex</u>.

Conclusion

- 6. Based on the above-mentioned working timetable for the public consultation and the legislative process, the Hong Kong community will still have sufficient time to discuss and forge consensus on the electoral arrangements for 2012. We will continue to make preparations for the public consultation exercise and conduct internal studies on the subject. We will also listen to the views expressed within the community, which will serve as reference for conducting the public consultation in the fourth quarter of 2009.
- 7. Although the public consultation has been slightly postponed, the objective of the Government to determine the two electoral methods for 2012 within its tenure has not changed. The aim of the Government is to roll forward the electoral methods for 2012 to a mid-way point, so as to pave the way for implementing universal suffrage for the CE in 2017 and LegCo in 2020.
