**Developing an Electronic Health Record Sharing Infrastructure in Hong Kong**

I am writing on behalf of Hong Kong Internet Service Providers Association ( "HKISPA" ) to recommend the Panel on Health Services to support the Government's initiative to develop a territory-wide electronic health record ( "eHR" ) sharing system.

We welcome the proposal to involve the Information and Communications Technology ( "ICT" ) industry in developing the eHR sharing system, in accordance with the eHR standards and as guided by the certification scheme for compliance and inter-operability. We believe that our telecom, internet and IT expertise could also be deployed to support private healthcare providers in upgrading their information systems and infrastructures with sharing capabilities, which will improve the quality, reliability and delivery of care to patients, lower the healthcare expenditures, and minimize medical mistakes.

Being able to participate in this project and in many constructive partnerships, involving both public and private sectors across both healthcare and ICT industries, will be a major boost to the local ICT industry. We believe that the eHR sharing system will create demand for skills and expertise for the local ICT and health informatics industry. eHR sharing system will also make a significant contribution towards the Digital 21 strategy.
