Progress Report on The Admission Scheme for Mainland Talents and Professionals

(From 1st October 2008 to 31st March 2009)

Employment applications

The Scheme was implemented on 15th July 2003. Between 1st October 2008 to 31st March 2009, **3340** entry applications for employment were received (monthly average: **557**). In the same period, **2732** applications were approved, **215** refused and **351** withdrawn/no further action taken. As at 31st March 2009, **752** applications were under processing.
