Replacement of Emergency Ambulances

At the meeting of the LegCo Panel on Security on 27 October 2008, Members discussed the replacement of emergency ambulances for the Fire Services Department. The supplementary information requested by Members at the meeting is set out below:

(1) **Assessment criteria for determining the replacement schedule of ambulances**

The assessment criteria adopted for determining the replacement of ambulances include vehicle age, maintenance cost, mileage, replacement cost and vehicle condition.

(2) **Types and number of specialised vehicles in the service of the Government, and the criteria adopted for replacement of these vehicles**

Based on the information provided by the Government Logistics Department (GLD), a specialised vehicle in the service of the Government refers to a vehicle which, in addition to having the

capacity for carrying passengers and/or goods, has mounted on it ancillary equipment for the purpose of performing a specific function. Emergency ambulances are regarded by GLD as specialised vehicles. As of 1 December 2008, the types and number of specialised vehicles in the service of the Government are listed in **Annex A**.

The criteria used for determining the replacement need of specialised vehicles include vehicle age, maintenance cost, mileage, replacement cost and vehicle condition.

(3) Breakdown of emergency calls with response time exceeding 12 minutes, by the duration of delay in the past three years

A breakdown of emergency calls by the length of response time for 2006, 2007 and 2008 (first 11 months) is listed in **Annex B**.
