I. Meeting with the Administration

Follow-up action to be taken by the Administration

2. Regarding the technical devices, other than handheld metal detectors, which could be considered technically suitable for assisting Police officers in the conduct of custody searches, the Administration was requested to -

- (a) provide information on the specifications of the equipment examined by the Police;
- (b) explain why the devices which had been examined by the Police failed to meet its requirement; and
- (c) advise whether the problems were related to the technical aspect of the equipment, such as sensitivity, and the cost involved.

Way forward

3. Members agreed that the Subcommittee could conclude its work after holding one more meeting before 9 December 2009 to discuss the remaining issue concerning the deployment of technical aids/equipment in custody searches.
4. The Chairman said that a draft report would be prepared for submission to the Panel on Security, having regard to issues studied/discussed by the Subcommittee at previous meetings. The draft report would be circulated to members for consideration once available.

II. Date of next meeting

5. The Subcommittee agreed that the Clerk would liaise with the Administration for provision of the information as referred to in paragraph 2 above and schedule the next meeting in consultation with the Chairman.

She asked whether the Police had any guidelines on carrying out searches of suspects on streets or places outside the Police stations</p> <p>The Administration advised that operational searches should only be conducted in accordance with the power vested in the Police under various legislations, such as searching of dangerous drug under the Dangerous Drugs Ordinance (Cap. 134), and a person being searched would be informed of the reason of the search. In carrying out operational searches, the Police would follow the overriding principles set out in the Guidelines on the Searching of Detained Persons. This type of search should be conducted only upon the direction of an officer of or above the rank of Sergeant who should record the details of the incident in CIS or his Police notebook. Every search should be recorded in the notebook of the officer who conducts the search and the information would also be recorded in the Police computer system so that the information could be retrieved in the future.</p>

However, the Police had not yet identified any equipment, the technical capability of which could meet the operational requirement to detect all sorts of items/articles concealed in the body, along with other relevant considerations such as costs and practicability</p> <p>Mr LAU Kong-wah considered that the progress of the study on the use of advanced technology and devices to assist Police officers in the conduct of searches was not satisfactory. He called on the Administration to step up its efforts in this regard</p> <p>The Administration advised that the Police had all along maintained close liaison with the Correctional Services Department, so as to coordinate the efforts of the two law enforcement agencies in the search for suitable equipment for conducting body searches</p>
