Action

**I. Review of the Comprehensive Social Security Assistance Scheme**

[LC Paper Nos. CB(2)1481/08-09(01) to (02), CB(2)1712/08-09(01) to (02), CB(2)1774/08-09(01) to (05), CB(2)1793/08-09(01) and CB(2)1821/08-09(01) to (06)]

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. The Subcommittee received views from 27 deputations on the Comprehensive Social Security Assistance (CSSA) Scheme. Major views of the deputations are summarised as follows –

Adequacy of CSSA payments and the adjustment mechanism of the CSSA Scheme

---

- (a) the CSSA payments were inadequate to meet the basic needs of children and could not support their development and learning needs in full. It was noteworthy that the magnitude of the rise in prices for school-related items in the past few years was greater than the movements in Social Security Assistance Index of Prices (SSAIP). There was a need to review the level of CSSA payments for children, and calculate the level of CSSA payments for them having regard to their development needs based on a different formula;

Action

- (b) the CSSA payments were inadequate to meet the basic needs of the elderly, in particular the expenses for private medical treatment and nutritious diets. Besides, the requirement for elders living with their family members to apply for CSSA on a household basis had given rise to the problem of elders in poverty. In the absence of a retirement protection scheme in Hong Kong, many grassroots were very concerned about their livelihood in the twilight years;
- (c) over one half of CSSA households living in private housing were paying actual rental higher than the maximum levels of rent allowance (MRA) under the CSSA Scheme. They had to cut other expenses on basic needs to save money for the rental. The Administration should consider restoring MRA to the 2003-level and reviewing the existing adjustment mechanism of MRA;
- (d) the abolition of special grants and long-term supplement for able-bodied adult CSSA recipients, including dental grants, expenses for eye glasses and rental deposit had posed hardship to CSSA households and further widened the gap between the rich and the poor;
- (e) the basic needs items covered under the CSSA Scheme were incompatible with the present needs, for instance, Internet access charges were not included. The Administration should conduct a comprehensive review on the CSSA Scheme. Besides, the interval for conducting the Household Expenditure Survey (HES) on CSSA Households should be shortened from five years to three years;
- (f) under the current mechanism for adjusting CSSA standard rates, the adjustment of CSSA standard rates lagged behind the inflationary cycle and failed to catch up with the rising prices. The Administration should consider reverting to the forecast methodology;

Operation of the discretionary mechanism on residence requirements

- (g) some Hong Kong residents who had worked outside Hong Kong for a period of time and had returned to Hong Kong due to loss of jobs were not eligible for CSSA because they could not satisfy the one-year-continuous-residence requirement. Although the Director of Social Welfare (DSW) might exercise discretion to waive the one-year-continuous-residence requirement, they would be granted with the discretion only when their savings had been almost used up. Given that these people were Hong Kong permanent residents, the one-year-continuous-residence requirement should be abolished;

Action

- (h) the seven-year residence requirement under the CSSA Scheme had posed financial difficulties to families with newly arrived members. Although discretion could be exercised having regard to individual circumstances, many newly arrived women had difficulties in meeting the criteria for exercising the discretion to waive the residence requirement. Moreover, it was difficult for some newly arrived single mothers to find jobs for fulfilling the working hours requirement under the New Dawn Project without leaving their children unattended. The Administration was urged to provide more assistance to these families, for instance, setting up a fund to assist newly arrived women to integrate into the society and enter into the labour market;
- (i) although discretion could be exercised to waive the residence requirements under the CSSA Scheme, the operation of the discretionary mechanism lacked transparency; and
- (j) the Administration should delegate the authority to exercise discretion to waive the residence requirements to frontline social workers in SWD, who had more in-depth understanding of the needs of the applicants.

3. Deputy Director of Social Welfare (Administration) (DDSW(A)) advised that the CSSA Scheme, which was non-contributory, aimed to provide a safety net of last resort for those in need so that they could meet their basic needs. The Administration had to strike a balance between providing financial assistance to the needy and ensuring proper use of public fund. In response to the concerns raised by the deputations, DDSW(A) made the following points –

- (a) the Administration attached great importance to the needs of children and would look into the aspect of Internet access charges in the forthcoming HES on CSSA Households. CSSA was not the only source of assistance to the needy, there were other forms of assistance, such as medical waivers, Computer Recycling Programme and school-based grants for after-school activities etc available for students from needy households, whether or not they were already on CSSA;
- (b) the rationale for requiring elders living with their family members to apply for CSSA on a household basis was to encourage family members to support each other. Nonetheless, discretion would be exercised if there were special circumstances, for example, where an elderly applicant had poor relationship with his/her family members or there were special reasons for which children of an applicant could not provide support to him/her;

Action

- (c) under the existing mechanism, the CSSA standard rates were adjusted annually in accordance with the movement of SSAIP in order to maintain the purchasing power of the payments, and an additional adjustment was made in August 2008 ahead of the normal adjustment cycle to ease the impact of inflation on CSSA recipients. Besides, two additional months and one additional month of CSSA standard rates were paid to CSSA recipients in 2008 and 2009 respectively. In accordance with the same mechanism, CSSA payment rates were adjusted downward by 11.1% in 2003 in the light of the persistent drop in SSAIP during the deflationary period;
- (d) MRA would be adjusted in accordance with the movement of index for private housing rent of Consumer Price Index (A) under the existing mechanism;
- (e) the long-term supplement for able-bodied adult CSSA recipients was abolished in 1999 to encourage them to work towards self-reliance. To provide additional financial incentives for able-bodied adult CSSA recipients to find and remain in employment, the "no reduction" limit for Disregarded Earnings (DE) had been raised and the eligibility criteria for DE had also been relaxed in December 2007;
- (f) DSW would take into account all relevant factors of each case, such as domestic violence, to establish whether there was genuine hardship for exercising his discretion to waive the seven-year residence requirement. Each case would be considered on its own merits. Over 5 000 CSSA applications had been exempted from the requirement since 1 January 2004;
- (g) in considering whether discretion would be exercised to waive the one-year-continuous-residence requirement, resources available to the applicants and their family members would be taken into account to establish whether the applicants were in genuine hardship. Over 3 000 CSSA applications had been exempted from the requirement since 1 June 2007; and
- (h) there was a clear delineation of work between frontline social workers and social security officers of Social Security Field Units (SSFUs) in SWD.

4. Principal Assistant Secretary for Labour and Welfare (Welfare)<sup>4</sup> supplemented that families encountering hardship could always approach the SSFUs. Staff at the SSFUs would render assistance to them or refer their cases to other agencies for follow-up as appropriate.

Action

5. The Chairman thanked deputations for attending the meeting and said that the Subcommittee would take into consideration deputations' views when drawing up the recommendations for the Administration's consideration.

6. The Subcommittee agreed to discuss the progress of development of social enterprises at the next meeting to be held on 7 July 2009.
