**Information provided by the Administration
in response to the letter from the Clerk to the Select Committee
dated 23 January 2009
(as at 6 March 2009)**

Transport and Housing Bureau's ("THB") remarks: Further to ^{T106}~~FHB-135~~, we are providing below additional documents in response to questions from the Select Committee in relation to the Hunghom Peninsula development (items 2(c), (e), (f) and (n)(iii)) If the Select Committee has any further questions, we would be happy to provide additional information.

2. Information on Hunghom Peninsula development

- (c) Detailed account on the role and participation of Mr LEUNG Chin-man in the Hunghom Peninsula incident including but not limited to the following:
- (i) Drawing up of the provisions in the land lease for the site for Hunghom Peninsula development;

*THB and Lands Department ("LandsD")'s response :
When the lease conditions for Hunghom Peninsula were first drafted in October 1994 and subsequently approved by the District Land Conference in June 1995 for sale by tender, Mr LEUNG Chin-man ("Mr LEUNG") was the Director of the Hong Kong Economic and Trade Office in Toronto. He was not involved in the drawing up of the land lease provisions for the site for the Hunghom Peninsula development.*

- (ii) Granting of the land lease to the developer of Hunghom Peninsula;

THB and LandsD's response : The site for Hunghom Peninsula development has been tendered for three times. The first two tenders were not successful and the third tender was finally awarded to the present grantee First Star Development Ltd ("the Developer"). In this

process, Mr LEUNG only participated as the Chairman of the Private Sector Participation Scheme ("PSPS") Tender Board on 20 January 1998 as the acting Secretary for Housing when the site was tendered for the second time.

The details of the tendering process are summarized as follows: The first tender was conducted on 15 September 1995 but was subsequently withdrawn due to a judicial review proceeding. There is no file record to suggest that Mr LEUNG was involved in the first tender.

The second tender of the site for PSPS was conducted on 22 August 1997 following the withdrawal of the earlier tender. At this re-tender exercise, three highest bidders were short-listed in accordance with the shortlisting rules (i.e. the Tender Board should only shortlist those tenders within 5% of the highest premium tender subject to a minimum of three tenders for assessment).

Mr LEUNG was the Deputy Secretary for Housing (1) ("DSH(1)") from 25 September 1997 until 25 August 1999. He chaired the PSPS Tender Board meeting on 20 January 1998 as Acting Secretary for Housing, to consider the tender. The relevant extract of this Tender Board meeting minutes is at ~~THB-140~~^{T37(c)} ~~THB-140~~^{T37(c)}. Since all highest bidders withdrew from the tender due to commercial reasons and there was no shortlisted tender left for consideration by the Board, the meeting agreed to re-tender the site.

The third tender exercise was originally scheduled on 3 July 1998, but was subsequently suspended in June 1998 following the suspension in land sales. The PSPS project was then included in the Land Sale Programme for disposal in the 1999/2000 financial year, and tender was invited on 25 April 1999 and closed on 25 June 1999. The PSPS Tender Board vide its meeting on 27 July 1999 agreed to award the tender to the

highest tender, First Star Development Ltd. There is no file record to suggest that Mr LEUNG was involved in the third tender.

- (iii) Approval of building plans of or modification of plans to the Hunghom Peninsula development;

THB and Buildings Department ("BD")'s response : The building plan and its modification are subject to the approval of BD.

Before the issuance of the Occupation Permit on 6 August 2002, BD processed the building plans and its amendments submitted within the period from October 1999 to April 2002 during which Mr LEUNG was the Director of Buildings. After the issuance of the Occupation Permit, BD processed the building plans for the Alteration & Addition Works submitted from May 2005 to April 2008 during which Mr LEUNG was the Permanent Secretary for Housing, Planning and Lands (Housing) ("PSH").

There is no file record to suggest that Mr LEUNG was involved in the approval of building plans of the Hunghom Peninsula development and its subsequent modification.

- (iv) Formulation of the policy of cessation of the production and sale of Home Ownership Scheme and PSPS flats;

THB's response : File record shows that Mr LEUNG's subordinates in Housing Department ("HD") prepared analysis for his consideration but there is no file record of further discussion or internal meeting. The following documents are relevant –

The policy of cessation of the production and sale of Home Ownership Scheme (“HOS”) and PSPS flats was prepared in the form of a draft Policy Committee (“PC”) paper in October 2002 through circulation among relevant bureaux and departments for comments. As head of HD, Mr LEUNG considered the paper before submission to the Secretary for Housing, Planning and Lands (“SHPL”) for clearance. The paper was then submitted to the PC for discussion on 24 October 2002. Mr LEUNG attended the PC meeting for this item. After PC’s consideration, a paper was formulated by circulation to various departments and submitted for the consideration by the Chief Executive in Council on 12 November 2002. Mr LEUNG, as head of the HD, considered the paper before submission to SHPL for clearance. Mr LEUNG attended the Executive Council (“ExCo”) meeting for this item. - (v) Formulation of the options for the disposal of the Hunghom Peninsula PSPS flats ("the disposal options");

THB's response : The disposal of PSPS flats was discussed at the Steering Committee on Land Supply for Housing ("HOUSCOM") on 13 August 2002 chaired by SHPL. Mr LEUNG attended the meeting as PSH. The relevant paper and extract of the meeting minutes are as follows : -

Assistant Director/Legal Advice of HD ("AD/LA") to the then Assistant Director/Legal (Kowloon and Conveyancing) of Lands Department ("AD/L(K&Con)") in which it was mentioned that AD/LA was going to advise SHPL and Mr LEUNG (as the then PSH) on the joint advice given by Senior Counsel and Counsel. - (vii) Making of the decision to dispose of the Hunghom Peninsula PSPS flats through lease modification with the developer to enable the latter to sell the PSPS flats in the open market;

THB's response : Please refer to THB's response to 2(c)(v).

- (viii) Negotiation with the developer in the lease modification process during the period from January to March 2003, including the drawing up of the negotiation strategy, setting of the premium and revised premium, etc.;

THB and LandsD's response : Pursuant to ExCo's decision on 12 November 2002, LandsD carried out negotiation with the Developer on the proposed lease modification terms including the premium amount to be paid for the lease modification. The negotiation halted in late March 2003 since both sides were unable to reach any agreement. There is no file record to suggest that Mr LEUNG was involved in the negotiation with the developer (including the drawing up of the negotiation strategy, setting of the premium and revised premium, etc.) in the lease modification process during the period from January to March 2003.

- (ix) Mediation with the developer in the lease modification process during the period from April to December 2003, including the drawing up of the strategy for re-opening the negotiation with the developer, setting of the premium and revised premium, etc. in particular during the discussion of various disposal options at the Senior Directorate Meetings chaired by the Secretary for Housing, Planning and Lands;

THB's response : Further to the information provided in part (viii) above, various possible disposal options for Hunghom Peninsula were discussed at several regular Senior Directorate Meetings ("SDM") (see ~~THB 26 to THB 39~~) chaired by the then Secretary for Housing, Planning and Lands ("SHPL") after the negotiation with the Developer during January to March 2003 was unable to reach any agreement. Mr LEUNG attended the SDM. On 25 July 2003, the Developer initiated litigation against the Government and the HA by issuing a writ. In light of the proceedings, re-opening negotiation was considered an option to be explored SHPL submitted a Loose Minute to the Chief Executive ("CE") on 28 July 2003 (see ~~THB 41~~) seeking endorsement to re-open negotiation with the developers so that the HA may avoid paying the guaranteed purchase price for Hunghom Peninsula and Kingsford Terrace and settle the dispute. CE directed that the case be discussed in ExCo on 28 October 2003, and Mr LEUNG wrote to seek CS's approval to waive the requirement to discuss it at the PC -
