

**Select Committee to Inquire into Matters relating to
the Post-service Work of Mr Leung Chin-man**

in response to the Appendix to the Clerk to Select Committee's letter

1. Appointment of Mr CHUNG Kwok-cheong as a member of
the Commercial Properties Committee of the Hong Kong
Housing Authority ("HA")

At the hearing of the Select Committee held on 26 May 2009, Mr Marco WU gave evidence on the normal process for nomination and appointment of members of HA and its committees. He also referred to the nomination process taken in early 2003 when the Housing Department ("HD") was undergoing reorganization and mentioned that there might have been meetings to discuss proposed membership for HA and its committees during the period before he left HD in early March 2003. Please advise/provide:

- (a) the normal process for nomination and appointment of members of HA and its committees before the reorganization of HD in early 2003 and a summary of the nomination and appointment exercise in 2003, including changes, if any, in the nomination procedures and the divisions in HD responsible for the nomination and appointment exercise; and

Transport and Housing Bureau ("THB")'s response :
Before the reorganisation of the Housing Department ("HD"), in nominating members of the Housing Authority ("HA") and its committees, inputs were obtained from the Home Affairs Bureau ("HAB") and the senior directorates of HD. The nominations would be submitted to the Chairman of Housing Authority and the Bureau Secretary responsible for housing matter for agreement. For HA's membership, the Bureau Secretary responsible for housing matter would minute to the Chief Executive for approval. For HA's committees, a presumption paper would be issued to seek the approval of the members of HA.

With the reorganisation of HD in 2003, the procedures were basically the same except that –

- 1. the nomination would also need to take into account the reorganisation of the HA committee structure to take effect from 1 April 2003; and*
- 2. the incumbent Chairman of HA was no longer consulted upon his exit on 1 April 2003.*

For the nomination of HA members, senior directorates of HD were involved. For the nomination of HA's committees members, the heads (i.e. senior directorates) of divisions in HD were involved according to the scopes of business of the committees under their respective purviews.

Since the HA was undergoing restructuring, the nomination for the 2-year term from 2003/04 to 2004/05 was coordinated by the Strategy Division, which oversaw the reorganization of the HA/Committee structure. For the logistic support, the Committees' Section, which is under the Corporate Services Division of the HD, was responsible.

- (b) documents relating to the nomination and appointment exercise in 2003 from January to April 2003 including correspondence on nominations made, records of discussion and decisions on the nominations, the list of proposed nominees and the list of appointed members.
