The Select Committee notes from the evidence given by Mr LEUNG Chin-man at the hearing on 20 July 2009 that he had made a suggestion to Mr John CORRIGALL during a meeting on 30 October 2003 for appointing an independent surveyor/valuer to assist him in the mediation with the developer of Hunghom Peninsula ("the suggestion"). According to Mr LEUNG, Mr CORRIGALL rejected the suggestion as he was the most experienced valuer in Hong Kong and that he would be assisted by staff of the Lands Department in the mediation process. The said meeting was the second of the two meetings as reported in the e-mail dated 31 October 2003 from Ms Handa CF LAM to Mr Anthony KH WONG (SC Paper No. T138). Mr LEUNG said that the discussion was not recorded in that e-mail but he has reconfirmed his memory as stated above with Ms Handa LAM recently.

As recorded in T138, besides Mr LEUNG Chin-man, Mr John CORRIGALL and Ms Handa CF LAM, Mr Vincent TONG and Mr Simon LEE were also present at the meeting. Please confirm with the persons present at the meeting (except Mr LEUNG Chin-man) whether Mr LEUNG Chin-man had made the said suggestion at the meeting. If yes, please ask them to provide details of the discussion on the matter and the conclusion reached, if any. Please also confirm whether the Administration has any other records or minutes relating to the aforesaid second meeting held on 30 October 2003. If yes, please provide us with such records or minutes.

Mr Vincent TONG stated that as the meeting took place almost six years ago, he could not remember the suggestion. Mr John CORRIGALL stated that he seemed to recall that the suggestion was made by Mr LEUNG and that he rejected it. Although Mr CORRIGALL did not recall the details, circumstances or date of the suggestion made, he had no reason to dispute that it was made at a meeting on 30 October 2003. However, Mr CORRIGALL doubted that he would have been so arrogant as to say that his reason for rejecting the suggestion was that he was the most experienced valuer in Hong Kong.
