Please advise if you have checked the minutes <br> and/or other records of these three meetings when you provided your <br> response. Please also provide the relevant parts of the minutes <br> and/or record of these three meetings to substantiate your answers to <br> Question 1(a); <br> Mr Wong's Response: I have checked the papers and the minutes of <br> these three meetings when I provided my response. <br> According to the minutes of the PC meeting held on 24 October 2002, <br> the discussion was on the comprehensive market-oriented housing <br> policy. There was no discussion on the Hunghom Peninsula <br> development project. <br> According to the minutes of the PC meeting held on 27 February <br> 2003, the discussion was on the proposal of using some Subsidized <br> Home Ownership flats as Government departmental quarters and the <br> proposal to use the overhung Home Ownership Scheme flats as <br> guesthouses for Mainland tour groups. There was no discussion on <br> the Hunghom Peninsula development project. |

Mr LEUNG Chin-man attended the said meeting in his capacity as the then Permanent Secretary for Housing, Planning and Lands (Housing). |
| (d) | If the answers to (c) above are the Housing Department and the Permanent Secretary for Housing, Planning and Lands (Housing)/ Director of Housing respectively, why you were not aware of Mr LEUNG's involvement in the Hunghom Peninsula case then in 2002, and why you became first aware of Mr LEUNG's involvement in the Hunghom Peninsula case only in early August 2008 as stated in your response to Question 1(b); and |
