PUBLIC HEALTH AND MUNICIPAL SERVICES SETTING ASIDE PLACES FOR USE AS PUBLIC PLEASURE GROUNDS AND CESSATION OF SETTING ASIDE PLACES FOR USE AS PUBLIC PLEASURE GROUNDS

INTRODUCTION

The Director of Leisure and Cultural Services, in his capacity as the Authority ("Authority") under the Public Health and Municipal Services Ordinance Cap.132 ("the Ordinance"), manages the public pleasure grounds listed in the Fourth Schedule to the Ordinance. Under Section 106 of the Ordinance, the Authority may, from time to time, by order set aside places for use as public pleasure grounds, and may by order amend, or add to, or delete from the Fourth Schedule.

2. We propose to introduce the amendments through the Public Health and Municipal Services (Setting Aside Places for Use as Public Pleasure Grounds and Cessation of Setting Aside Places for Use as Public Pleasure Grounds) (No. 2) Order 2008 (Order No. 2) at <u>Annex A</u> and the Public Health and Municipal Services Ordinance (Amendment of Fourth Schedule) (No. 3) Order 2008 (Order No. 3) at <u>Annex B</u> to this Brief to -

- (a) set aside the places specified in Schedule 1 at Order No. 2 for use as public pleasure grounds;
- (b) cease to set aside the places specified in Schedule 2 at Order No. 2 for use as public pleasure grounds; and
- (c) rename the public pleasure grounds specified in Order No. 3.

JUSTIFICATIONS

3. The proposal to set aside 35 new venues as public pleasure grounds will enable the Authority to enforce the regulations relating to these public pleasure grounds for proper management. Two venues no longer

used as public pleasure grounds should be removed from the Fourth Schedule. Another two venues should be renamed to better reflect their locations and functions.

Places to be set aside for use as public pleasure grounds

4. The following 35 new venues are required to be designated as public pleasure grounds and are to be included in the Fourth Schedule —

- (i) 12 new venues that are already open or will be open for public use by the Leisure and Cultural Services Department (LCSD):
 - (a) Chung Yat Street Soccer Pitch
 - (b) Fung On Street Children's Playground
 - (c) Hang Kwai Street Playground
 - (d) Hoi Chu Road Playground
 - (e) Ivy Street Rest Garden
 - (f) Pak Shek Kok Promenade
 - (g) Po Wing Road Playground
 - (h) Po Wing Road Sitting-out Area
 - (i) Sham Tsz Street Playground
 - (j) Tung Chung Road Soccer Pitch
 - (k) Yau Tong Road Playground
 - (1) Yau Tsim Mong Pet Garden
- (ii) 23 venues taken over from the respective District Councils for management by LCSD:
 - (a) Centre Street Sitting-out Area
 - (b) Cheung Sha Wan Path Sitting-out Area
 - (c) Cochrane Street Sitting-out Area
 - (d) Fan Tin Tsuen Sitting-out Area
 - (e) Fung Mat Road Sitting-out Area
 - (f) Ginza Square
 - (g) King Lam Street Sitting-out Area
 - (h) Lynwood Sitting-out Area
 - (i) Mount Davis Playground
 - (j) Mount Davis Sitting-out Area No. 1
 - (k) Mount Davis Sitting-out Area No. 2
 - (1) Mount Davis Sitting-out Area No. 3
 - (m) Ngoi Man Street Sitting-out Area
 - (n) Pier Road Sitting-out Area

- (o) Pok Fu Lam Road Sitting-out Area
- (p) Robinson Road Sitting-out Area
- (q) Rock Hill Street Sitting-out Area
- (r) Sai Yuen Lane Sitting-out Area
- (s) Sha Chau Lei Sitting-out Area
- (t) Shek Po Tsuen Playground
- (u) Sheung Fung Lane Sitting-out Area
- (v) Southern District San Wai Village Sitting-out Area
- (w) Tai Wong Street East Sitting-out Area

Places cease to be set aside for use as public pleasure grounds

5. Two venues are to be deleted from the Fourth Schedule. They were used temporarily as public pleasure grounds before and were surrendered for the construction of Tseung Kwan O Complex in October 2008 —

- (a) Pui Shing Road Temporary Garden
- (b) Pui Shing Road Community Garden

Renaming of public pleasure grounds

6. To better reflect the location and function of the venues, we recommend renaming the following two venues in the Fourth Schedule:

(a) Stanley Promenade

The venue, formerly named as Stanley Waterfront Playground, was redeveloped under the Stanley Waterfront Improvement Project initiated by the Tourism Commission. It has been reopened for public use since March 2008.

(b) Kwai Chung San Kui Park

The Kwai Chung Estate Residents Right Concern Group has proposed to rename the venue, formerly named Tai Wo Hau Road Park as Kwai Chung San Kui Park. The renaming is supported by the Kwai Tsing District Council.

AMENDMENT OF FOURTH SCHEDULE

7. The Amendment Order at <u>Annex B</u> amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to update

the list of public pleasure grounds and to rename the two public pleasure grounds.
